Research indicates that significant gaps in knowledge and skill regarding reading and comprehension still persist between demographic groups. As a country, we have to keep making significant strides to improve our results and equip more of our to be people to be fully-functioning citizens capable of reviewing information - reading and analyzing - and making considered, rational decisions in policy and leadership. The WCPL and its locations offer many, many positive opportunities to county residents. I believe that our libraries have the capacity to expand their offerings and reach even more broadly into the needs and wants of its communities. Most towns no longer have a true, active town center in the way they might have in past decades, when it included places to shop, work, learn and worship. Commerce cycles through small businesses to box stores to online with no central focus.
