The above described property is further identified by reference to Deed Book 1053, Page 102, Wake County Registry, and said property is further identified in the records of the Wake County Department of Natural Resources, and is Site No. 23-5, in the plans for Crabtree Creek, relating to Crabtree Creek (stream) and its tributaries, as shown by recorded plat entitled "Crabtree Creek Watershed Site No. 23" found in Book of Maps, Book 1975, Page 80, Wake County Registry.

TO HAVE AND TO HOLD the above easement unto the GRANTEE as a perpetual easement, which shall be binding upon the heirs, personal representatives, successors and assigns of the GRANTORS, with the following provisions and conditions:

- 1. A "watershed improvement project" is a project of watershed improvement and temporary storage of floodwaters which is undertaken by the GRANTEE alone, or in conjunction with some other lawful government agency, or by any successor governmental agency designated by GRANTEE.
- 2. The GRANTEE shall have right of ingress and egress to said project from Highway 54 only and to the extent of twenty-five (25) feet along the southern side of Crabtree Creek.
- 3. The GRANTEE has exclusive control over the maintenance and pertinent appliances necessary and convenient for the temporary impoundment, storage, detention, control and regulation of floodwaters, but the GRANTORS retain the right to use all the land in the flood easement for agricultural and recreational purposes so long as no improvements are constructed which would violate flood area restrictions.
- 4. In the event construction of the proposed dam is not commenced within fifteen (15) years from the date hereof, the rights and privileges herein granted shall at once revert to and become the properties of the GRANTORS, their heirs and assigns.

And the said Wachovia Bank and Trust Company, N.A., as Co-Trustee under the will of Leroy Martin, deceased and as Co-executor and trustee under the will of Raymond Elmore Earp, Sr., deceased, together with Sidney A. Martin, Co-Trustee under the said Martin will, and Raymond E. Earp, Jr., Co-Executor under the said Earp will, do hereby covenant that they have not placed any presently existing liens or encumbrances on said premises and that they will warrant and defend the title to the same against the lawful claims of all persons claiming by, through, under or on account of said fiduciary capacities in so far as it is their duty to do so by virtue of their offices as said fiduciaries.

And the individual grantors, for themselves, their heirs and assigns, do hereby covenant that they are the beneficiaries of the estate and trust of Raymond Elmore Earp, deceased, herein mentioned, and that the grantors have the right to convey the fee or any lesser estate or interest in the land herein described; that the same is free from encumbrances, except as may herein be mentioned, and that they will defend the title thereto against the claims of all persons whomsoever.
