Key Drivers In This Request

- Reallocate funds from expected savings in CIP 2013
- Appropriate funds needed to begin designs for next round of identified SNAP projects
- Funds needed for construction of SNAP projects will be sought when needed through similar reallocations from CIP 2013 savings and CIP FY 2017-2023.



Space Needs Analysis & Prioritization (SNAP)

- CIP 2006 & CIP 2013 focused on meeting growth and address overcrowding with large prototype construction & renovation projects.
- Educational & educational support space needs have been identified that were not specifically included in CIP 2006 or CIP 2013
- Developed SNAP evaluation protocols and applied them to identified needs, and implemented results to inform and direct current and future capital planning
- SNAP funding is included in the FY 2017-2023 Capital Improvement Plan
