DECLARATION OF EASEMENTS

This Declaration of Easements made and executed this ______ day of _____, 2025, by the City of Raleigh, a municipal corporation of the State of North Carolina (the "City") and the County of Wake, a political subdivision of the State of North Carolina (the "County").

WITNESSETH:

WHEREAS, the City and the County are the owners, as tenants-in-common, of that certain parcel of land located in Wake County, North Carolina having Wake County PIN # 1741256016, and more particularly described in Book 11637, Page 2770, Wake County Registry (the "City/County Property"); and

WHEREAS, 3540 Auburn LLC is the owner of land having Wake County PIN # 1741150442 and more particularly described in Book 18490, Page 2319, Wake County Registry (the "Auburn Property"), such land being in close proximity to the City/County Property;

WHEREAS, prior to future development, the Auburn Property will need sanitary sewer and water supply facilities upon, under, through, and across the City/County Property and an extension of the sanitary sewer main and water main, which will enable the Auburn Property to connect to existing public sewer lines, waterlines, and easements; and

WHEREAS, in accordance with applicable provisions of the Raleigh Unified Development Ordinance and the Wake County Unified Development Ordinance, upon the

development of the Auburn Property, the developer of the Auburn Property may be required to construct the above-mentioned sewer lines, waterlines, and associated facilities; and

WHEREAS, the City and the County have determined that extending the sewer main and water main and establishing an easement over the City/County Property to allow for such extensions would represent an orderly and cost-efficient expansion of the City's sanitary sewer and water supply systems and is in the public interest; and

WHEREAS, accordingly, the City and the County have agreed to declare and establish easements for both the sanitary sewer and waterline (the "Easements") for purposes of allowing the extension of the sewer main and water main upon, under, through, and across the City/County Property.

NOW, THEREFORE, for valuable consideration, the receipt of which is hereby acknowledged by the City and the County, in consideration of the orderly and cost-efficient expansion of the City's sanitary sewer and water supply systems and the provision of sanitary sewer and water services to the Auburn Property, the City and the County do hereby DECLARE, DEDICATE, RESERVE, AND ESTABLISH, for the benefit of the City, the permanent right, privilege and easement, now and hereafter, to construct, install, improve, remove, replace, inspect, repair, maintain and use a system of pipelines or mains for sanitary sewer and water supply purposes, together with all the appurtenance facilities and equipment necessary or convenient thereto, in, upon, under, over, through, and across the City/County Property, which easement areas are more particularly identified and described as a "30' Permanent Sanitary Sewer Easement" and a "City of Raleigh Waterline Easement" on Exhibit A attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD the aforesaid permanent easement interests and all privileges and rights thereunto belonging to the City and County and their respective successors and assigns in perpetuity unless this Declaration of Easements is modified, amended, canceled or terminated by the written consent of the County and the City.

The rights, privileges and benefits of this Declaration of Easements shall not merge by operation of law or terminate but shall remain in full force and effect despite the fact that the City and/or County may own title to the Property and the benefits described herein now or in the future.

THE CITY/COUNTY PROPERTY does not include the primary residence of either declarant.




