Theresa Furr, Wake County Soil and Water Conservation Director, thanked Commissioners for proclamation. She shared remarks about Wake County's Big Sweep Program, a volunteer litter clean up program. She shared appreciation for recognition of the efforts across Wake County to build a cleaner, greener future. She shared the importance of protecting the environment. She shared the work would not be possible without the support of the residents and partners of Wake County (the City of Raleigh, Richard Arnold and Art Ross, Volunteer Leaders). She shared appreciation to past program leaders Sheila Jones and Lois Nixon, whose vision and leadership was instrumental in growing the program. She shared appreciation for Cape Fear Adventures, Green for Life, the North Carolina Wildlife Federation. She shared a special thanks to Heidelberg Materials for their generous donation of a custom trailer and a fleet of boats which has improved the cleanups. Mr. Maloney shared there is a process in place with the environmental staff for the transfer of developer to homeowner association. He shared some HOA's looked at the language and felt they had authority; but if the minimum standards are met and determined by Wake County Environmental Services, then there must be a transfer from developer to homeowner association or lot owner in some instances, for permanent maintenance.

Chair Evans shared for stormwater control measure, does that have to do with a retention pond.

Mr. Maloney shared that is correct.

Chair Evans shared there is a process to complete transfer of improvements that the County would inspect and sign off on it being effective. She clarified that Mr. Maloney is proposing that the transfer could be done from homeowner or HOA, once the certification has taken place. She thanked Mr. Maloney for the options and the great explanation.

Ms. Tammy Baggett, Library Director, shared dates for National Library Week: Celebrating Wake County Public Libraries and their staff.

She shared in 2024, Wake County Public Libraries:

- Welcomed over 3 million visitors across 23 locations
- Provided 10,000 +programs with 300,000 attendees
- Circulated 11.9 million books and materials
- Served over 272,000 active card holders
- Created over 60,000 library accounts
- Provided over 180,000 hours of computer usage

She shared Library staff work diligently to provide inclusive, accessible and innovative services, ensuring a welcoming environment where all individuals are treated with respect and dignity.

She shared additional details regarding National Library Week:
Celebrating Wake County Public Libraries and their staff:

- Libraries serve as great equalizer
- Today is about libraries right to read
- Tomorrow is National Library Workers Day is tomorrow, April 8, 2025

Chair Evans opened floor for Commissioner remarks on Advisory and Regional Boards.

Commissioner Stallings shared her attendance at Health and Human Services (HHS) Steering Committee of State Association and Wake County's Health and Human Services Board and Alliance Behavioral Health Board and she sees a strong theme about concerns and cuts for

Medicaid. She shared these job cuts are on the minds of many. She shared about 600,000 people in North Carolina have received some type of Medicaid expansion services; about 46,000 here in Wake County and about 25 percent of North Carolinians are receiving Medicaid assistance. She encouraged Commissioners to assist with advocacy at State level. She shared NCACC's work regarding Foster Care Services is having more of an impact. NCACC's plan is to have a plan to support all 100 counties with Foster Care Services. She shared concern about rates for Sexually Transmitted Infections (STI's) in the County and home testing kits have been rolled out at some of the regional centers. She also shared NCACC HHS Steering Committee was impressed by community resources for persons who dial into 988 service for mental health behavioral health crisis.

Chair Evans shared Capital Area Metro Planning Organization (CAMPO) that board authorized a study that Department of Transportation and turnpike conducted to look at for viable solution along US 1 North to get improvements made between I-540 Northern Line in Wake County. She shared a study was done to look at feasibility and results are back and CAMPO is in the process of public engagement and anyone who lives in northern part of County, a website (https://www.publicinput.com/us_1_tollingoptions) will be available to submit public comment. She shared public engagement will run from now until end of first week in May, 2025.

Commissioner Adamson shared she attended the Healing Transitions Women's Campus to see the new addition that Wake County funded. She shared the visit was exciting as the old building had been retrofitted containing one shower and one small bathroom. Today, the facilities are more accommodating to all of the women. She toured the facility and saw instructor led classrooms. She shared the Healing Transitions center has extra land on the campus and leadership is looking at putting a 28-unit transitional housing building on the land. She shared this would be used by the ladies coming out of the program. She shared 60% of funding has been raised for this project. The goal of this project is to unify moms with their children. She shared understanding that some judges are permitting supervised overnight arrangements with moms and children because the arrangement is in a controlled environment. She shared that she and Vice-Chair Mial attended Jewish Community 4th annual Seder event.
