**WHEREAS**, the Wake County Board of Commissioners recognizes the importance of civic engagement, volunteer service, and mentorship in strengthening communities, improving the quality of life, and fostering opportunity for residents across Wake County; and

**WHEREAS**, through a comprehensive body of service and community engagement beyond its youth development efforts, the Cary (NC) Alumni Chapter of Kappa Alpha Psi Fraternity, Inc. has produced meaningful civic and quality-of-life outcomes across Wake County, including strengthened food security and family support, increased awareness of critical public health issues, and sustained assistance to seniors, families, and neighborhoods through year-round service initiatives; and

**WHEREAS**, through its ongoing Youth Development Programs, the Cary (NC) Alumni Chapter of Kappa Alpha Psi Fraternity, Inc. provides mentoring, college readiness, STEM education, and life-skills training for young men across Wake County, achieving strong outcomes including a 98 percent graduation rate, 85 percent attendance at four-year institutions, more than 20,000 hours of community service, and three Bill Gates Millennium Scholarships, in support of the County's long-term goals for youth development and educational advancement; and

**WHEREAS**, fraternal organizations such as Kappa Alpha Psi Fraternity, Inc. play an important national and statewide role in advancing mentorship, leadership development, and service-oriented engagement, helping to strengthen communities by expanding access to opportunity and positive role models; and

**WHEREAS**, in Wake County, the Cary (NC) Alumni Chapter of Kappa Alpha Psi Fraternity, Inc. has demonstrated clear local impact through targeted literacy partnerships, food security initiatives, community health awareness efforts addressing prostate cancer and mental health, and holiday support for children and families; and

**WHEREAS**, recognizing the Cary (NC) Alumni Chapter of Kappa Alpha Psi Fraternity, Inc. affirms the value of sustained volunteerism, mentorship, and community leadership, and highlights the positive contributions of fraternal service organizations in strengthening the social, educational, and economic fabric of Wake County; and
