AMENDMENT

This **AMENDMENT** made and entered into the 1st day of July, 2024, by and between the County of Wake, a body politic and corporate of the State of North Carolina, hereinafter referred to as "**COUNTY**" and **Alliance Health**, a political subdivision of the State of North Carolina (hereinafter referred to as "**ALLIANCE**";

WITNESSETH

That the **COUNTY** and **ALLIANCE** have an existing legal contract specifying services, terms and conditions under which **ALLIANCE** provides specified services to the **COUNTY**; and,

WHEREAS, **ALLIANCE** experienced delays in engaging qualified providers to establish short-term crisis stabilization and transitional programs to serve Wake County youth and has therefore requested an extension from **COUNTY** to complete the scope of services identified in the Funding Agreement dated June 20, 2023, and

WHEREAS, during this period, **ALLIANCE** will perform services authorized in the funding agreement dated June 20, 2023, and

WHEREAS, said contract specified the term to be completed by June 30, 2024 and shall be amended to extend to March 31, 2025,

NOW THEREFORE, in consideration of the continued services offered by **ALLIANCE** and agreed to by the **COUNTY**, the **COUNTY** and **ALLIANCE** mutually agree to amend the funding agreement dated June 20, 2023. All other rights, terms and considerations currently contained in this contract remain in effect.

**ARTICLE I
TERM**

1.1 The term of this Funding Agreement shall be from **June 15, 2023**, through **June 30, 2024**, **March 31, 2025** unless terminated or extended by written agreement of the parties hereto. **Alliance** may request an extension of this term for good cause, which shall include longer than expected turnaround time for locating homes, purchasing, renovating, obtaining DSHR licensure and staffing if Grant Recipients are making reasonable progress towards these goals. Extensions must be requested prior to the expiration of the Term and shall require approval of the Wake County Board of Commissioners.

ARTICLE VII

7.1 Except for the change made herein, the Funding Agreement shall remain in full force and effect to the extent not inconsistent with this Amendment. Such in the event that there is a conflict between Original Agreement and this Amendment, this Amendment shall control.
