FY2025 Recommended Budget \$2,074,346,000

Setting the FY2025 tax rate

County Manager Recommendation:

51.05 cents per \$100 of valuation

Breaking down the 51.05 cents

- 36.30 cents will fund operating expenses
- 14.75 cents will go towards long-term debt and capital plans

FY 2025 Budget Process

- County Manager presented Recommended Budget to Board of Commissioners on May 6
- Capital Work Session with Board on May 13
- Public Hearings on Budget on May 20, May 21
- Budget Work Session today May 23
- Board Budget adoption at Regular Meeting on June 3

County ARPA Pilots

Continued ARPA Funding in FY25

- Federal government updated ARPA guidance; positions can now be funded with ARPA through December 2026
- Several ARPA pilots will continue with ARPA funding through FY25 as summarized on the following slides
 - ARPA pilots will be evaluated for ongoing County support beyond federal funding timelines
- Staff will provide a comprehensive status update for ARPA funded programs at a work session later this calendar year

FY25 ARPA Funded Pilots

Pilot Project	Department	Description and Project Goal
Student Engagement Team	Cooperative Extension and Wake County Public School System	Provide resources to address students' social determinants of health. Intended outcomes include improved academic performance, greater engagement in class and out-of-school activities and improved behavioral health outcomes.
Neighborhood Networks	Health and Human Services	Provide social work team to partner with WCPSS to address five protective factors for children and their families: resilience, relationships, knowledge, communications, and support.
NextGen Youth Career Exploration	Capital Area Workforce Development	Provide disconnected youth in Wake County the tools and resources to explore different careers, including pre-apprenticeships. To date, 67 individuals/students have been served.

Pilot Project	Department	Description and Project Goal
Landlord Engagement Unit Program	Housing Affordability and Community Revitalization	Connect households exiting homelessness with landlords seeking tenants to fill affordable units. Goal to reduce the length of time households experience homelessness and increase the number of permanent housing options.
Bridge 2 Home Program	Housing Affordability and Community Revitalization	Provide flexible funding to 11 partner agencies with the goal to make homelessness episodes rare, brief, and non-recurring in Wake County.
Water Quality Well and Septic Assistance	Environmental Services and Housing Affordability and Community Revitalization	Support low-income, disabled and elderly individuals afford costly well and septic repairs.

Pilot Project	Department	Description and Project Goal
Re-entry Program	Capital Area Workforce Development	Provide small grants to community-based organization serving previously incarcerated residents. Goal to help individuals get their immediate needs met, build skills, and find well-paying jobs.
Micro Business Development Entrepreneurship	Capital Area Workforce Development	Program to help aspiring entrepreneurs with the major barriers to business success: navigating resources, understanding government regulations and documentation, developing a business plan, and creating a financial plan.
EMS Navigation Line	Emergency Management Services	Provide telehealth primary and urgent care for low-acuity calls
Enhance Food Security	Cooperative Extension	Partner with community organizations to address equitable access to healthy foods and develop a more resilient and equitable local food supply chain.
Fire Services Recruitment	Fire Services	Fund trainee salaries, books, and other supplies and materials needed to attend the fire academy, removing barriers to starting a career in the fire service. Goal to increase workforce diversity in the Wake County Fire Tax District.

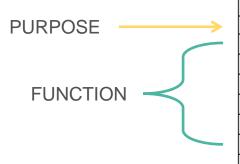
