3. Breast Cancer Awareness Month Proclamation

Wake Alcoholic Beverage Control (ABC) Board Chair, Mr. Lucius Jones, shared remarks and presented Wake County with a check in the amount of \$10,418,000. Mr. Jones shared that they currently have 300 employees and are in the process of building a new warehouse. He shared the following distributions: \$1.5M to Wake Brook for substance abuse support, \$4.1M to the surrounding municipalities and \$5.5M to 17 nonprofits to provide treatment and education for alcohol and substance abuse. He introduced members of the ABC Board and the General Manager, Brian Hicks.

Commissioner Calabria shared appreciation for the partnership with the ABC board. Money will improve the lives of residents for addiction treatment.

Yvonne Gilyard, Clerk to the Board, thanked her sisters from Sister to Sister Alliance for being in attendance and asked them to join her at the podium. She read the Breast Cancer Awareness Month proclamation aloud and presented the proclamation to Sister to Sister Alliance. Ms. Gilyard shared that she is a two time breast cancer survivor and urged all women and men to get annual check-ups.

Chair Thomas thanked the members of Sister to Sister Alliance for

attending today's meeting.

Kim Bedgood, Sister to Sister Alliance, shared that breast cancer does not discriminate. Se encouraged men to check their pecks because they too, can get breast cancer. She shared black women die of breast cancer more frequently. She shared that Sister to Sister Alliance's goal is to make people aware and shared that cancer crosses all boundaries. She thanked the Chair for the acknowledgement of breast cancer and for the proclamation. She thanked the board for the proclamation.

Commissioner Stallings thanked Ms. Gilyard for sharing the proclamation and to Sister to Sister Alliance for being here. She shared that most of us know someone who has experienced breast cancer and/or experienced it ourselves. She thanked Sister to Sister Alliance for their attendance and sharing awareness.

Commissioner Waters shared her appreciation to Sister to Sister Alliance for their bravery and having a heart to reach out and share their journey and empower others who are facing breast cancer.

Chair Thomas shared that Manager Ellis is going to have the Wake County Justice Center lit pink tonight. She acknowledged Ms. Terry Spicer, Founder of The Sisters Inspiring Sisters, Incorporated (the SISI) and shared the SISI Lift Your Pearls and Check Your Girls campaign making sure that women are getting their mammograms.

Chair Thomas thanked Sister to Sister Alliance for the work that they are doing. She shared that both of her parents were diagnosed with cancer and it encouraged her to go and get genetic testing. She shared that she has tested positive for the BRCA gene. This is another opportunity for women of color to understand their health.

Ms. Carmen Wimberley Cauthen - library bond concerns. Gave the history of Richard B Harrison library.

Ms. Octavia Rainey - serves on Library Commission, shared that Dr. West said do not move the library to the DMV. Ms. Rainey shared that she submitted a public records request, which has now been moved to City Attorney's office. To date, no response has been provided. Ms. Rainey shared comments on why Diversity, Equity and Inclusion (DEI) department overlooks Southeast Raleigh. Shared that Board of Commissioners are not being honest.

Ms. Alicia Arnold, Deputy Director of Housing Affordable & Community Revitalization, shared the 2025-2030 Consolidated Plan and Action Plan.

She shared What is the consolidated plan.

Commissioner Stallings asked for Ms. Arnold to explain what stakeholder engagement looks like.

Ms. Arnold shared that they will do a lot of mixed messaging to get feedback. They have an extensive list of stakeholders that HUD shares with them that ranges from business community, financial institutions, faith partners, community groups, health partners. All will be engaging and public meetings will be held in various regions in Wake County. They will also host stakeholder meetings, send out letters for feedback as well as public hearings during the Board of Commissioner meetings.

Commissioner Waters asked what has been the guiding principles on priority needs and what is being learned from benchmarking across the country.

Ms. Arnold shared that local residents have shared that there is a segment of residents and a segment of incomes in our communities that the housing market is not naturally addressing with the challenges of cost of materials and land. Wake County is creating a priority population and priority goal areas based off of needs that they hear from the community. She shared additional comments about partnering with the City of Raleigh.

Commissioner Waters shared comments on the public sector living in area where they work.

Chair Thomas opened the public hearing.

Ms. Octavia Rainey shared she has 55 years of fair housing experience. She shared that Wake County does not enforce the fair housing act. She shared that Wake County does not speak about the immigrant community.

Ms. Carmen Wimberly Cauthen shared that when gathering comments find ways to engage with people at the lower end of the scale. Go into the shelters, men and women out of incarceration. Consider posting at newer housing apartment complexes and at the hotels.

Chair Thomas closed the public hearing.

Commissioner Calabria shared comments on engaging people at the lower end of the income spectrum.

That the Board of Commissioners hold a public hearing to receive comments on the affordable housing and community development needs in Wake County to inform the development of the five-year strategic plan.

Ms. Anita Davis, Medicaid Transportation Manager, shared FY26 Community Transportation Program (CTP) Combined Capital Grant.

She shared Public Hearing-Community Transportation Grant.

She shared GoWake Access Transportation.

She shared GoWake Access Service Zone.

She shared the ridership trends and trips.

She shared what has been done over the year.

She shared FTA Zero-Emission Transition Plan.

Commissioner Waters asked for clarity on capacity and if Wake County is able to meet the needs.

Ms. Davis shared that Medicaid represents 70% of the trips. The other 30% is represented by rural or micortransit and other sponsored agencies. There are 72 vehicles and they still are not able to meet all of the demands. There are almost 40,000 people that do not have transit. At times people are turned away or have to be placed on a waiting list.

Commissioner Calabria asked what is the State funding contribution and how has it changed over the last few years.

Ms. Davis shared the State funding falls in to two parts: 1. Annual Road funding for trips and 2. CTP Grant that funds administration costs. She said there are other Federal grants available. The State funding represents a little less than 10% of the total budget.

Commissioner Calabria asked if software issues have been resolved.

Ms. Davis shared that it has been resolved and they have seen some increases.

Commissioner Calabria confirmed that Medicaid is 70%. He asked for clarity if Medicaid will enable Wake County to cover the cost entirely or if Medicaid will subsidize.

Ms. Davis shared that Medicaid covers the full cost. The great thing about having 70% is Medicaid also subsidize other non-Medicaid services.

Commissioner Calabria asked if Wake County had the additional vehicles would more riders be serviced without additional operation costs.

Ms. Davis shared additional vehicles would not be enough. Even with more vehicles, there will always be a bigger demand. She shared it would require better coordination with other local agencies (i.e. Capital Area Metropolitan Planning Organization (CAMPO) to increase the availability of services.

Commissioner Calabria asked if there is anything that can be done to offer more services.

Ms. Davis shared that having more vehicles, increase in training for staff, more training in technology and a better coordination of services would be beneficial.

Vice-Chair Evans asked if riders outside of the Medicaid population have to meet certain qualifications to use the transit services.

Ms. Davis shared that non-Medicaid services are not income based. She shared the criteria includes being 6 years or older or classified as disabled. For rural services, the person must live in a rural area. There are specifications to the programs.

Vice-Chair Evans asked if Wake County is able to expand micro-transit service in other areas of the County.

Ms. Davis confirmed it would be helpful to expand micro-transit services. Micro-transit services are fare free services offered by Medicaid. For the rural general public, it is \$2 - \$4, depending on the destination. Go Raleigh recently implemented a new micro-transit service in Wake Forest. She shared creating other alternate forms of transit is helpful.

Chair Thomas opened the public hearing
