A RESOLUTION ADOPTED BY THE BOARD OF COMMISSIONERS

OF THE TOWN OF FUQUAY-VARINA, NC

ORDERING THE CHANGING OF THE NAME OF

A PORTION OF JAMES SLAUGHTER ROAD

(APPROX. 788 LINEAR FEET)

WHEREAS, the Board of Commissioners of the Town of Fuquay-Varina, following due advertisement, held a public hearing in consideration of changing the name of a portion of James Slaughter Road (located partially within the extraterritorial jurisdiction of Fuquay-Varina) to Spainhour Lane.

WHEREAS, the Board of Commissioners find:

- That the name of the road needs to be changed to end confusion of a duplicative road name. Due to development in the area, James Slaughter Road is proposed for realignment. Its intersection with Bass Lake Road will be moved approximately 475 feet to the west, to align with Westminster Lane at a signalized intersection. The remainder of James Slaughter Road is proposed to be closed to through traffic and renamed Spainhour Lane.
- The name Spainhour Lane will not conflict with other road names in Fuquay-Varina or Wake County.

NOW, THEREFORE, the name of State Road 1399 (from its terminus at Bass Lake Road running southeast approximately 788 linear feet, to its proposed realignment point) be changed to Spainhour Lane. Town Staff is directed to process this resolution through Wake County and the North Carolina Department of Transportation to accomplish the intent of this resolution.

The Town Clerk is hereby ordered and directed to file in the Office of the Register of Deeds of Wake County a certified copy of this resolution and order.
