2024 Wake County Community Survey Executive Summary

Overview

ETC Institute administered a community needs assessment survey for Wake County, North Carolina during the months of fall 2024. This survey will be used to gather input to assist in the County's ongoing efforts to identify and respond to the needs of the community.

Methodology

ETC Institute mailed a survey packet to a random sample of households in Wake County. Each survey packet contained a cover letter, a copy of the survey, and a postage-paid return envelope. Residents who received the survey were given the option of returning the survey by mail or completing it online at *Wake.gov/insights*.

After the surveys were mailed, ETC Institute followed up with residents to encourage participation. To prevent people who were not residents of Wake County from participating, everyone who completed the survey online was required to enter their home address prior to submitting the survey. ETC Institute then matched the addresses that were entered online with the addresses that were originally selected for the random sample. If the address from a survey completed online did not match one of the addresses selected for the sample, the online survey was not included in the final database for this report.

The overall results for the sample of 1,006 surveys has a precision of at least +/-3.1 at the 95% level of confidence.

Major Findings

Job Market. Respondents were asked to rate their level of agreement with 10 statements regarding the Wake County job market. Respondents most often agreed (selecting "agree" or "strongly agree") that Wake County promotes job creation and economic development in my community (64%), I can find jobs with safe and comfortable work environment (57%), and Wake County supports small, local businesses (54%). Most respondents (79%) say they are not having trouble finding a job near where they live. Of those who do have a problem finding a good job, the highest percentage report the most significant barriers (rated "significant problem/major problem") are jobs not paying enough (62%), discrimination (42%), and living in place with few job opportunities (25%).

Housing, Growth, and Environment. Respondents were provided with a list of 11 items related to housing, growth, and environment and asked to rate their level of agreement with each. Respondents most often agreed (selecting "agree" or "strongly agree") that they have access to clean water for daily use (89%), parks and greenways in community are well-maintained (74%), and affordable high-speed internet is available (68%).

Quality of Life and Infrastructure. Respondents were asked to rate 10 items related to quality of life and infrastructure in Wake County. The items rated the highest (as "good" or "excellent") were access to recreation spaces (76%), quality and variety of arts and cultural events (71%), and quality and variety of music and concert venues (69%).

Education. In regards to education, the items rated the highest (as "good" or "excellent") were the quality of Wake Technical Community College buildings and campuses (83%), the quality of public library facilities (77%), and access to education programs at Wake Technical Community College (75%).

Safety and Emergency Services. Respondents most often agreed (rating "agree" or "strongly agree") that fire departments throughout Wake County provide high quality services (92%), Wake County EMS provides high quality services (86%), and they feel safe at home (86%).

Medical Health Care. Seventy-six percent (76%) of respondents were satisfied (rating "good" or "excellent") with access to medical health care services in their community and 79% were satisfied with the quality of medical health care services in their community. Most respondents (71%) say that no one in their household has experienced problems or challenges seeking medical health care in the last two years. Of those who say someone in their household has, the items most often rated as significant or major barriers are long wait times for appointments (52%), cost of healthcare (43%), and not enough doctors or clinics (43%).

Behavioral Health Care. Eighty-seven percent (87%) of respondents say that they or someone or close to them has sought counseling or therapy in the last two years and 58% have sought out mental health services for diagnoses. Of those who said they have not sought out any type of behavioral health program in the last two years, the major barriers (rated as "major barrier/significant barrier) were not enough counselors or behavioral health providers nearby (44%), waiting long to get an appointment (41%), and cost of behavioral health care (39%).

Benefits and Assistance. The benefits received most often were Medicaid (75%) and Food & Nutrition Services (55%). Of those who receive some sort of benefit or assistance, the biggest barriers to receiving their assistance (rating "agree" or "strongly agree") are long wait times or delays in getting approved (72%), the application is too confusing or hard to fill out (57%), and it's hard to talk to or get help from the caseworkers (56%).

Satisfaction with Government. Respondents were most satisfied (rating "satisfied" or "very satisfied") with customer service provided by Wake County employees (54%) and the availability of information about government services and programs (47%).




Q2. Wake County Job Market

by percentage of respondents (excluding "don't know")




Q3. Are you having trouble finding a job near where you live?

by percentage of respondents (excluding "don't know")




Q3a. Barriers to Finding a Good Job

by percentage of respondents to answered "yes" to Q3 (excluding "not sure")




Q4. Housing, Growth, and Environment

by percentage of respondents (excluding "don't know")




Q5. Quality of Life and Infrastructure

by percentage of respondents (excluding "don't know")





by percentage of respondents (excluding "don't know")




Q7. Safety and Emergency Services

by percentage of respondents (excluding "don't know")




Q8. Medical Health Care

by percentage of respondents (excluding "don't know")




Q9. Have you or anyone in your household experienced problems or challenges seeking medical health care in the last two years?

by percentage of respondents (excluding "don't know")




Q9a. Barriers to Medical Health Care

by percentage of respondents who answered "yes" to Q9 (excluding "not provided")




Q10. Behavioral Health. Have you, or someone close to you, sought the following behavioral healthcare services anytime in the last two years?

by percentage of respondents (multiple selections could be made)




Q10a. Barriers to Behavioral Health

by percentage of respondents who did not answer Q10 (excluding "not provided")




Q11. Benefits and Assistance. Have you or someone close to you sought or received any of the following benefits in the past two years?

by percentage of respondents (multiple selections could be made) (without "none/prefer not to answer")




Q11a. Barriers to Benefits and Assistance

by percentage of respondents who respondend to Q11 (excluding "not sure")





by percentage of respondents (excluding don't knows)




Q13. Agreement with Statements about Wake County

by percentage of respondents (excluding "don't know")




Q15. Demographics: How many years have you lived in Wake County?

by percentage of respondents (excluding "not provided")




Q16. Demographics: Do you currently own or rent your current residence?

by percentage of respondents (excluding "don't know")




Q17. Demographics: How many persons in each age group currently live in your household?

by percentage of respondents (excluding "not provided")




Q18. Demographics: Gender

by percentage of respondents (excluding "not provided")




Q19. Demographics: What is your age?

by percentage of respondents (excluding "not provided")




Q20. Demographics: Race/Ethnicity

by percentage of respondents (multiple selections could be made)




Q21. Demographics: What is the highest level of education you have completed?

by percentage of respondents (excluding "not provided")




Q22. Demographics: Which best describes your total annual household income?

In my two decades living in Raleigh, I have seen an exponential increase in the number of people experiencing homelessness yet little initiative to alleviate their struggles. Not only is the cost of living too high for even the middle class, but there are additional, complex problems within the homeless populations including substance use, addiction, and interpersonal abuse.
- The infrastructure is not able to handle the traffic that is moving into the area due to the amount of multi-family residences being built.
- The most important issue is addressing the ever growing population. There is a severe housing crisis in Wake County, but to build adequate housing quickly could put strains on other infrastructure. The County should develop a very aggressive long-term housing growth plan.

- The most important issues facing wake county is housing, education, and other areas that will be affected once the new president comes in office
- The most pressing issue facing Wake County today is adapting to its rapid growth. Growth presents exciting opportunities, but it must be handled thoughtfully to avoid exacerbating disparities and to sustain the quality of life that makes Wake County so attractive.

Raleigh desperately needs a strong NEWSPAPER, we need news in print with author ownership, without well-covered printed news, Raleigh has lost democracy. Without an ethical printed news source, Raleigh has also lost its community voice. Case in point, The City Council enabled The firm CLEARSCAPES to cut down over 100 beautiful old-growth trees in Pullen Park, claiming they were diseased, which was not the case. Clearscapes returned to the City Council and requested more money periodically to cover their overages when renovating

the Pullen Art Center. Had this been covered in a printed newspaper, the citizens would have had a voice in that renovation expense and plan. Raleigh has a parade at Christmas. The city allows one man to source and bring in the same rag-tag home-built floats pulled by pick-up trucks, and there is no design invitation for well-designed floats to be designed and built for parade inclusion. This practice has killed one young dancer, and the city of Raleigh could raise the bar for our Christmas parade by breaking up this farmer's monopoly. Often, they double-book the floats, and at the parade's end, the trucks rush to make it to another town to use the same floats in another town's Christmas parade. With ethical journalism, operations like this could be exposed, and a strong sense of community could come back to our state capital. Please help shine a light on what is unreported and out of control. The city council only allows 3 minutes for any citizen to make a case against the city council's plans for the city. They are making unchecked decisions, and it has gotten worse since COVID. Thank you for doing what you can-the leadership of the state begins in the state capital.

- I am a senior and I have lived in Wendell for over 27 years. I own my own home and was given the senior consideration for real estate taxes. I was notified I no longer qualify and I don't understand why. I am surely not getting any younger and only have Social Security to depend on. My situation has not changed so why did my tax situation change? I called but no-one called me back to explain.
- I am long time resident of Wake County and retired with a pension. I am very fortunate to live in a home that is affordable to me in retirement, however if I had to purchase now, I might be hard pressed to purchase. Thereof our children could not purchase homes in Wake and settled in other communities. In addition to low income housing, there needs to be a focus on starter homes and young people starting out. Additionally, child care is outrageously expensive. Finding ways to address these expenses and to provide pre k for all children in Wake from age 3. While a new section of 540 has opened in my area, the roads to get to it are terribly congested. Massage transit is weak and I worry about the ability to get to appointments and such as I age.
- I appreciate everything the employees do, but I know they need more resources to be better and met all needs.
- I can live comfortably in Wake County and have access to the services I need. I have the ability to reach out and find help and to monitor the Wake County government. However, I know there are citizens of Wake County that are not as fortunate as me. I am concerned about these members of our community as we all live here and should be taken care of if needed.
- I follow wake gov on social media, but is there a newsletter I could get via email? For me personally, that would be a better way to learn about services/programs as they come up. I work full-time and would never think to look up Wake county services.
- I glad for these survey & open meetings. Hone owners for greater than 20 yrs should pay less property taxes. Leaf pick-up & yard waste need to be more frequent.
- I have lived in Wake County for over 25 years, and it has been a wonderful experience overall. However, I believe there are opportunities for improvement. First, I would love to see more emphasis on supporting entrepreneurship by offering additional free or low-cost training programs at Wake Tech to help residents start their own businesses. Additionally, focusing on capacity-building initiatives in lower-income neighborhoods could empower individuals and families to lift themselves out of difficult situations. Lastly, providing more meaningful tax relief for seniors would help ensure that long-time residents who own their homes are not burdened with the fear of losing them due to unaffordable property taxes. These measures would foster a stronger, more equitable community.

There is 1 grocery store and 1 dentist and I need to travel to knightdale or garner for most goods or services. The zoned middle school is in garner, WCPSS owns a huge lot on the coner of Poole and barwell. This areas population needs a middle school and more Commercial areas
- I see disparities around me that don't affect me directly but affect others in my community and the community as a whole.
- I think this is a state issue but I work in the human service field and it is incredibly difficult to find therapist/psychiatrists that accept Medicare advantage plans. It is also difficult to find mental health services for individuals who have both Medicaid and Medicare.

- I strongly believe that more resources and funding should be allocated to supporting, recruiting and retaining high quality teachers. They need a fair wage, benefits, access to paid time off when needed for child care and health issues and mental health support. Life-work balance is something that needs to be recognized and protected for our educators. They should also have a stronger role in determine decisions made about policies that affect them and their students, as they are on the front lines and know what is going on in the classrooms, and often, in their students' families' homes. Support, uplift and celebrate our educators. Provide incentives and compensation for furthering their education at the graduate level. Make an educational career in Wake County something that people aspire to have.
- I was a victim of domestic violence as a teenager. My father shot my family, killing my mother and her faithful companion. My sister and I were also shot multiple times. - Need more public swimming pools not associated with paid memberships
- Need to pay teachers more to attract and retain high quality teachers. My daughter that has a
 Masters in Education from App State left the teaching profession due to the low pay and stress
 of the job. Growth and development is too much. Always saddened to see clear cutting of trees
 for another new development. Traffic is ridiculous.
- Need Wake County to also focus on the needs and requirements of people retiring or retired
- New residents should bear more of the burden of the increase in property tax values. I worry
 that our most vulnerable will not be able to stay in their homes and middle-class families like
 mine will suffer some harm as tax increases pile on ongoing inflation. My experience and what I
 hear from others is that salaries are not keeping up with the rising cost of living in Wake County.
 I do think Wake County is a wonderful place to live.
- Nope. This survey made me realize there are things I need to learn about my local government and how things are running.
- Not at this time, but for families with children, I'm concerned about providing bus transport for students that need it, and from what I perceive there is not enough support for adequate teachers including salary.
- Not me but I know of many who can't find affordable housing. There is absolutely not enough subsidized housing in Wake County; the wait lists are many years long. Also, there are not enough programs for homeless families; it is shameful.
- Not really except for monitoring the overdevelopment and stop Gentrification. It would be nice
 to have shelter for those in need and maybe help those that can not afford to maintain there
 property due to age or disability.
- On main roads, there should be sidewalks on one side and bike paths on the other. The law that makes it illegal to ride a bike on the sidewalk should be removed. On roads that connect neighborhoods to main roads should have a sidewalk or bike path on at least one side of the road. I don't think we need them in neighborhoods, since the speed limit is normally 25 mph in most neighborhoods, and there for pretty safe to walk or ride a bike. This way people can walk or ride a bike to work. I would never ride in the bike lane in the street. It is too dangerous and normal people are afraid to use them for biking.

Instead, you collected record enormously high taxes and I was told by a librarian that they have a flat budget and so that's why they added a bond, that you guessed it, will result in yet even higher taxes. You need to work within your income and stop asking for more money. Get better candidates who know how to manage money because at this point, WAKE county is out of control.
- Overall, I think the County does an excellent job. We have issues with affordable housing and traffic that may require public/private partnerships to resolve. I also think that there are still issues of racism and sexual discrimination that continue to plague us.
- Parks and Recreation should hold more open gym hours for the youth. If basketball courts are inside and the rec center is open and not in use, it should be available for tax payers. I have had to have my young children play outside in the heat of the summer while a gym was staffed but not open. It is ridiculous. You should also have year-round leagues in a county this size. We have to keep the youth engaged. I feel this small step will help with crime prevention.

If you think I am going to feel comfortable moving out of my parents home for less than \$50,000/yr let alone procreate...when rent is on average 1200-1400k a month....you may need to speak to a health professional and Dave Ramsey.

- School quality in affluent areas is embarrassingly better than areas with lower SES. Funding for schools from the "education" lottery should fund schools better.
- Schools: It is disheartening to learn that wake county schools have left building problems, such as repairs to air conditioning, until the problems are extreme. Housing, I could write a book here. But let me say here that I am a senior on a limited income. My property value was just increase by almost a doubling of the value of my lot. I applied for relief and was denied because my total income is \$3,000.00 above your cutoff. Increasing the value of property by the amounts done this year without increasing the cut-off for the income level by any amount is unfair to seniors. Yes, I have not seen a doubling of my taxes this year. However, my experience is that increases will really begin next year. I live downtown where I can walk or bus to important places like groceries, doctors. I live here for that reason because there is eye disease in my family history, with longevity on both sides. I have been here since 1986. This year is the last I will be able to drive any daylight hours. I gave up night last year when my macular pucker made that dangerous. I could never afford to move into this neighborhood now. I maintain my house in the important ways, outside paint and roof, tree care, inside keeping appliances serviced and in good working order. The interior will never be updated other than work I am able to perform myself because I have to be certain that I will be able to pay property taxes. Ok, so I wrote a personal book. I truly feel for those with a lower income than mine or with a larger household. Gentrification has priced too many residents from where they prefer to live, or need to live for various reasons. Increase the income level for decreased property taxes.
- Send info for trash pick up to stick on receptacle. They are all worn out. Uncles picture of recycled items.
- Simplify how information is disseminated. One place to look and easy to navigate website.
- Slow down on new monetary expenditures, Also publish the new tax rates (mils) now, just not evaluations.
- Slow the level of new development.
- Slow the roll.... Hold a moratorium on building apartments, houses and re-zoning until infrastructure can catch up. We need widened roads, additional streamlined transportation, more schools and increased strategies to address areas of high congestion.
- Smart growth not just about finding revenue. Too many apartments and townhomes and roads can't handle this many people in smaller towns. Repair roads, more police, speed cams to slow people down. More greenways and sidewalks to connect neighborhoods.
- Specific to libraries. It is a shame that there is such a lack of programming. Also, their policy of
 "libraries are only for books" is a slap in the face. Many other systems in similar seized counties
 across the country offer manyore services like movies, games, and other useful rental and
 resources and it is a shame our system refuses to think it would be beneficial
- Spend less money on the police and more on affordable housing, affordable healthcare, transit, and education
- Spending money wisely, it is not yours.
- Stop allowing developers to mow down every single tree on the land when they develop a property. Encourage more reuse of properties that are in place but not being utilized.

- STOP BUILDING BRAND NEW HOUSING, START MAKING IT AFFORDABLE FOR ALL TO RENT OR
 OWN! TAKE CARE OF YOUR RESIDENTS AND DEVELOP DRUG/ALCOHOL PROGRAMS THAT ARE INPATIENT THAT YOU CAN BILL LATER OR HAVE SOMEONE DONATE IT! THIS COUNTY IS DYING AND
 THE DOMESTIC VIOLENCE IS GETTING WORSE. HELP US COME TOGETHER AND WATCH OUT FOR
 ONE ANOTHER! STOP BUILDING!!
- Stop building mansions
- Stop building so fast quality of area is going down.
- Stop building. Let people get caught up with today before starting on tomorrow.
- Stop focusing on DEI and hire quality people for their roles
- Stop government council members and other local positions pander to developers. Also stop WCPSS from putting special needs children through the system without sufficient support or not following their IEP.
- Stop increasing property tax. Eliminate tax on food and service. Eliminate wasteful spending. Charge 540 no users to bring down cost for all users.
- Stop making the cost of living so expense including buying a home and taxes going high.
- Stop prioritizing funding for new companies and support our existing companies.
- Stop spending money and time on things that do not matter as much as: public safety/fire, crime, etc. parks are wonderful, but what good are they if they're overrun with homeless, drugs, crime, etc. we lose police and firefighters every day to better paying counties and towns.
- Stop the leaf pickup from the street, require residents to bag and put out bi-weekly.
- Stop the out of control growth. Address the southern wake county back roads that are too narrow and unable to support the population growth that drives them daily.
- Stop the overbuilding and removing all the natural areas. Taking away natural habitats for animals. We need more animal shelters and cheaper options for owing a pet.
- Stop trying to define everyone by race. The sooner we stop talking about race the quicker it will be a non issue.
- Sustainable growth, road maintenance, more libraries-, senior citizen or homestead discounts for taxes-, crime prevention, education and equitable distribution of funding
- Take back control of transportation planning from GoTriangle. Wake County needs to focus on our own transit issues. We have underused rail corridors that parallel overstressed roadways (to Fuquay Varina and to Zebulon/Knightdale), but GoTriangle did not even consider them in their commuter rail study. It is, practically speaking, impossible to use mass transit to access downtown Raleigh from major suburbs. Dense new developments along these corridors are helping provide more housing, but the complete lack of foresight on mass transit means that we will continue to have worsening traffic.
- Take into consideration the groups of people that face more challenges and barriers than the average person.
- Take politics out of public service. All humans are equal and should be provided with the same services despite religion, race, ethnicity, gender, age, education or economic status.
- Taxes continue to escalate. I don't mind paying as I am able to (even on a fixed retiree income) but I fear that this rise will become an issue for progress among the population at large.

- Teach the police that following all traffic laws might help them to start enforcing the laws. A
 police campaign showing us by example and then enforcing all basic traffic laws will cure
 congestion.
- The costs compared to pay have made it very unaffordable for many.
- The County is more than just Raleigh and Cary.
- The county provides a very high level of service and it shows. Biggest QoL suggestion would be enhanced trash pickup on roadways around the county, but this may be a state DOT issue
- The main issue is work opportunities are 40 minutes away from where I can afford to live in Garner
- The roads around the downtown region are in terrible condition I've had to replace my struts and fix flat tires twice in the last 3 years. Fill in the potholes, smooth out the pavement we pay too much in car registrations and taxes to have that nonsense in the densest area of the county.
- There is a deficit of locations for children to play without fear of cars, and an overdependence on personal vehicles. If we could improve public transportation and utilize the reduced footprint for green spaces, our community would be a much safer place.
- There is too much to talk about to fit in this little box. From my perspective, it seems like the budget is not going back into our community. When I was in middle school, granted that was almost 20 years ago, my ceiling tiles were falling down and there were mold in the classrooms. In high school, we didn't have enough textbooks in the classrooms. There is not enough public transit, and what we do have is not reliable. I once waited two hours for a bus in the middle of the day on a weekday. We need a rail system since the triangle is big enough now, and so many people keep moving here. There was all this hype about these new tech companies setting up in the triangle, I applied to jobs and so did plenty of people I knew around the area, but I doubt a single local got those jobs, they just moved people here from other places. It seems like (while housing prices would have gone up anyway), this was a huge reason housing prices went up like they did. Gentrification is out of hand. I like that my home city is growing, but I want it to grow ethically, and unfortunately that responsibility falls on the government.
- There needs to be a better system for property revaluations to make sure they are fair and accurate and make it easier for residents to challenge assessments. The 2024 reassessments were in no way fair and tax rates should have been decreased so taxes wouldn't increase as much as they did.
- There needs to be more continue education classes that are offered online or in the evenings.
 Wake county also needs to work on the housing crisis why do people have to make 3 times the rent when many jobs don't pay 3 times the rent. Wake county is becoming a place that the working class cab not offered to live it needs to change NOW.
- There's poor communication when applying for jobs. You have to look at your antiquated application system to know that you are no longer being considered. That's called ghosting and it's poor practice.
- These questions are so vague. Asked about Historical statues. We all have to learn good and bad about the History of our Country. Yet, we've erased all civil war artifacts that's like trying to erase the Holocaust and saying it never happened. Until we keep our eyes open, and learn from the past, and become better for the future, we'll just be stagnant

 ABOUT THE COMMUNITY

- This is a very open question but I'll try to stay on target. We need affordability in housing. Our
 AMI just increased so our Affordability guidelines should as well. We must have more housing in
 the 10-30% AMI range to address citizens basic needs of shelter, food and clothing. These 3
 things if addressed for ALL people will help to fix the variety of issues you asked about. Fix the
 root problems instead of treating the symptoms.
- This is more of a future suggestion, as I'm not sure how it could be applied to the current situation, but more density and mixed use areas (like more shops in the middle of or close to residential areas)! I can't drive, so I rely mostly on other people to get places. My immediate area is pretty walkable (lots of sidewalks and greenways), but everything is so spread out, it's prohibitively far to actually go anywhere like grocery stores or doctors, or even fast food. Buses don't run often enough or go to enough places, it takes an extremely long time to go even a couple miles; it's literally faster to walk than take a bus sometimes.
- Thoughtful commercial growth with resident input
- To be real honest y'all are talking about all these programs and I'd be happy to have the highways cleaned up and kept clean. For such a nice area the highways look like a trailer park? Also the bus system needs to be reassessed maybe turned into an Uber style system. Most buses except the college are empty every single time I see them. It would save a lot of money and not use fossil fuels needlessly if there is nobody on a bus and some areas it would be a good idea to keep busses. Also my protest tax doubled for no reason this year and I am a disabled veteran on disability Wake should have more Tax exemptions for seniors and vets and find a different way other then property tax(extortion)
- To help Latino communities and address or provide resources for single income household like side gigs or programs for the kids after school with the own transportation with no income limit .
- Too many Woke people in leadership positions
- Top priority for Wake County should be public schools (not charter schools that don't have to meet/follow same requirements for public schools). FUNDING for public schools should be the #1 priority of the County. Every kindergarten and first grade class should have full time IAs. Some of the school facilities are in DIRE need of updating. Teachers need raises. Schools need more counselors, less police presence. Prioritizing sidewalk and greenway connections to schools should be a consistent priority across the school system. It is incumbent on County Commissioners to fund the schools at the levels that are needed.
- traffic is becoming a problem
- Transit needs major improvements before it's too late. Why is driving the only real option to get from Raleigh to other parts of the triangle? We have a beautiful downtown Union Station that only gets a dozen trains per day...let's get more local & regional routes!
- Transportation for outlying areas is a large issue! Also, Medicaid parameters need to mesh with other county opportunities better. In order to qualify for Medicaid, your significant other cannot make over a certain amount of money. This takes the Medicaid recipient away from their only form of physical assistance. Not a very well thought out plan in my opinion.
- Try not to follow counties like Montgomery County in Maryland because that's why I moved here to get away from them.
- Try to think creatively about how to increase amount of child care options.
- Use common sense and decency when approving development. cutting through neighborhoods to reach new development is insane. Think about people not profit.

- Unincorporated areas of south Wake are not included in most all decisions etc. for Wake. We are
 in desperate need of safe roads (street lights, sidewalks), green space, etc. The population in far
 south unincorporated Raleigh has been exploding for years, yet no significant improvement on
 roadway safety, sidewalks, greenway access, etc.
- Use the tax payer money for good. Fight racism.
- Wake County allows for many people in "Grey areas" to slip through the cracks. For example, many financial aid programs will not offer assistance until you are already homeless or have received an eviction notice. Most people do not want to make their lives worse to ask for help. There are also very few avenues for adults with disabilities to receive advocacy and support services unless they are totally and permanently disabled from making an income.
- Wake County as a whole is a nice play to live. However, I believe they can do better as far as affordable housing goes and also Wake County is growing way to much.
- Wake county does not seem to care about residents that live in the unincorporated areas. They
 seem to assume that we all want to sell our property for a huge profit and move. Most of the
 people that still own large parcels want to keep it as farm land, but the county taxes are making
 that impossible to keep.
- Wake county has a lot to offer. I believe greater opportunities for affordable housing, and better
 pay for jobs is extremely important. I also believe paying our teachers a living wage and NOT
 having school vouchers would be beneficial for our community. Public schools are a very
 important and needed institutions. Also, we need to keep working harder to make everything
 available to all diverse people in our community.
- Wake County needs to encourage employers to hire physical disabled people. Physical disabled people need flexible work schedules that includes: remote work and hybrid work. Would it be possible to encourage industries to train the disabled for professional positions? Also, I see a lot of biotech coming to Wake County. Can they be encouraged to hire professional disabled people to work a minimum of 3 days from home? This applies to all industries. Careers are needed for the disabled. We don't want jobs (just over broke). We need companies that offer a minimum of 3 weeks of paid vacation, 12 holidays and paid week of Christmas off work.
- Wake county needs to look at the lack of ambulances most days instead of spending millions on
 a station in Cary. EMS personnel on ambulances test firefighters through out the county as if
 they work for them. They cannot move most patients by themselves. If it wasn't for the fire
 departments EMS could not perform their duties. Apparently the EMS staff is not being made
 to perform their duties. The run routine traffic to emergency calls. They need new
 management.
- Wake County relies on city services too much, leaving and county residents with fewer options for service and accessibility
- Wake county residents should ensure The Sheriff's department works closely with the federal
 government to remove those who have violated immigration laws and entered the country
 illegally. Wake county should develop a greenway from the hiking trails from blue jay point park
 to falls dam park. Wake county Board of elections should REQUIRE approve of citizenship to
 register to vote.
- WCPSS funding-there exists high quality staff and improvements in facilities. I Prefer WCPSS over charter schools but way too much fundraising is needed by PTAs to support their schools. The community is filling the gaps but they are widening.

- WE HAVE AN ABANDONED HOUSE ACROSS THE STREET FOR 20 YEARS. NO ONE AT THE COUNTY LEVEL WILL DO ANYTHING ABOUT IT AFTER NUMEROUS REQUESTS
- We live in the county, we are not happy with the environmental issues that impact water
 retention to our property because of our neighbor town. We feel that the water problems are in
 need of county corrections and better treatment. As senior adults, Wake County's biggest
 population, we need more attention (see introduction statements). Looks like we need more
 upright buildings, less ground cover with cement to better serve water retention problems, and
 add future growth.
- We lived just outside the Raleigh city limits and we might as well live in another country. My
 brother needs mental health care, but that will be impossible until I retire because there is no
 way for him to get around without me, since we live a mile from the Raleigh city limits. A bus
 service that extends to neighborhoods outside Raleigh would make his life so much easier.
 Thanks!
- We need comprehensive, realistic, and accessible affordable housing. Housing is often the primary need that people in our community have; often, other struggles (medical, mental health, substance use, etc.) will be much easier to impact and improve when someone has a safe place to stay without worrying about eviction, safety, or other concerns.
- We need more street lights and lower cars and home insurance
- We need normal people in office, not politicians. Racism and discrimination are huge problems.
 Need to reach out to more underserved communities.
- We need zoning laws to accommodate sustainable development that priorities a walkable and affordable city over car-centric suburban development. There are no connected sidewalks for me to safely leave my neighborhood to reach greenways nearby.
- What would it matter, they are going to continue to lie and allow themselves to be bought off by real estate companies and investors to build, build. The county makes a great deal of money and between the state and county they can afford to pay teachers more. The county also needs more EMS personnel and ambulances.
- WHEN MY HUSBAND WAS ALIVE, HE NEEDED TRANSPORTATION TO DAYCARE FOR SENIORS. I
 WOULD MAKE AN APPOINTMENT AND MANY TIMES, THE VAN WOULD NOT SHOW UP.

- When reviewing or deciding on major issues, use a cross section of residents from different economic, gender and races.
- While multi jurisdictional, enforcement of laws on roadways is essential as drivers get worse and more distracted. Education needs a total overhaul.
- Why do we need libraries, what is their purpose other than a place to go instead of home?

 WOULD ALSO LIKE TO SEE THE COMMUNITY COLLEGES OFFER CONTINUING EDUCATION FOR LIFETIME LEARNERS NOT INTERESTED IN COURSE CREDIT
- With the growth Wake county has, I believe property taxes are too high.
- Work on challenging systemic racism at all levels of the county government. Make anti-racism a priority in schools, housing, healthcare, small business ownership.
- Work with the cities to improve mass transit
- Would like to see local, smaller committees,

- Work on equitable development and stop developing so fast. The roads and infrastructure can't
 handle the influx. The amount of homes built on places like the Neuse River and what used to be
 nice natural spaces is causing more animals to be hit and issues. There should be a limit on
 developing.
- Work on expanding road access, make 540 free for residents.
- Work with surrounding counties to address the increased construction of homes that is leading
 to an increase in traffic congestion in Wake County. Many of the vehicles clogging our roads are
 from adjoining counties. Public transit within Wake County, and in partnership with adjoining
 counties, would make a difference.
