I'm very interested in serving on the board because I believe protecting the rights of residents living in adult care homes is imperative to a just society. Many times residents are ignored by adult care home workers or possibly family members out of convenience, but they deserve to know their rights and to be advocated for just as any other citizen.

## **Work Experience**

---

I have worked as certified nurse aide for almost three years now. I worked as private care nurse aide for one year at Right at Home LLC. where I went to patient's houses or memory care units to care for patients. I spent a lot of time with those living in adult care homes, and enjoyed my time there. I learned about the challenges residents face living in memory care facilities, including the decline in ability to care for themselves as well as possible neglect from workers. As a nurse aide in the hospital, I continue to advocate and care for my patients who are majority of the ages 50 and older. Patients undergoing a long term or short term stay at the hospital confront feelings of loneliness, helplessness, and fear. I make it my goal to combat those feelings and provide the necessary competency to care for their medical needs as well.

## **Volunteer Experience**

I have prior experience volunteering and managing a nonprofit called the Food Ark, a student led and run organization that aims to empower youth in the Triangle area to change their local food systems. I've orchestrated various programs aimed at educating high school and elementary school aged youth on food insecurity, agriculture, and food science. I started my journey with the Food Ark in high school as a chapter founder and president and continued to become a board of director and finally executive director. I learned how to engage community partners, manage a team, and be a proactive part of the community.

I completed my Bachelors of Science in Public Health at the University of North Carolina at Chapel Hill in May of 2022 and am pursuing my Masters in Science Nutrition now and expect to graduate in May of 2023. During my time as an undergrad one course in particular stands out as applicable to a position on the Adult Care Home Community Advisory Committee, which was titled Nutrition Across the Lifecycle. During this course our professor explored holistic nutrition across the lifespan, including those who may reside in an adult care home. I learned the fragility and importance of the bodily changes that occur as aging takes place as well as the mental impacts of such changes. This education helped develop my personal empathy toward those living in care homes as it was paired with my time as a nurse aide.
