RESOLUTION OF THE CARY TOWN COUNCIL TO RENAME THREE SEGMENTS OF MORRISVILLE CARPENTER ROAD

WHEREAS, the Carpenter Fire Station Road Bridge and Intersection Improvements Project includes realignment of a portion of Morrisville Carpenter Road; and

WHEREAS, when the Carpenter Fire Station Road Bridge and Intersection Improvements Project is complete, what is now Morrisville Carpenter Road will consist of three road segments requiring names; and

WHEREAS, the portion of existing Morrisville Carpenter Road beginning at the intersection of existing Saunders Grove and extending east 0.11 miles will be converted to a cul-de-sac street; and

WHEREAS, the portion of existing Morrisville Carpenter Road beginning at the intersection of existing Saunders Grove Lane and extending west 0.21 miles to the CSX railroad right-of-way will be realigned with existing Saunders Grove Lane; and

WHEREAS, the portion of existing Morrisville Carpenter Road beginning at the intersection with NC 55 Highway and extending 0.08 miles east to the CSX railroad right-of-way will align with existing Indian Wells Road; and

WHEREAS, to enhance public safety response and maintain an orderly street network, the Town Council of the Town of Cary has determined that these segments of Morrisville Carpenter Road should be renamed; and

WHEREAS, sections of Morrisville Carpenter Road lie within both the incorporated limits of the Town of Cary and the unincorporated limits of Wake County and the Town of Cary and Wake County are the entities with the authority to rename the sections of road located within their respective jurisdictions; and

WHEREAS, after having given full and complete consideration to the matter, it now appears to the satisfaction of the Town Council that the segments of Morrisville Carpenter Road located within Cary's jurisdiction shall be renamed to Quail Hunter Court, Saunders Grove Lane, and Indian Wells Road due to Council having heard no opposition from adjacent property owners and to further the purpose of public safety.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Cary, meeting in regular session, that the sections of the three segments of Morrisville Carpenter Road located within Cary's jurisdiction, depicted on Exhibit A attached hereto, are renamed to Quail Hunter Court, Saunders Grove Lane, and Indian Wells Road. Town Staff is hereby authorized to take any actions necessary to effectuate the change, including informing necessary parties of the name change, updating Town databases and maps, and installing new street signs.
