Tony, Hope you're doing well! Just wanted to update you on something we've been pursuing. Northern Wake station 5 has been unstaffed for a long time. No units have responded from that station since our new CAD went live in May of 2019.

Raleigh has recently done some parcel annexations creating a situation where there are only 27 parcels outside of 5 miles from the other Northern Wake stations that rely on NW5 for inclusion inside the 5 mile area. All 27 of those parcels are within 5 miles of either Durham Highway station 2 or Western Wake. Our intent is to close NW5 permanently and we're working on moving forward with that plan.

Do you see any issues with this? What do you need from us to make sure all of our collective "t's are crossed and I's are dotted"?
