

RESOLUTION  
FOR PUBLIC HEARING TO CONSIDER EXPANSION OF EXISTING FIRE TAX DISTRICT

WHEREAS, the current Wake County Fire Tax District extends west on Old Weaver Trail to the intersection of Creedmoor Road and north on Creedmoor Road to the Falls Lake Bridge north of Highway 98, leaving an underserved area in the most northwest part of Wake County; and

WHEREAS, North Carolina General Statutes §153A-303 authorizes the Wake County Board of Commissioners to annex territory to a service district upon finding that the area to be annexed is contiguous to the district, with at least one eighth of the area's aggregate external boundary coincident with the existing boundary of the district; and that the area to be annexed requires the services of the district; and

WHEREAS, pursuant to 153A-303, the Board of Commissioners must cause a report containing certain specified information to be prepared and filed with the Clerk of the Board; and

WHEREAS, the Board plans to hold a public hearing on October 21, 2024 at to consider expanding an existing fire tax district.

NOW THEREFORE, BE IT RESOLVED BY THE WAKE COUNTY BOARD OF COMMISSIONERS:

The Wake County Board of Commissioners resolve to call for a public hearing on October 21, 2024 at 2pm in the Wake County Board of Commissioners Chambers to consider the annexation of territory to the current Wake County Fire Tax District consistent with North Carolina General Statutes, and

That the Clerk to the Board is hereby directed to make such publications of the notice of public hearing regarding the proposed expansion of the service district as set forth in N.C.G.S. §153A-303, and

The County Manager or his designee is directed to prepare a report as required by N.C.G.S. §153A-303(d). The report shall include a map of the service district and the adjacent territory, showing the present and proposed boundaries of the district, a statement showing that the area to be annexed meets statutory requirements and standards, and a plan for extending services to the area to be annexed. This report shall be completed by September 20, 2024.
