Background – Community Capital

- Established in 2002 to support **capital investments** in projects addressing critical community issues.
- **Goals:**
 - Increase partnership between public, nonprofit and for-profit sectors;
 - Address critical countywide needs in a way that is financially sustainable and effective; and
 - Encourage sustainable financial operating plans that address countywide problems.

Funding Approach



- From 2002 to 2021, funded through County CIP
- Financially constrained
- Competitive process every four years



- Primary funding sourced by revenues from the Wake ABC Board
- Since 2022, facilitated a competitive process every two years

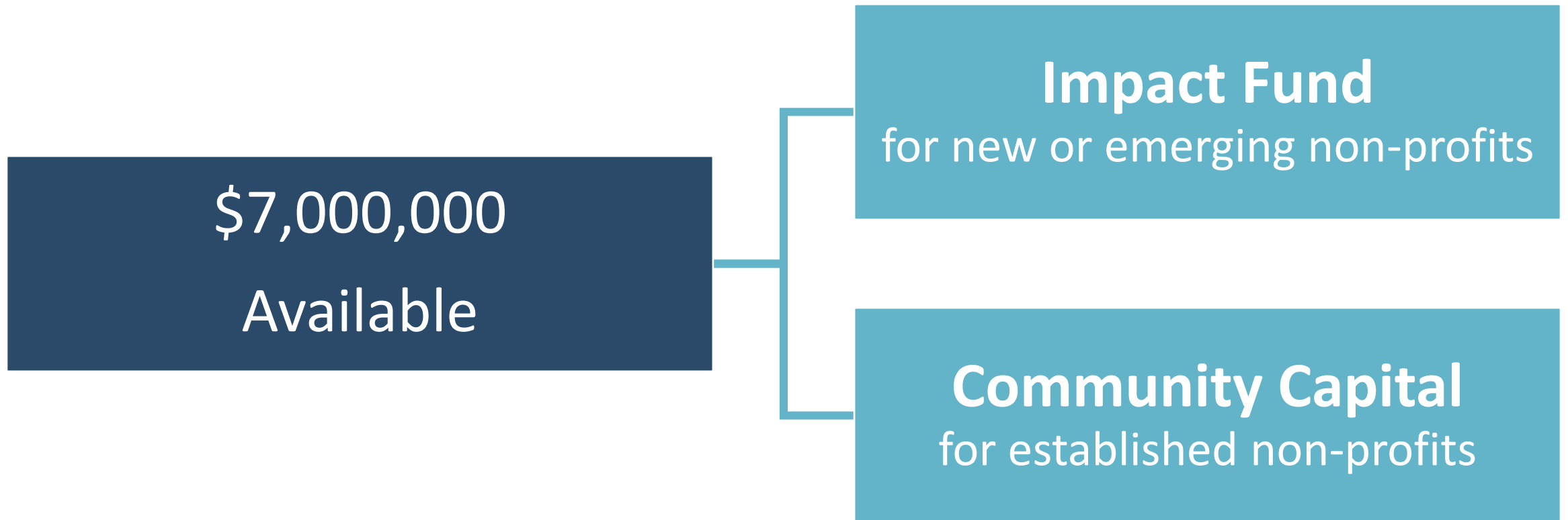


- Fund nonprofits that can rally additional community support
- County contributions up to 40% of a capital project

Who is eligible?

- **Non-profit organizations**
 - 501(c)(3) organizations, limited exceptions
 - Services must address a community need
 - If applicable, prior Community Capital grant awards are complete
- Project must be a **capital investment** (i.e., facilities, long-term leases, durable equipment)
 - Day-to-day operating expenses incurred through normal business are not eligible for grant funds

Impact Fund

Projects at a minimum must:

- ☐ Capital project greater than **\$25,000**
- ☐ Maximum funding request of **\$200,000**
- ☐ Rely on County funding for no more than 40% of total project funding
- ☐ County dollars are 'last in'
- ☐ Provide a detailed, **5-year** annual operating plan; the county does not intend to provide operating funds to support the capital project

Community Capital

Projects at a minimum must:

- ☐ Capital project greater than **\$100,000**
- ☐ Maximum funding request of **\$1,500,000**
- ☐ Rely on County funding for no more than 40% of total project funding
- ☐ County dollars are 'last in'
- ☐ Provide a detailed, **10-year** annual operating plan; the county does not intend to provide operating funds to support the capital project
- ☐ **Alternative strategies** analysis required

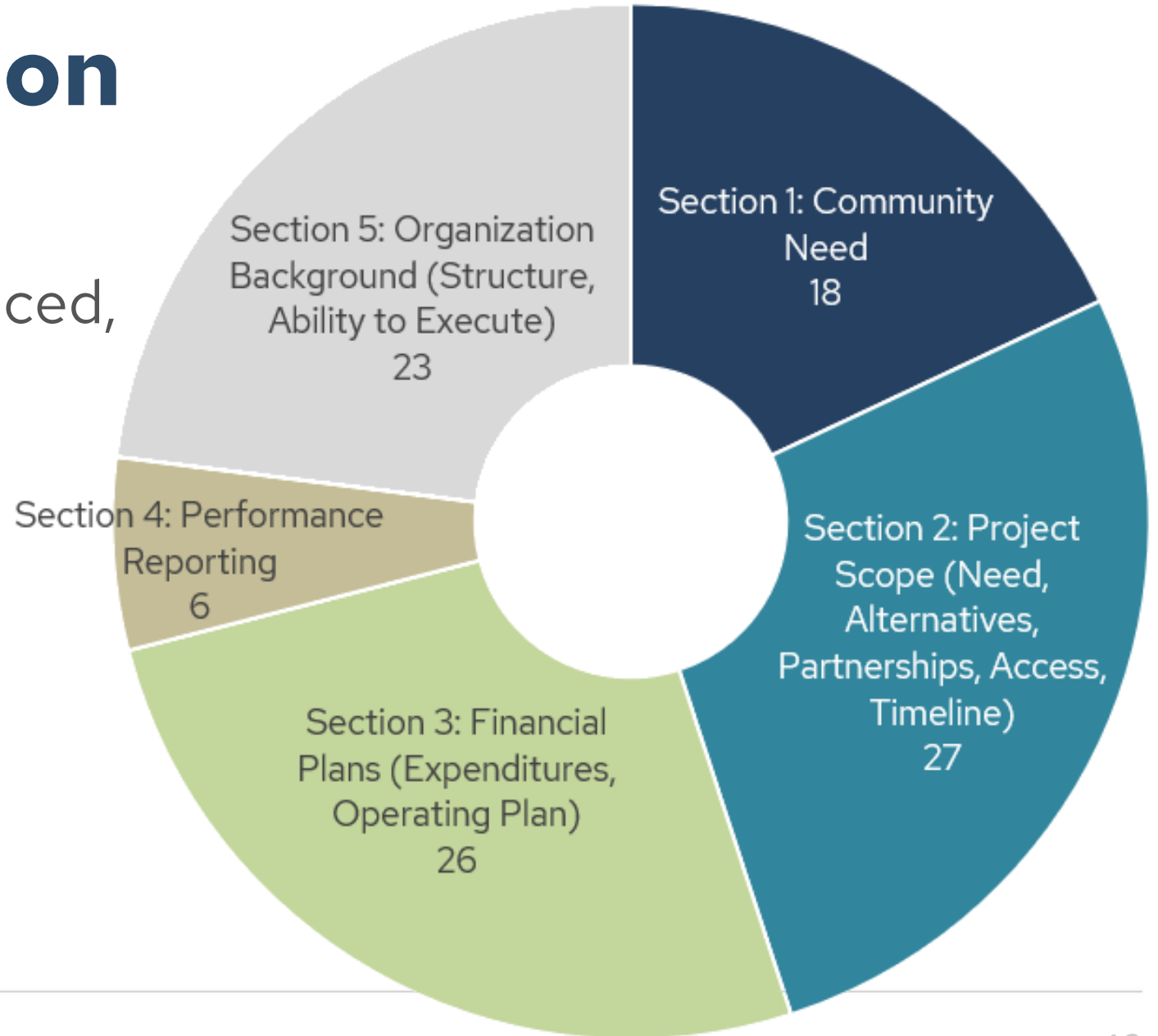
Priority Projects

Preferred projects should address key County priorities:

- Access to healthcare
- Behavioral health crisis prevention and recovery
- Food security
- Homelessness services
- Housing services

Project Evaluation

- Weights seek a well-balanced, documented plan
- Interview/presentation (not required)

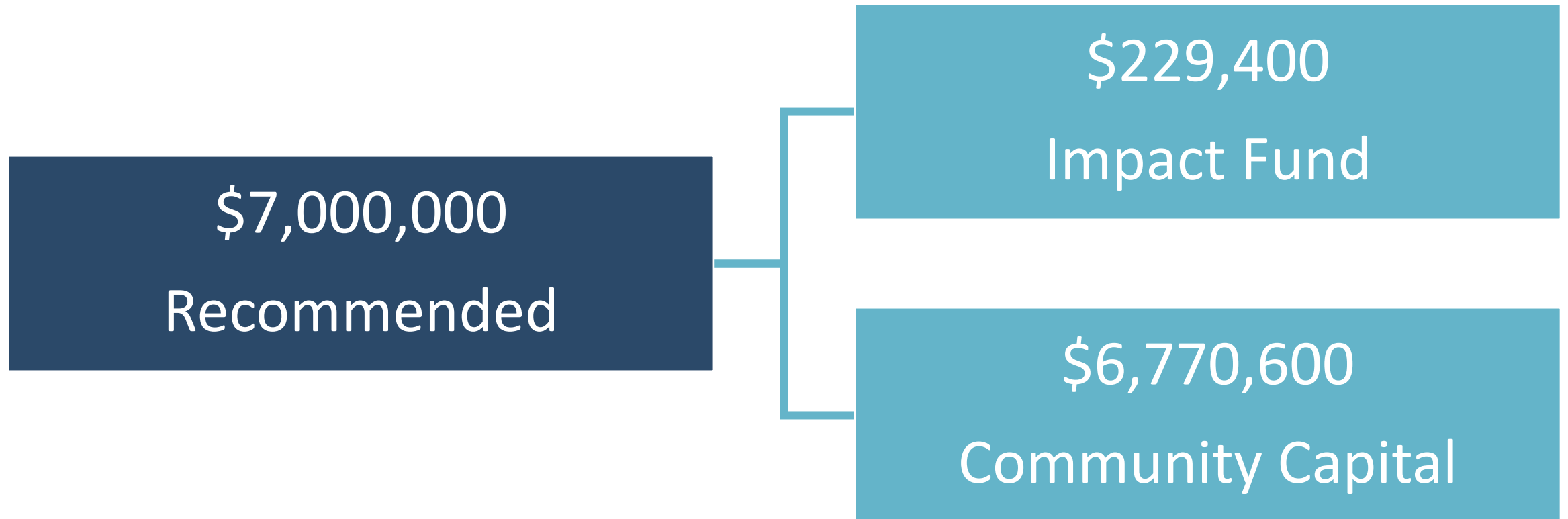
Emerging Trends Based on Proposal Reviews

- Multiple, concurrent capital campaigns in planning stages

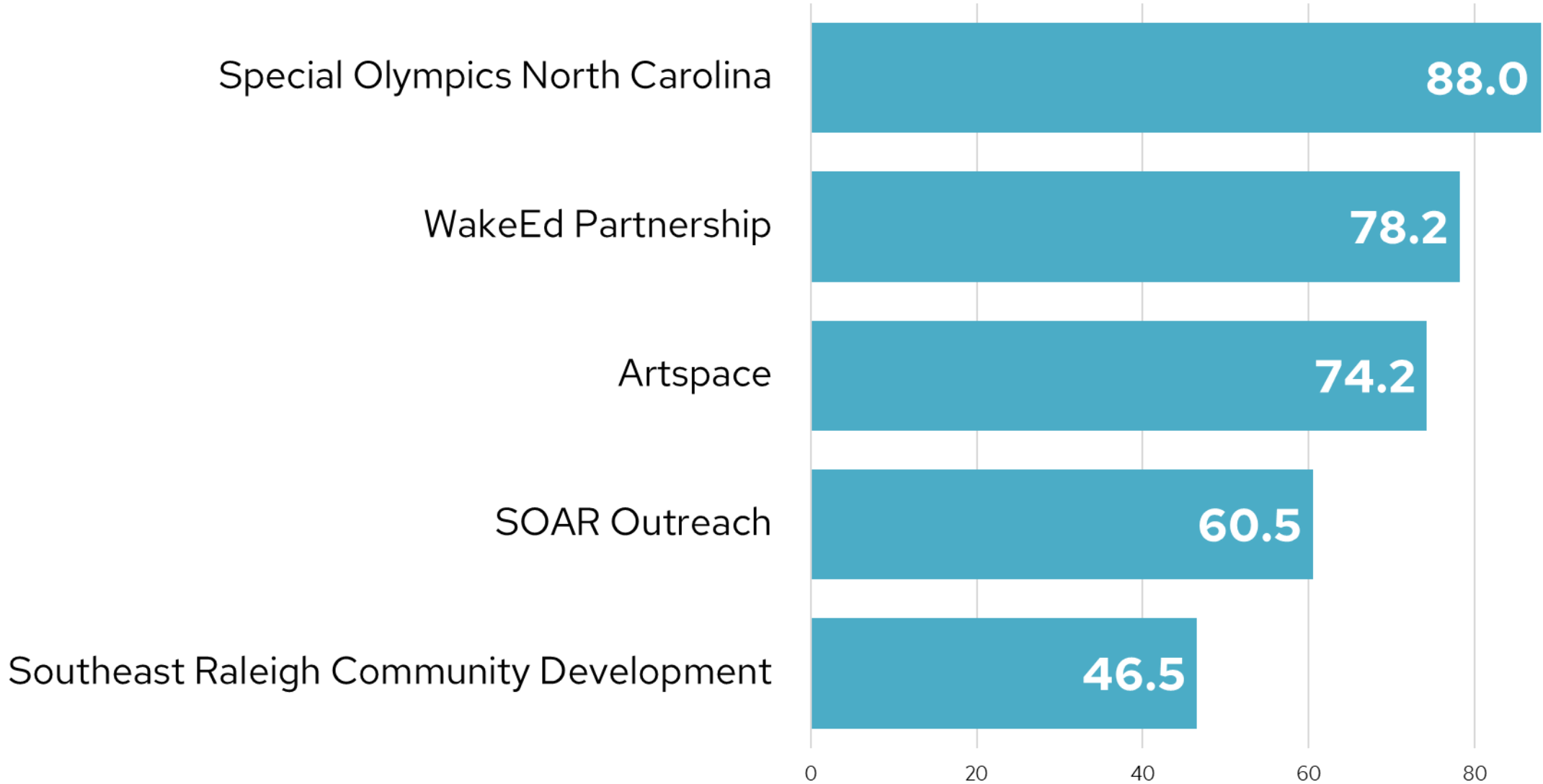

FY 2026 Community Capital Process



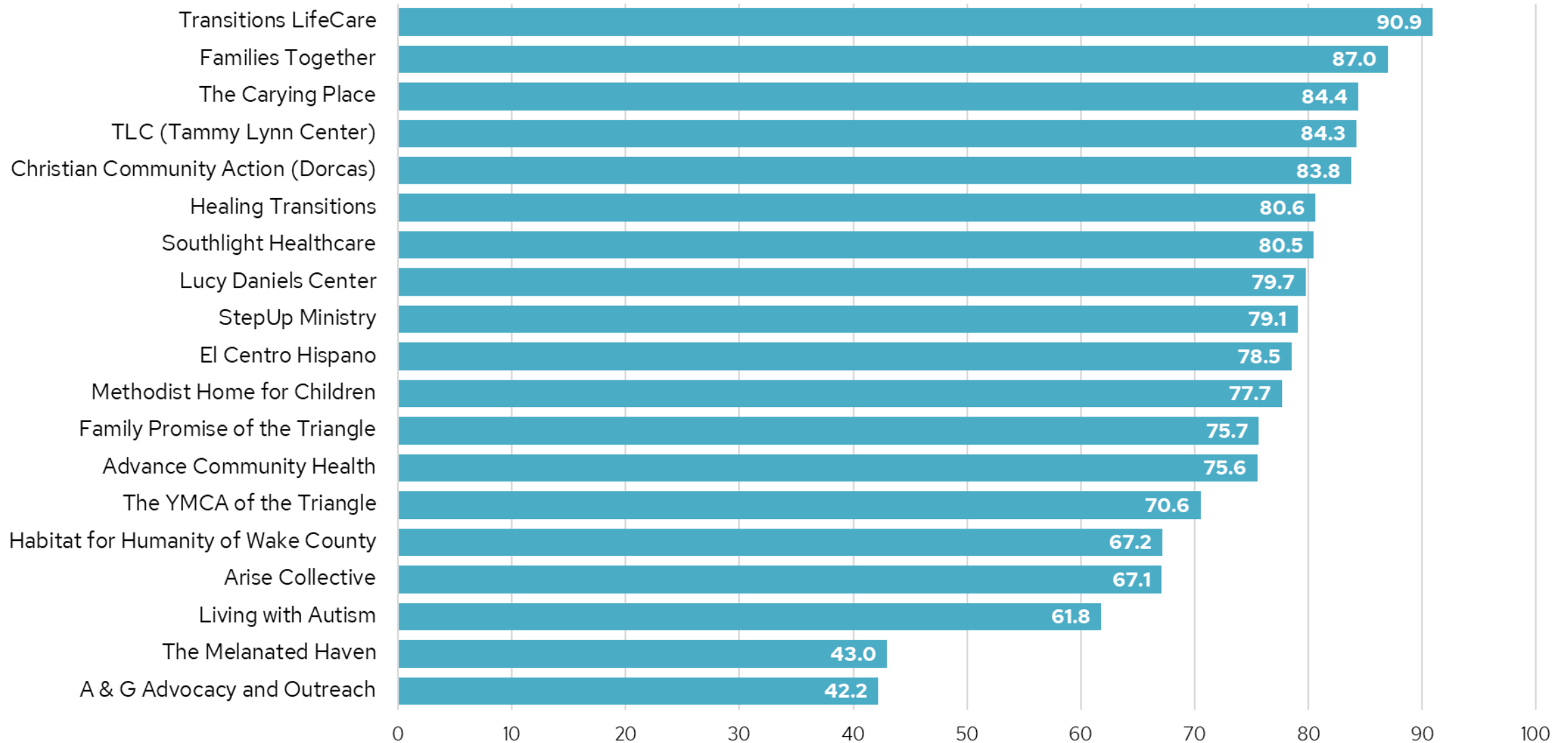

Impact Fund Project Submittals

Special Olympics of North Carolina

Requested: \$49,575 | Recommended: \$49,500

- Two 15-passenger vans for transporting individuals with intellectual or developmental disabilities (IDD) to local and regional events.
- Reduces the reliance on personal and coaches' vehicles to transport athletes.
- More than 3,900 Wake County youth and adults participate in Special Olympics, and it is projected to grow by at least 10% growth in the coming year.
- Matching funds are on hand.

WakeEd Partnership

Requested: \$25,000 | Recommended: \$25,000

- Facility renovations, including:
 - Roof replacement,
 - Double door installation, and
 - Light switch (electrical) reconfiguration.
- Improvements are needed to protect, store, and manage donated school supplies for distribution to Wake County teachers and classrooms.
- Work is expected to take place between January and May 2026.



Artspace

Requested: \$154,905 | Recommended: \$154,900

- Roof replacement and repairs of a 30,000 square foot facility that ensures the continuation of a locally owned visual arts and cultural center.
- Artspace provides professional development and studio space for local artists, free public programs and exhibitions, and accessible art education for all ages.
- An active plan is underway for matching funds, with decisions expected in early 2026.



Projects Not Recommended for Funding

SOAR Outreach

Requested: \$80,000

- Specialized vehicle for mobile distribution and outreach (pop-up events) supporting underserved populations.
- Promotes the accessibility of essential items, including school supplies, hygiene products, undergarments, diapers, feminine care, and digital tools.

Southeast Raleigh Community Development

Requested: \$80,000

- Two (2) transitional housing units for seniors, the disabled and veterans.
- Renovation costs (\$100K per home) include HVAC, electrical, plumbing, roofing, appliances, and landscaping.



Community Capital Project Submittals

Transitions LifeCare

Requested: \$145,930 | Recommended: \$145,900

- Replace 28 electric hospital beds and mattresses for those receiving palliative care, improving patient care and safety.
- Patients from a 10-county service area (94% from Wake County), including uninsured, underinsured, and unhoused residents.
- Matching funds secured through endowment earnings and fundraising pledges.



Families Together

Requested: \$1,072,245 | Recommended: \$1,072,200

- Rebuild and expand the Polly Street Emergency Shelter (destroyed by a fire) into a 12-unit non-congregate family shelter with on-site offices and supportive services.
- Serves primarily single mothers, two-parent households, and kinship caregivers.
- Matching funds are secured and/or pledged from insurance proceeds, pre-award expenses, and the City of Raleigh.

The Caring Place

Requested: \$1,500,000 | Recommended: \$970,000

- Eleven (11) transitional housing units and office and program space to help families through housing, financial literacy, and family services.
- Part of a \$26 million mixed-use development in Cary; includes 51 affordable rental apartments, a childcare center, and shared space.
- Partnerships with Greenwood Forest Baptist Church, the Town of Cary, and others.



Preliminary Image

TLC (Tammy Lynn Center)

Requested: \$569,462 | Recommended: \$400,000

- TLC serves children and adults with IDD and co-occurring complex medical conditions, most of whom are non-verbal, physically dependent, and require 24-hour skilled nursing.
- Supportive housing at its "Residents Village" for people with intellectual or developmental disabilities (IDD) receiving care.
- This phase will renovate the final intermediate care home (Civitan) to provide modern, advanced medical, therapeutic, and residential care in a home-like setting.



Christian Community Action (Dorcas)

Requested: \$1,500,000 | Recommended: \$750,000

- Renovation and expansion of Dorcas Plaza in Cary to:
 - Double the food pantry,
 - Enlarge community service and workforce development areas,
 - Create a new specialty retail space, and
 - Expand donation-processing and storage capacity.
- Dorcas reinvests earnings from the specialty retail into services for low- to moderate-income residents in western and southern Wake County.
- Leveraging owned, debt-free property, grant proposals to other foundations, and a campaign for the matching funds.



Healing Transitions

Requested: \$1,500,000 | Recommended: \$825,000

- Construction of a 17-unit, 25,000 sq. ft. apartment-style recovery housing community on the Women's Campus.
- Will serve up to 41 residents at a time, prioritizing family stability, reunification, and breaking cycles of addiction and trauma across generations.
- Matching funds include nearly 50% in secured commitments and cash, plus pending requests to major contributors and a future campaign.



Southlight Healthcare

Requested: \$1,500,000 | Recommended: \$750,000

- Construct a 12,000 sq. ft. Rapid Access Center adjacent to existing Raleigh Hub.
- Will provide walk-in behavioral health services, same-day clinical assessments, crisis stabilization, peer-led recovery support, and a training and education center.
- Matching funds include secured land, financing options and credit, and pending campaign pledges.



Lucy Daniels Center

Requested: \$600,000 | Recommended: \$450,000

- Purpose-built clinic space providing outpatient pediatric mental health treatment.
- One in five children in Wake County experiences a diagnosable mental health condition, but only 36% of psychiatrists accept new Medicaid patients.
- New clinic will triple capacity and serve approximately 1,500 children per year.
- Request helps fill an unexpected funding gap.

StepUp Ministry

Requested: \$1,000,000 | Recommended: \$550,000

- Replace the aging “StepUp House” with the construction of a new 8,000 sq. ft. headquarters and program facility.
- The new building will include classrooms, case management rooms, a digital literacy lab, childcare spaces, and outdoor learning areas.
- Matching funds include existing pledges and cash, plus pending grant applications and campaign pledges.



El Centro Hispano

Requested: \$164,445 | Recommended: \$76,200

- Staff recommends a pledge for the first five years of a 10-year lease for the Raleigh office, ensuring service continuity.
- Each year, more than 7,600 residents access El Centro Hispano's Raleigh programs and services, including:
 - Health navigation,
 - Nutrition and food support,
 - Early childhood education,
 - Digital literacy,
 - Tax assistance, and
 - Human services referrals.



Methodist Home for Children

Requested: \$377,360 | Recommended: \$281,300

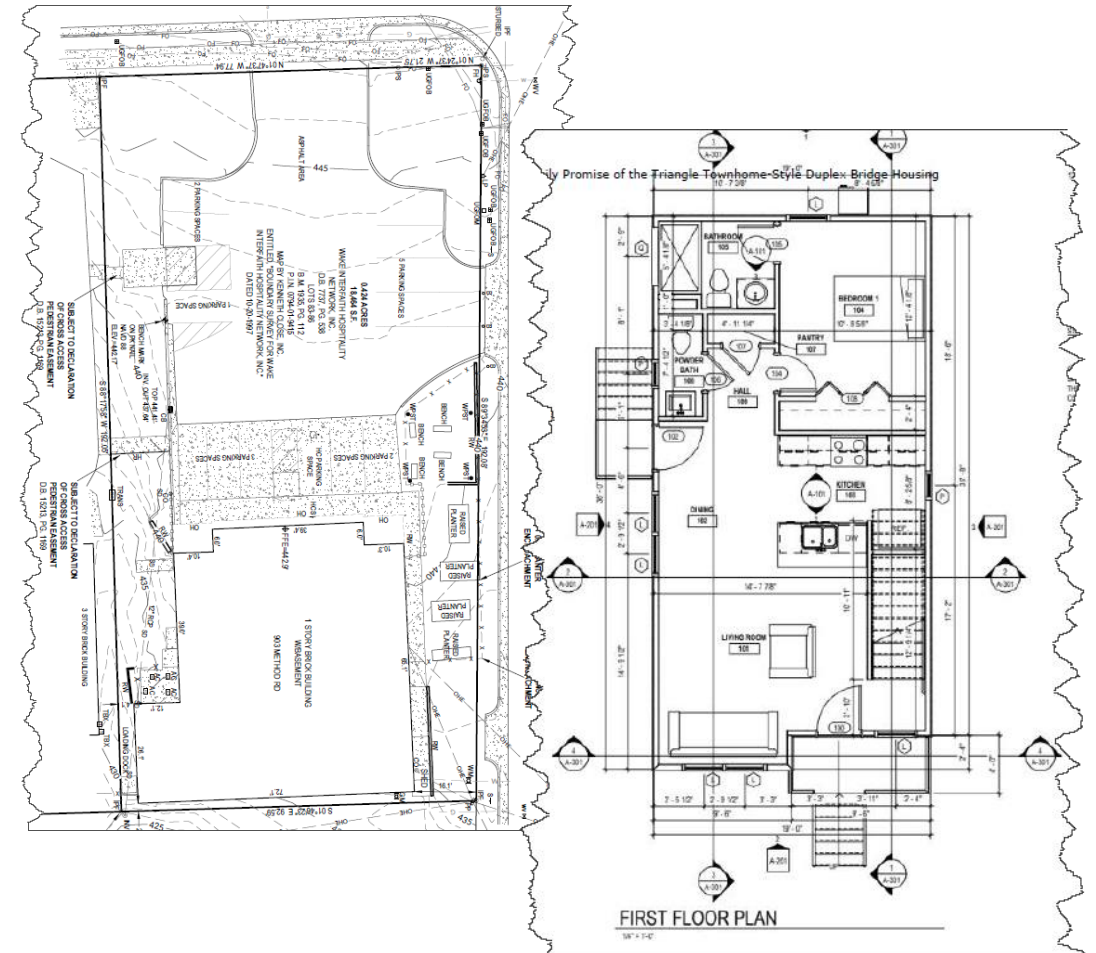
- Replacement of 17 air handling units and one boiler at the Jordan Child and Family Enrichment Center to improve reliability and reduce operating costs.
- The current, aging system is frequently failing, leading to classroom closures and interruptions in care that disproportionately affect low-income and working families.
- Matching funds include a private donor and reserves.



Family Promise of the Triangle

Requested: \$680,000 | Recommended: \$300,000

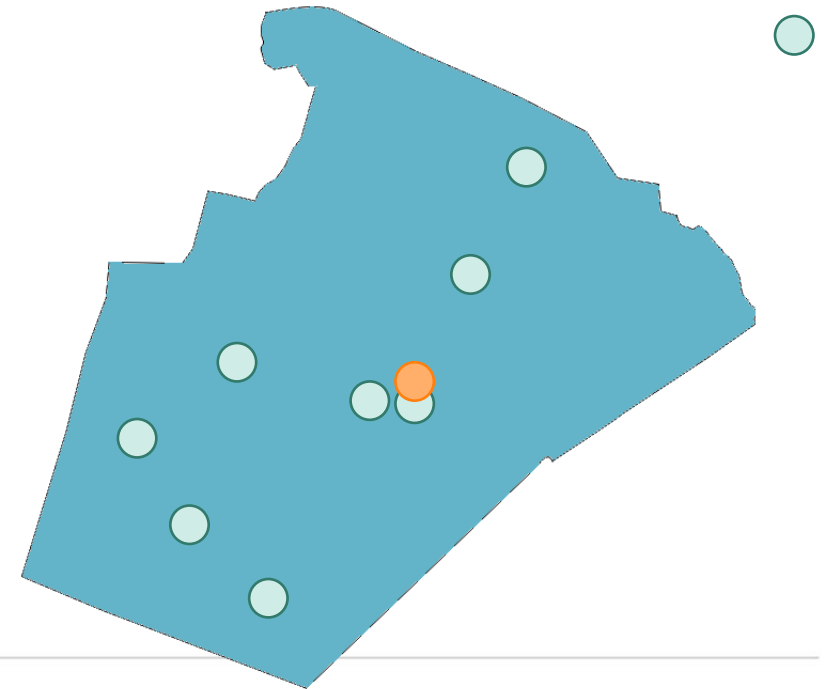
- Four (4) townhouse-style duplex units, serving up to eight (8) families with children, as a hybrid model between emergency shelter and transitional housing.
- Offers private, trauma-informed housing while receiving case management, job training, childcare support, and healthcare through partnerships.
- Matching funds include secured grants, board member pledges, and “community commitments”.



Advance Community Health

Requested: \$498,000 | Recommended: \$200,000

- Equipment and facility renovation of the Southeast Raleigh clinic off Rock Quarry Road, which includes:
 - Exam tables replacements,
 - Kiosk installations,
 - Lighting and fixture upgrades,
 - Generator replacement,
 - Elevator renovation,
 - HVAC improvements, and
 - Information technology infrastructure.
- Matching funds include reserves, federal grants, Duke Energy grants, and leveraging an existing line of credit.



Projects Not Recommended for Funding

A & G Advocacy and Outreach

Requested: \$812,000

- Partnering with Sherrill's University for an expansion and renovation of an existing 10,000 square foot facility, doubling its overall size.
- To address workforce shortages in construction, healthcare, and food service; limited mental health access; and reduce poverty.

Arise Collective

Requested: \$1,250,000

- Construction and rehabilitation of 18–26 units of safe, supportive housing for formerly incarcerated women in Wake County.
- Program anticipates serving 40 to 50 residents per year, helping participants achieve stability, education, and long-term independence.

Projects Not Recommended for Funding

Habitat for Humanity

Requested: \$180,000

- Construction of three new townhomes intended to provide supportive rental housing for adults with intellectual and developmental disabilities (IDD).
- Collaboration with Building Independence to provide supportive housing.

Living with Autism

Requested: \$192,750

- Renovation of a newly acquired facility in Cary to serve as a modern, accessible day program center for individuals with intellectual and developmental disabilities (IDD).
- Project includes mechanical and plumbing upgrades, installation of sensory and therapeutic rooms, and outdoor play areas.

Projects Not Recommended for Funding

The Melanated Haven

Requested: \$550,000

- Maternal health service facility where black birthing families access postpartum care, mental health support, and wellness services.
- Proposed the acquisition and renovation of a centrally located property to accommodate four families for a seven (7) day respite.

YMCA of the Triangle

Requested: \$320,000

- Replacement of the HVAC and dehumidification system serving the Alexander Family YMCA Natatorium.
- Failing system threatens closure of the pool, disrupting programs.
- Serves 10,000 residents annually, including free or subsidized access for vulnerable families.
