Dr. Jose Cabanas, Wake County EMS Director/Medical Director, said that Wake County is celebrating EMS week. He shared an overview of the EMS System.

He said the primary mission of EMS is to provide prompt, compassionate, clinically excellent care whenever and wherever needed. He shared a chart of the growth in Wake County. He shared the 2017 Department facts.

Chair Holmes said there is a county organizational chart and the citizens are at the top. She said that every e-mail regarding the budget is being read and considered by the board members.

Chair Holmes opened the public hearing.

Ms. Latoya Montague, 409 Viewmont Drive, Raleigh, thanked the Board of Commissioners' for their support of education on behalf of Communities and Schools in Wake County.

Mr. Rusty Carroll, 8525 Bellslake Road, Fuquay-Varina, NC, asked the Board of Commissioners for continued funding for the public schools and the Wake County Sheriff's office. He thanked the Board of Commissioners for their support in the past.

Ms. Monica Lavery, 5205 Caffentree Drive, Raleigh, NC, spoke about gentrification in her neighborhood. She supports more funding for Wake County Public Schools.

Ms. Angie Welsh, 4901 Waters Edge, Wake County Smart Start Board Chair, asked the board for support for pre-K programs.

Mr. Samuel Gunter, 5115 Shady Bluff Street, Durham, thanked the board and County Commissioners for the budget and the support for affordable housing funding. Ms. Sherry Presnall, 1801 Broomhurst Lane, Apex, N.C., PTA President, Apex High School, asked for the Board of Commissioners to support the Board of Education's budget request of funding for the Wake County School System.

Mr. Kevin Campbell, 2420 N Raleigh Boulevard, Raleigh, NC, President, CEO, Habitat for Humanity, thanked the board for supporting affordable housing and the County Manager's additional \$15 million in the budget.

Ms. Claire Green read aloud a note from Ms. Jessica Gutierrez (1065 Becker Street, Cary, NC) that left the meeting to care for a special needs child, asked the Board of Commissioners to support funding for Wake County Public Schools and invited board members to visit a special needs classroom and look for ways to improve safety in the classroom.

Mr. Joe Rappl, 212 Round About Road, Holly Springs, asked the board to fund affordable housing and look for ways to fund it beyond what the federal government provides.

Mr. Howard Manning, 187 High House Road, Cary N.C, President, Dorcas Ministries, commended the County Manager for the budget. He supports the additional funding for affordable housing.

Ms. Claire Green, 1214 Cole Court, Cary, NC said that classroom size is of concern and there are accommodations that are needed for her child. She asked the board to support the Board of Education's funding request.

Ms. Lisa Mead, 109 Ferncroft Ct., Cary, N.C asked the Board of Commissioners to fully fund the Board of Education's funding request.

Ms. Tangie Thompson, 241 Allen Grove Court, Apt 104, Raleigh, N.C. said that CASA has made a difference in her life and asked the board to support the low income communities.

Mr. Michael White, 313 Sunnybrook Road, Apt. 202, Raleigh, N. C. said that CASA provided him help when he was homeless. He asked the board to support the homeless in the community.

Mayor Frank Eagles, Town of Rolesville, thanked the Board of Commissioners for supporting feeding families and housing in Wake County. He said that he serves on the Human Services Board and thanked the board for their work.

Ms. Renee Sekel, Cary, NC asked the Board of Commissioners to support the Board of Education's funding request.

Ms. Attiya Taylor, Raleigh, N.C. asked the Board of Commissioners to fully fund the Board of Education's funding request.

Mr. Joey Stansbury, 5356 Meryton Parkway, Raleigh, asked the citizens to take a look at a position that the Board of Education is funding. He said that the board needs to look at the spending and its outcomes.

Ms. Angela Humphries, Wake Forest, N.C., spoke of affordable water in the Wake Forest area. She asked for the board to look at implementing higher salaries, accountability of funds for Wake County Public Schools, the burden of property tax increases, and affordability of services.

Mr. Lyle Warrick Raleigh, N.C. said that he supports additional affordable housing in Wake County.

Mr. Marc Segre, Raleigh, N.C. said that he volunteers at various agencies in Wake County. He supports additional affordable housing in Wake County. He asked the board to add additional funding each year.

Ms. Susan Parry, Raleigh, N.C., said she serves on the Board of Wake Up Wake County and served on the Wake County Board of Education. She said high quality schools are important and asked the Board of Commissioners to fully fund the Board of Education's funding request.

Ms. Julie Van Haefen, Apex/Cary, said she is President of the Wake County PTA Council, read aloud a PTA Resolution supporting the funding request of the Board of Education.

The meeting went into recess, then the meeting reconvened.

Mr. Andrew Blackburn, 2417 Trailwoods Drive, Raleigh, N. C., asked the Board of Commissioners to continue the funding stream of affordable housing.

Mr. Donald Belk, 220 Chimney Rise Drive, Cary, N. C., Chair, Friends of the Wake Soil and Water Conservation District, asked the board to continue the support of the watershed and thanked the board for the support of the Wake Soil and Water Conservation District.

Ms. Yvette Holmes, 113 S. Wilmington St. Raleigh, thanked the County Manager for recommending an additional \$15 million for affordable housing in Wake County.

Ms. Cindy Dial, 4644 Forest High Drive Raleigh, N. C., encouraged the board to continue to fund affordable housing in Wake County. She said an additional \$2.61 a week is minimal to spend toward funding.

Ms. Kim Coley, 202 Brittany Place, Cary, N. C. said that she has attended county meetings for the past eight months. She said a large portion of the budget is going to education. She asked that transparency toward funding be given. She asked for a plan of debt control. She asked board members to reconsider a tax increase.

Virginia Hall, 300 Duncan Vale Way, Cary, N.C, thanked the board for supporting affordable housing in Wake County.

A recipient of affordable housing thanked the Board of Commissioners for their support.

Mr. Peter Rumsey, 515 N. Ludworth Street, Raleigh, N. C. thanked the Board of Commissioner for supporting affordable housing in Wake County and investing in infrastructure.

Chair Holmes said the Budget Public Hearing would recess until 7 p.m.at the Wake County Commons.

Mr. Joe Desormeaux, Assistant Superintendent for Facilities, Wake County Public School System, said that the request is for appropriations in CIP 2013 and in the Seven Year Capital Improvement Program. He said the key drivers in the request are East Wake Middle School Construction, Infinity Center, and Middle Creek Transportation Design.

Commissioner Burns said that additional funds are already identified in CIP 2013 and in the 7 year plan. He asked about funds for upkeep of existing schools such as West Millbrook Middle and how the board can assist related to emergency situations that may arise. He asked why are there sewage issues at the school.

Mr. Desormeaux said that West Millbrook Middle School issues have been escalated. He said that funding has been identified in the operating budget to take care of sewage issues. He said a recurring maintenance plan is in place to address the issues.

Commissioner Portman asked for explanation of why there is less cost to rebuild than maintain an existing school. He asked for a specific explanation of East Wake Middle School and West Millbrook Middle School.

Mr. Desormeaux said at East Wake Middle School, there are faulty designs and higher operating costs to maintain the existing facility. He said West Millbrook Middle School has security issues, and it would be more costly to maintain in its existing state.

Commissioner Calabria asked for explanation of security funding for the schools as design and construction is considered.

Mr. Desormeaux said that security phones, card readers, cameras, access to central entranceways, have been added for security. He said there is a line item in the Capital Improvement Plan for security.

Commissioner Ford moved, seconded by Commissioner West, that the Board of Commissioners approve the following requests from the Board of Education for appropriations in CIP 2013 and in the Seven Year Capital Improvement Program:

1. Appropriate \$4,185,349 in CIP 2013 for partial construction funding for the East Wake Middle School Renovation.

2. Appropriate \$2,300,000 in the Seven Year CIP for Space Needs Analysis and Prioritization Projects (SNAP) including the Infinity Center and the Middle Creek Transportation Center. The motion carried by the following vote:

 Mr. Todd Taylor, Wake County Debt Manager, shared a background of the request.

- NC General Statute *160A-20* requires Board approval of Limited Obligation Bonds (LOBs)
- Today's request is the final step of Board approval
- In 2016 the County began utilizing bank construction period draw programs as a short-term, cost-saving financing tool for the County's capital needs
- Draw programs are temporary; hence, the County always plans for draw programs to be "taken out" and refinanced with permanent bonds
- Prior April 16, 2018 Board action:
 - Authorized Findings Resolution for proposed LOBs
 - Scheduled public hearing for May 21, 2018 for proposed LOBs
 - Directed staff to apply to LGC for approval of proposed LOBs

Mr. Taylor said that the short-term financing will be replaced with long-term financing.

- Proposed LOBs will:
 - Provide permanent "take out" financing of a portion of 2017
 Wells Fargo draw program
 - Additionally, provide partial funding for construction of two schools (Parkside and North Ridge Elementary) which have been accelerated into FY 2018

He shared the financing information and funding needs breakdown.

- Prior Authorized Projects under draw program \$156,000,000
- New Projects (Parkside and North Ridge Elementary) \$19,000,000
- Not to exceed total issuance amount \$175,000,000

Commissioner Portman moved, seconded by Commissioner Burns, that the Board of Commissioners:



Cardiac Arrest Registry to Enhance Survival







Outcome for Mental Health & Substance Use Patients Evaluated by APPs





Item Summary:

- Purpose: State statute requires the Board of Commissioners to approve all public bid construction projects more than \$500,000.
- Background: Wake County has responsibility for over 171 buildings totaling 4.87 million square feet of building space. In order to protect the County's investment in its facilities, staff periodically assess the condition of various building components and systems and to plan repairs or replacements.

The Public Safety Center completed constructed in 1990. This parking deck serves the Sheriff's Department, EMS and Fire Services 24 hours each day. Facility condition assessments show a need to replace the deck coating, water sealant, and expansion joints systems, which are original to when the Public Safety Center was constructed. All of these systems need to be replaced. The Level 3 deck coating system was replaced in 2012. This Board action approves a contract to replace the remaining deck coating on Levels 1 and 2.

- Board Goal: This Board action supports routine County business.
- Fiscal Impact: This project was previously funded in the FY2017 Capital Improvement Plan. The bids received are within the allocated budget.

Additional Information:

The Public Safety Center Parking Deck has three above grade parking levels containing 182 Parking Spaces that serve the Sheriff's Department, EMS and Fire Services. This facility opened in 1990. The parking deck coating systems and expansion joints are original to the construction and have exceeded their useful life. This project replaces the expansion joints; coating systems and restripes the entire deck.

Item Summary:

- Purpose: The Board of Commissioners approves real estate transactions associated with affordable housing development of Wake County Property.
- Background: Wake County partners with Habitat for Humanity to increase the stock of affordable housing in the County and to provide homeownership opportunities to low income individuals. In October 2016, Habitat for Humanity of Wake County submitted a proposal to purchase four vacant County owned lots at a nominal fee. Habitat for Humanity agreed to acquire the four lots for a total of \$40,500. The Wake County Board of Commissioners approved the sale on January 17, 2017. Wake County receives payment for each lot at the time the homebuyer closes with their lender.

Habitat has encountered flood prone soils on one parcel, 308 W. Jones Street in Fuquay Varina. At Habitat's request, this Board action would cancel the sale of this parcel and extend the development agreement deadline.

- Board Goal: This Board action complements housing affordability initiatives in the Social and Economic Vitality goal area.
- Fiscal Impact: The County will not receive payment in the amount of \$9,000 for the lot located at 308 W. Jones Street, Fuquay Varina, NC. However, the County will be able to dispose of this vacant lot in the future according to the Public Land Disposition Policy for Affordable Housing.

Additional Information:

Habitat for Humanity targets all households earning 30-60% of area median income (currently \$25,300-\$50,580 for a family of 4). All of Habitat's homeowners are first time homebuyers or have not owned a home in three years. Habitat homeowners contribute "sweat equity" by working alongside volunteers for the construction of their home. The average home sale price is \$140,000.

In February 2018, Habitat for Humanity of Wake County contacted Wake County HCR regarding the property located at 308 W. Jones Street in Fuquay Varina. Habitat was informed that the lot has poor soils and is prone to flooding. These factors would require additional foundation supports at a cost of approximately \$20,000. In order to keep the homes affordable and costs down, Habitat no longer wishes to purchase this lot.

Based on Habitat's current construction schedule, they also request that the Development Agreement be extended from May 31, 2018 to November 30, 2018. Habitat anticipates that the last home at 201 W. Jones Street to close with a homebuyer in July 2018.

FIRST ADDENDUM TO DEVELOPMENT AGREEMENT BETWEEN HABITAT FOR HUMANITY OF WAKE COUNTY, INC. AND WAKE COUNTY

WHEREAS, the undersigned are parties to a Development Agreement ("Agreement") entered by and between Habitat for Humanity of Wake County, Inc. with an effective date of April 12, 2017, by and between Wake County, ("County"), and Habitat for Humanity of Wake County, Inc. ("Developer"), for the purchase and sale of four (4) lots (collectively referred to as "Lots") to be developed for affordable housing. Said Lots are more particularly identified in *Exhibit A* attached to the Agreement and are located in the Town of Fuquay-Varina and the Town of Zebulon; and

WHEREAS, the Agreement identifies the Lots and the per lot sales price as follows:

120 Lawrence Street, Fuquay-Varina (\$9,000)308 W. Jones Street, Fuquay-Varina (\$9,000)201 E. Jones Street, Fuquay-Varina (\$9,000)507 N. Gill Street, Zebulon (\$13,500)

WHEREAS, the Agreement expires on May 31, 2018 and all homes to be constructed by Developer on the Lots are to be sold on or before May 31, 2018; and

WHEREAS, Developer has requested a written amendment to the Agreement as described herein and County, acting by and through approval of its Board of Commissioners mutually agrees to the amendment as set forth herein.

WHEREBY, by and through the execution of this First Addendum to Development Agreement Between Habitat for Humanity of Wake County, Inc. and Wake County, the parties hereby mutually agree to amend the Agreement as follows:

- <u>"Lots" Removal of 308 W. Jones Street</u>: All references to 308 W. Jones Street, including the legal description for 308 W. Jones Street included in *Exhibit A* of the Agreement shall be removed. The lot identified as 308 W. Jones Street, Fuquay-Varina at a sales price of \$9,000 shall be released from said Agreement and the total purchase price to be paid by Developer for the remaining three (3) Lots shall be adjusted from \$40,500 to \$31,500.
- 2. <u>Expiration of Agreement & Deadline for Sale of Homes</u>: The Agreement shall be extended through November 30, 2018 and all deadlines to be completed by Developer, including the sale of all homes developed on the Lots, as amended herein, shall be mutually extended to November 30, 2018.

All other terms and conditions of the Amendment shall remain the same and in full force and effect.

Item Title: Sale of Four County-Owned Lots to Habitat for Humanity of Wake County to Increase the Stock of Affordable Housing within Wake County and Provide Homeownership Opportunities for Low Income Individuals

Specific Action Requested:

That the Board of Commissioners approves the sale of four lots at a total purchase price of \$40,500 in Fuquay-Varina and Zebulon to Habitat for Humanity of Wake County, subject to terms and conditions acceptable to the County Attorney.

Item Summary:

Beginning in 1998, Wake County's Housing and Community Revitalization (HCR) department worked in partnership with the Town of Fuquay Varina and the Consolidated School Redevelopment Commission to revitalize the Consolidated School neighborhood located within the Town of Fuquay Varina. As part of this partnership, the following projects were completed:

- A building was renovated as a five star daycare center
- A building was renovated to provide 17 units of affordable housing to seniors
- Affordable in-fill single family housing has been built and sold
- A community center was renovated
- Sidewalks were installed
- An 18 unit subdivision was created

As one part of the revitalization effort, Wake County purchased property in the neighborhood and subdivided it into 18 single-family lots. In June 2009 & 2015, the Board of Commissioners approved the sale of nine lots to Habitat for Humanity of Wake County. Construction was completed on all nine lots in June 2016. Wake County also acquired additional property in the neighborhood for revitalization. There are 6 remaining vacant lots in Consolidated School neighborhood of Fuquay-Varina.

In February 2016, Wake County foreclosed on a home located in Zebulon that was unlivable. HCR partnered with the Zebulon Fire Department to conduct volunteer burn on the property for training purposes. It is now a vacant lot.

In October 2016, Habitat for Humanity of Wake County submitted a proposal to purchase the following County owned lots at a very nominal fee. Wake County provided a counter proposal and offered the lots at the following purchase prices:

- 120 Lawrence Street, Fuquay-Varina (includes 124 Lawrence Street) -\$9,000
- 308 W. Jones Street, Fuquay-Varina \$9,000
- 201 W. Jones Street, Fuquay-Varina \$9,000
- 507 N. Gill Street, Zebulon \$13,500

Habitat for Humanity accepted the counter offer.

Habitat for Humanity targets all households earning 30-60% of area median income (currently \$23,000-\$45,960 for a family of four). All Habitat's homeowners are first time homebuyers or have not owned a home in three years. Habitat homeowners contribute "sweat equity" by working alongside volunteers for the construction of their home. The average home sale price is \$140,000.

Habitat has built 188 homes in the last five years. Home equity is the largest single wealth building factor among families in the lower income groups. Families are able to use their home ownership as a springboard for educational achievements and more positive health outcomes.

Habitat plans to start construction on the home in Zebulon in early spring 2017. The Fuquay-Varina homes will be completed by Spring 2018.

Approve Business Development Fund Request for Support of the International Bluegrass Music Association Convention

That the Board of Commissioners approves a recurring funding request for \$75,000 in additional Greater Raleigh Convention and Visitors Bureau Business Development Funds to support the International Bluegrass Music Association Convention each year from 2018 through 2021

Item Title: Approve Business Development Fund Request for Support of the International Bluegrass Music Association Convention

Specific Action Requested:

That the Board of Commissioners approves a recurring funding request for \$75,000 in additional Greater Raleigh Convention and Visitors Bureau Business Development Funds to support the International Bluegrass Music Association Convention each year from 2018 through 2021.

Item Summary:

- Purpose: The Greater Raleigh Convention and Visitors Bureau (GRCVB) is authorized to award Business Development Grants (BDF) grants up to \$100,000. Awards exceeding this amount may be offered upon approval by Wake County and the City of Raleigh.
- Background: The Greater Raleigh Convention and Visitors Bureau (GRCVB) is requesting approval to award up to \$175,000 annually in Business Development Funds for 2018 through 2021 (cumulative \$700,000) to support the International Bluegrass Music Association Convention and Bluegrass Festival. This is an increase of \$75,000 per year. The GRCVB Business Development Fund (BDF) was approved by the City of Raleigh and Wake County in April 2007. The BDF uses \$600,000 in revenues from the Room Occupancy Tax and Prepared Food and Beverage Tax "to fund grants on behalf of major convention and meeting groups utilizing the Raleigh Convention Center for the Benefits of the Wake County economy." The additional funding will be applied towards convention related expenses.
- Fiscal Impact: Funds are appropriated to GRCVB through the Interlocal Agreement and associated amendments governing the Wake County Room Occupancy and Prepared food and Beverage Taxes. There is no fiscal impact to Wake County.

Additional Information:

The GRCVB Board of Directors previously approved \$100,000 for the IBMA's World of Bluegrass Convention and Wide Open Bluegrass festival for 2013-2018. The *additional* \$75,000, if approved, will be used to offset convention and signature expenses, which have continued to increase. The GRCVB Board supported the increase and extension through 2021 at their April 17, 2018 meeting.

The City of Raleigh approved the request on May 15, 2018. The BDF is funded within the 85% of the allocation of Room Occupancy Tax and Prepared Food and Beverage tax revenues dedicated to the Convention Center financing. The GRCVB can accommodate this request within their annual BDF allocation.

IBMA's World of Bluegrass is a three-day Business Conference, an awards show, and a two-day Festival. The weekend festival includes ticketed concerts at the Red Hat Amphitheater as IBMA's primary fundraiser; plus, a free Street Fest organized by a Local Organizing Committee featuring seven additional stages, an arts market, local vendors, barbecue championship, and more. The events attract thousands of fans, industry professionals, media, and musicians to Raleigh and Wake County from 45 different States and 11 foreign countries. Except for 2015, when the events were moved indoors due to Hurricane Joaquin, the attendance numbers – and consequently the direct economic impact to Raleigh and Wake County – have grown every year.

Approve Hospitality Tax Small Projects Funding Commitments

That the Board of Commissioners commits Hospitality Tax Small Projects funding in the amounts of: \$500,000 for the NC Museum of Natural Sciences, \$1,250,000 for the Triangle Aquatic Center, \$1,000,000 for the Town of Knightdale, \$400,000 for the Town of Cary and \$500,000 for the Town of Apex.

Item Title: Approve Hospitality Tax Small Projects Funding Commitments

Specific Action Requested:

That the Board of Commissioners commits Hospitality Tax Small Projects funding in the amounts of: \$500,000 for the NC Museum of Natural Sciences, \$1,250,000 for the Triangle Aquatic Center, \$1,000,000 for the Town of Knightdale, \$400,000 for the Town of Cary and \$500,000 for the Town of Apex.

Item Summary:

- Purpose: The 20th Amendment to the Revised Interlocal Agreement between Wake County and the City of Raleigh Relating to Room Occupancy and Prepared Food and Beverage Tax Revenues provides Wake County with \$2,000,000 annually for the purpose of providing funding for community projects in accordance with the enabling legislation, at the sole discretion of the County. The Board is asked to approve the projects that will receive a funding commitment.
- Background: In October 2017, the Board approved a competitive process to solicit proposals from organizations to develop partnership and to leverage resources to address projects supporting arts, cultural, sports or convention activities in Wake County. The Hospitality Tax Small Projects fund has approximately \$3.6 million available from FY2017 and FY2018 for award. The Board received presentations on the process at the April 19, 2018 and May 14, 2018 Board Work Sessions. Based on feedback from the Board, staff recommends commitments to five projects and total funding of \$3.65 million.
- Fiscal Impact: The staff recommendation will fully allocate the Small Projects funding available from FY2017 and FY2018 along with \$48,680 from FY2019.

Additional Information:

The Hospitality Tax Small Capital Projects funding is intended to accomplish the following goals:

- Provide activities and amenities for residents and visitors to Wake County to generate overnight stays and patronage of food and beverage establishments.
- Enhance our cultural, sports and arts opportunities by addressing an unmet need, inadequate existing facilities or a future need that supports and improves the quality of life in Wake County.
- Develop an increased capacity in Wake County for partnerships between public, nonprofit and for-profit sectors.

Hospitality Tax projects are intended to be capital projects and not funding for recurring operating needs. A capital project is defined as expenditures for facilities or projects that generally cost \$100,000 or more and typically require longer than one

year to complete. The County does not intend to fund recurring operational needs that may arise as a result of a funded Hospitality Tax project.

A review team of County staff and community representatives reviewed each proposal, received presentations and conducted interviews with each project team. Each project was scored by the review team using established criteria included in the RFP:

- Project overview and objectives demonstration of unmet need, need for County funds, partnerships, mechanism to track and measure success and advancement of Hospitality Tax Operating Principles
- Project capital budget mix of funding sources, funding secured, ratio of county funds, schedule of expenditures, impacts on existing infrastructure
- Project timeline project readiness, obstacles to completion, status of land acquisition, and specific project plan
- Project operating plan completeness of 10-year operating plan demonstrating revenues to support operations and defensible basis for projection
- Project impact on visitors and return on investment countywide reach, ability to attract day visitors within 50 miles of project and overnight visitors and return on investment calculation
- Organizational information proven track record on previous projects that are performing as expected

The Board is requested to determine which projects will be selected to receive Hospitality Tax Capital Funding and the amounts available for each project. Projects receiving funding commitments by the Board will be required to enter funding agreements with the County that will outline any contingencies or milestones that must be achieved prior to payment to the project. The County funds will be the last dollars provided for any of the approved projects. The Board will be asked to approve each of the funding agreements at a later date.

Based on feedback from the Board of Commissioners at the April 19, 2018 and May 14, 2018 Work Sessions, the County Manager has recommended that the Board approve funding commitments for the following projects at the level indicated in the chart below. This recommendation will fully allocate the Small Projects funding available from FY2017 and FY2018 along with \$48,680 from FY2019.

Allocation of FY 2018 Community Capital Project Funds

That the Board of Commissioners:

- 1. Commits Community Capital Project Funds for the fiscal years 2018 through 2022 in the amounts of: \$498,000 for The Green Chair Project, \$500,000 for Healing Transitions, \$500,000 for Dorcas Ministries, \$128,000 for Poe Center, and \$500,000 for YMCA of the Triangle; and,
- 2. Authorizes the County Manager to enter into memorandums of agreement with the Green Chair Project, Healing Transitions, Dorcas Ministries, Poe Center, and YMCA of the Triangle

Item Title: Allocation of FY 2018 Community Capital Project Funds

Specific Action Requested:

That the Board of Commissioners:

- 1. Commits Community Capital Project Funds for the fiscal years 2018 through 2022 in the amounts of: \$498,000 for The Green Chair Project, \$500,000 for Healing Transitions, \$500,000 for Dorcas Ministries, \$128,000 for Poe Center, and \$500,000 for YMCA of the Triangle; and,
- 2. Authorizes the County Manager to enter into memorandums of agreement with the Green Chair Project, Healing Transitions, Dorcas Ministries, Poe Center, and YMCA of the Triangle.

Item Summary:

- Purpose: The Community Capital Program uses a competitive, criteria-based process to award capital investments that address critical, communitywide issues. This item seeks the Board of Commissioner's approval to commit the FY 2018 Community Capital funding as presented during the April 2018 Work Session.
- Background: The Community Capital program was created in 2002 to fund partnership opportunities with community service providers. In October 2017, the Board approved a competitive process to solicit proposals from organizations. The FY 2018 Community Capital Program has a total of \$2,315,000 available from FY2019 to FY2022 for award. At the April 9, 2018 Work Session, staff presented the FY 2018 Community Capital project submissions that were recommended for funding following the competitive evaluation process.
- Board Goal: The community organizations recommended to receive funding provide services that complement several initiatives in the Education and Social and Economic Vitality goal areas.
- Fiscal Impact: There were five recommended projects presented with a total of \$2,126,000 of Community Capital funding allocated over the FY 2019 to FY 2022 award period. \$189,000 of Community Capital funding was recommended to be reserved for future consideration. The following charts depict the Community Capital funding available and recommended by project and fiscal year.

Additional Information:

There is currently \$2,315,000 available to allocate for new community capital projects, of which funds are planned to be distributed between FY 2019 and FY 2022.

On October 2, 2017, the Board of Commissioners approved the process for selection of projects to receive Community Capital funding. Projects were reviewed and selected to receive funding through a competitive, analytical process which included a request for proposals, submissions by applicants, finalist interviews, and analysis by an evaluation team comprised of external and internal stakeholders.

Seven projects were submitted through the Community Capital RFP process requesting a total of \$5,514,946. The Community Capital evaluation team reviewed the seven submitted projects and have recommended five of the project submissions for funding.

On April 9, 2018, staff presented the evaluation team's recommendation for Community Capital funding during the April Work Session. The five projects recommended for funding are described in detail below.

The Green Chair Project

Funding in the amount of \$498,000 has been recommended for The Green Chair Project's "Furnish the Future" project. This project will help further The Green Chair Project's purpose of redirecting gently used furnishings to help families transiting into stabile housing. The Community Capital funding will help the organization acquire a permanent warehouse space to serve customers and provide needed facility enhancements to improve the flow and capacity of the showrooms, as well as expanding volunteer spaces. This initiative provides for larger, more functional permanent facility, complete with the upgrades and renovations necessary to allow The Green Chair Project to meet their goal of reaching at least 1,000 Wake County families by the year 2020.

Healing Transitions

Funding in the amount of \$500,000 has been recommended for Healing Transitions' expanded men's emergency shelter and recovery bed project. This project will allow Healing Transitions to increase the availability of their men's emergency and recovery shelter beds. Currently, the shelter has been overcapacity in providing this vital temporary housing to a growing Wake County homeless population. Access to these beds not only provides needed shelter to those without anywhere else to turn, but also additional space for those individuals in need of substance abuse treatment to receive the assistance they need.

Dorcas Ministries

Funding in the amount of \$500,000 has been recommend for Dorcas Ministries' Western Wake Social Services Building project. Dorcas Ministries plans to expand their current service facility space with the construction of a new social services building to serve the Western Wake County area. Through the use of Community Capital funding, Dorcas Ministries plans to house multiple service providers to create a single location for in-need residents of western Wake County to seek social services and assistance.

Poe Center

Funding in the amount of \$128,000 has been recommended for the Alice Aycock Poe Center for Health Education. With this funding, the Poe Center plans to make key facility upgrades and renovations necessary to keep the facility up to date with the leading edge in health science education.

YMCA of the Triangle

Funding in the amount of \$500,000 has been recommended for the YMCA of the Triangle's Southeast Raleigh Elementary School/YMCA project. This Community Capital funding will help Triangle YMCA make their joint vision (along with Wake County Public School System and Wake County) a reality in bring together public and non-profit resources to support and serve the southeast Raleigh community in order to close the achievement gap, provide state-of-the-art health facilities, and expand access to a community that will benefit from YMCA programs and services.

Projects Not Recommended for Funding

Of the seven total projects submitted to the Community Capital process for funding, two were not recommended for funding, they are: Passage Home, which requested \$1 million for an Agricultural and Workforce Center, and Rex Healthcare Foundation, which requested \$263,000 for renovations to the UNC Rex Rehabilitation and Nursing Care Center.

Memorandums of Understanding

Once approved, each project will enter into a memorandum of understating with Wake County that will include the stated use of project funds, conditions of funding, reporting requirements, and monitoring to be done for each project. Also to be included in the agreements are provisions for the repayment of funds if terms of the agreement are not met or if the project ceases to be used for the purposes stated in the agreement.



Item Summary:

Wake County Public School System Capital Improvement Program Appropriations

That the Board of Commissioners approves the following requests from the Board of Education for appropriations in CIP 2013 and in the Seven Year Capital Improvement Program:

- 1. Appropriates \$4,185,349 in CIP 2013 for partial construction funding for the East Wake Middle School Renovation.
- 2. Appropriates \$2,300,000 in the Seven Year CIP for Space Needs Analysis and Prioritization Projects (SNAP) including the Infinity Center and the Middle Creek Transportation Center

Item Title: Wake County Public School System Capital Improvement Program Appropriations

Specific Action Requested:

That the Board of Commissioners approves the following requests from the Board of Education for appropriations in CIP 2013 and in the Seven Year Capital Improvement Program.

- 1. Appropriates \$4,185,349 in CIP 2013 for partial construction funding for the East Wake Middle School Renovation.
- 2. Appropriates \$2,300,000 in the Seven Year CIP for Space Needs Analysis and Prioritization Projects (SNAP) including the Infinity Center and the Middle Creek Transportation Center.

Item Summary:

- Purpose: The Board of Commissioners is statutorily responsible to fund school system's capital projects, and approves all appropriation of funds.
- Background: Beginning with the FY 2017-2023 CIP, the Board of Education and the Board of Commissioners approved a shift in the planning approach for the school system's capital needs by adopting a sevenyear, rolling capital improvement program to be updated annually based the most recent data for enrollment, crowding, market trends and other factors impacting the system's capital needs.

The Wake County Board of Education approved a resolution requesting funding from the Board of Commissioners for its rolling Seven-Year Capital Improvement Program for FY2018-FY2024 on May 2, 2017. CIP totals \$2.1 billion and includes funding for 13 new school and 13 major renovations, partial funding for three new schools and renovations of three existing schools. It also supports life cycle replacements for facilities and educational equipment, technology, furniture, program contingency and program management. This Board action continues to implement the approved CIP.

- Board Goal: This action supports routine County business.
- Fiscal Impact: The resolution appropriates a total of \$6,485,349, all of which falls within programmed amounts, and will be funded with cash allocated for the school's capital program. Operational costs for the additional square footage are estimated to be \$354,658 and would be included with the County's annual appropriation to the school system.

Additional Information:

CIP 2013 Appropriation – East Wake Middle

The resolution appropriates \$4,185,349 for partial construction funding for the renovation of East Wake Middle School. This is the last appropriation of funding from the CIP 2013 Building Program. The remaining funding for the East Wake renovation is included in the Seven Year CIP. Construction is scheduled to begin in the spring, with anticipated occupancy in August 2020.

Seven Year CIP Appropriation

The appropriation within the current program totals \$2.3 million for two Space Needs Analysis and Prioritization (SNAP) projects: \$1.89 million is for the Middle Creek Transportation Center and the remaining \$414,660 is for the Infinity Center.

Middle Creek Transportation Center

The Middle Creek Transportation Center is a planned regional bus maintenance facility in Southwest Wake County expected to be 80,000 square feet with 22 repair bays, an operations support building, a fuel and wash station and parking for buses and staff. This appropriation of \$1.89 million covers the remainder of design funding and an anticipated increase in instruction costs. The estimated cost of construction is approximately \$30 million and will be funded with future appropriations of SNAP funding included in the Seven Year CIP.

Infinity Center

The Infinity Center, located on Carl Sandburg Court near New Bern Avenue in Raleigh, houses programs for high school students with disabilities who've received long-term suspensions. In August 2017, the Board of Commissioners appropriated construction funding for this facility. In November, the project bid over budget due to adding roof and

mechanical system replacement scope. This appropriation of \$414,660 covers the gap between the budget and the bid.

Operating Cost Impacts

The County is responsible for maintenance, grounds, utility and custodial costs for additional square footage and acreage for all school buildings. The estimated operating impact for the facilities receiving appropriations in this item is estimated to be \$354,658 as detailed in the table below. Any other operating impacts would be considered as part of the annual budget process.

- 1. Conducts a public hearing on the proposed issuance of Limited Obligation bonds; and, upon close of the public hearing,
- 2. Adopts a resolution authorizing the execution and delivery of Limited Obligation bonds of the County in an amount not to exceed \$175,000,000 and related documents in connection with the financing and refinancing of certain public school and community college improvements for the County of Wake, North Carolina

Item Title: Public Hearing on Proposed 2018A Limited Obligation Bonds not to exceed \$175,000,000

Specific Action Requested:

That the Board of Commissioners:

- 1. Conducts a public hearing on the proposed issuance of Limited Obligation bonds; and, upon close of the public hearing,
- 2. Adopts a resolution authorizing the execution and delivery of Limited Obligation bonds of the County in an amount not to exceed \$175,000,000 and related documents in connection with the financing and refinancing of certain public school and community college improvements for the County of Wake, North Carolina.

Item Summary:

- Purpose: State statute (160a-20) requires Board approval of certain types of debt, including Limited Obligation Bonds. The current Board action is the second of two required authorizations for the issuance of Limited Obligation Bonds ("2018A LOBs") which will provide permanent take out financing of certain short- term temporary debt; and new funding for certain School projects.
- In 2016, the County began using short-term construction period draw Background: programs as a financing tool to temporarily fund certain County capital needs while achieving savings by issuing the debt at a lower variable interest rate versus the higher fixed interest rate of permanent bonds. The County's short-term draw programs are only intended to be utilized for a short period of time before being converted to permanent bonds. The proposed 2018A LOBs, anticipated in the County's financial plans, will refinance certain temporary short-term variable rate debt into fixed rate permanent bonds, as well as provide new funding for certain identified School projects. On April 16, 2018 the Board authorized a resolution making findings and determinations regarding the proposed issuance of 2018A LOBs; scheduled a public hearing for May 21, 2018; and approved the filing of application to the Local Government Commission ("LGC") for approval of the financing arrangement. The current Board action represents the final authorization required to proceed with the proposed issuance of the 2018A LOBs.
- Board Goal: The current Board action complements Education initiative E2.2 In partnership with WCPSS and Wake Tech, support a 2018 WCPSS bond referendum, and continue implementing financing strategies to address needs identified in the 7-year CIP.

Fiscal Impact: Because the proposed 2018A LOBs have been anticipated in the County's Debt and Capital Model, the associated closing costs and future debt service are already incorporated into the County's FY2019 Proposed Budget.

Additional Information:

On January 17, 2017, the Board of Commissioners authorized a Draw Program with Wells Fargo National Bank for \$334,349,000 to fund WCPSS and WTCC capital projects identified in the 2017-2023 Capital Improvement Program. On January 16, 2018, the Board of Commissioners authorized an additional \$55,317,000 under the Draw Program for WCPSS and WTCC capital projects identified in the 2018-2024 Capital Improvement Program. Summarily, this brought the total Draw Program authorization to \$389,666,000. A list of projects authorized under this program is attached as reference.

Proceeds of the proposed 2018A LOBs will be used to provide permanent funding for: (1.) a portion of the \$389,666,000 projects described above ("Prior Authorized Projects"); and (2.) new education projects ("New Projects").

Prior Authorized Projects

The proposed 2018A LOBs will permanently finance approximately \$156,000,000 of Prior Authorized Projects. This amount includes both (a.) life-to-date project expenses reflected in the Draw Program outstanding balance of \$92,356,738 at May 1, 2018; and (b.) unspent project funds totaling up to \$63,643,262 for certain projects under construction.

New Projects

The proposed 2018A LOBs will also provide \$19,000,000 in new partial funding for two accelerated school projects, Parkside Elementary and Northridge Elementary.

Total needs for the proposed 2018A LOBs not to exceed \$175,000,000 are as follows:

The proposed 2018A LOBs will be collateralized by a security interest in Apex High School. As this school is currently part of original collateral pledged for the Draw Program, it will be released from the current Draw Program Deed of Trust and become the collateral for the proposed 2018A LOBs Deed of Trust. The proposed 2018A LOBs will be sold to investors via negotiated sale on June 14, 2018 by senior manager JP Morgan, with comanagers Robert W. Baird & Co and Wells Fargo assisting. The Local Government Commission is scheduled to consider the proposed 2018A LOBs transaction at their meeting on June 5, 2018. Upon LGC approval, the closing for the 2018A LOBs will occur June 28, 2018.

Upon close of the scheduled public hearing, staff recommends the Board adopt the attached approving resolution for the proposed issuance of 2018A Limited Obligation Bonds not to exceed \$175,000,000.

The Chair announced that this was the hour and day of the public hearing on whether to issue not to exceed \$175,000,000 of Limited Obligation Bonds of the County to (i) refinance a portion of the County's obligations under an existing Installment Financing Agreement (the "Installment Financing Agreement") previously entered into by the County pursuant to Section 160A-20 of the General Statutes of North Carolina, and (ii) finance additional school improvements.

The County entered into the Installment Financing Agreement to finance the cost of constructing, renovating, rehabilitating and equipping public school and community college facilities in the County. Pursuant to the plan of finance established when the County entered into the Installment Financing Agreement, the County now proposes to issue the Limited Obligation Bonds to refinance a portion of the County's obligations under the Installment Financing Agreement. In addition, the County will consider issuing additional Limited Obligation Bonds to finance additional school improvements. To secure its obligations with respect to the Limited Obligation Bonds, the County will execute and deliver a deed of trust granting a lien on the site of Apex High School, together with all improvements and fixtures located or to be located thereon. Said site was conveyed to the County under the plan of finance and is leased back to the Wake County Board of Education for school purposes. The lease will be subordinate to the lien created by the deed of trust.

The Chair acknowledged due publication of a notice of public hearing in a newspaper with general circulation in said County as required by Section 160A-20 of the General Statutes of North Carolina and directed the Clerk to the Board of Commissioners to attach the affidavit showing publication in said newspaper on a date at least ten (10) days prior to the date hereof as Exhibit A hereto.

The Chair then announced that the Board of Commissioners would immediately hear anyone who might wish to be heard on the advisability of the proposed projects or financing as described above.

A list of any persons making comments and a summary of such comments are attached as Exhibit B hereto.

All statements and comments were duly considered by the Board of Commissioners.

Thereupon, Commissioner ______ introduced the following resolution the title of which was read and copies of which had been distributed to each Commissioner:

RESOLUTION AUTHORIZING THE EXECUTION AND DELIVERY OF LIMITED OBLIGATION BONDS OF THE COUNTY IN AN AMOUNT NOT TO EXCEED \$175,000,000 AND RELATED DOCUMENTS IN CONNECTION WITH THE FINANCING AND REFINANCING OF CERTAIN PUBLIC SCHOOL AND COMMUNITY COLLEGE IMROVEMENTS FOR THE COUNTY OF WAKE, NORTH CAROLINA

BE IT RESOLVED by the Board of Commissioners (the "Board") for the County of Wake, North Carolina (the "County"):

Section 1. The Board does hereby find and determine as follows:

(a) The Wake County Board of Education (the "School Board") is the local school administrative unit for the public school system located in the County of Wake, North Carolina (the "County"), and the School Board has advised the County that there is a need for additional new public school facilities in the County and for renovation, rehabilitation and improvement of existing school facilities in the County, all to serve the citizens of the County. Wake Technical Community College ("Wake Tech") provides community college education in the County, and Wake Tech has advised the County that there is a need for additional new community college facilities in the County and for renovation, rehabilitation and improvement of existing community college facilities in the County and for renovation, rehabilitation and improvement of existing community college facilities in the County, all to serve the citizens of the County.

(b) The County has previously entered into an Amended and Restated Installment Financing Agreement, dated as of February 1, 2018 (the "Installment Financing Agreement"), with the lender named therein, pursuant to which the lender advances moneys to the County in an amount sufficient to pay the cost of the school and community college improvements to be financed, and the County repays the advancement in installments, with interest. In connection with the plan of finance, the School Board conveyed to the County the sites of Willow Springs High School, Apex High School and Barton Pond Elementary School, three of the public schools being improved under the plan of finance, in order for the County to execute and deliver one or more deeds of trust granting a lien on such sites, together with all buildings, improvements and fixtures located or to be located thereon, to secure the financing.

(c) Under the plan of finance, the County will issue its limited obligation bonds from time to time to refinance obligations incurred under the Installment Financing Agreement. In

addition, the County has determined to finance additional school improvements with the proceeds of such limited obligation bonds. After a public hearing and due consideration, the County has determined at this time to issue its Limited Obligation Bonds, Series 2018A (the "Series 2018A Bonds") in a principal amount of not to exceed \$175,000,000 for the purpose of (i) refinancing all or a portion of the obligations of the County incurred to date under the Installment Financing Agreement, and (ii) financing additional school improvements. The Series 2018A Bonds will be issued under a Trust Agreement, to be dated as of June 1, 2018 (the "Trust Agreement"), between the County and U.S. Bank, National Association, as trustee (the "Trustee"), as supplemented by a First Supplemental Trust Agreement, to be dated as of June 1, 2018 (the "First Supplemental Trust Agreement"), between the County and the Trustee. As security for the Limited Obligation Bonds, the County will deliver a Deed of Trust granting a security interest on the site of Apex High School and the improvements located or to be located thereon (the "Deed of Trust").

(d) The Series 2018A Bonds will initially be sold to J.P. Morgan Securities LLC; Robert W. Baird & Co. Incorporated; and Wells Fargo Bank, National Association (collectively, the "Underwriters"), pursuant to the terms of a Bond Purchase Agreement, to be dated the date of delivery thereof (the "Bond Purchase Agreement"), between the County and the representative of the Underwriters. In connection with the offering and sale of the Series 2018A Bonds by the Underwriters, there will be prepared and distributed to potential investors a Preliminary Official Statement, to be dated as of the date of delivery thereof (the "Preliminary Official Statement"), relating to the offering and sale of the Series 2018A Bonds, and the Official Statement (hereinafter defined).

(e) There have been presented to the Board drafts of the following documents relating to the transaction hereinabove described:

(1) Trust Agreement;

(2) First Supplemental Trust Agreement, including a form of the Series 2018A Bonds attached as Exhibit A thereto;

(3) Deed of Trust;

(4) Bond Purchase Agreement; and

(5) Preliminary Official Statement.

Section 2. For the purposes described above, the County is hereby authorized to enter into the Trust Agreement and the First Supplemental Trust Agreement and to issue the Series 2018A Bonds thereunder in a principal amount not to exceed \$175,000,000. The Series 2018A Bonds shall mature, shall bear interest at such rates, and shall be subject to redemption as set forth in the Trust Agreement and the First Supplemental Trust Agreement. The Series 2018A Bonds shall bear interest at such interest rates or yields that, together with the sale prices paid to that County as described in Section 3, shall result in a true interest cost to the County of not to exceed five percent (5.00%). The final maturity of the Series 2018A Bonds shall not be later than December 31, 2043.

Section 3. The Series 2018A Bonds shall be sold to the Underwriters pursuant to the terms of the Bond Purchase Agreement. The Series 2018A Bonds may be sold to the Underwriters at a discount below the amount of the principal amount of the Series 2018A Bonds, such discount not to exceed one percent (1%) of the principal amount of the Series 2018A Bonds; provided, however, that if all or any of the Series 2018A Bonds are to be sold to the public by the Underwriters at original issue discount (resulting in lower interest costs of the interest component of the debt service payments on the Series 2018A Bonds), then the Series 2018A Bonds may be sold at a further discount in the amount necessary to cover such original issue discount.

Section 4. The Board hereby approves the forms of the Trust Agreement, the First Supplemental Trust Agreement, the Deed of Trust, the Bond Purchase Agreement and the Series 2018A Bonds in substantially the forms presented at this meeting. The Chair of the Board, the County Manager and the Interim Finance Director are each hereby authorized to execute and deliver the Trust Agreement, the First Supplemental Trust Agreement, the Deed of Trust, the Bond Purchase Agreement and the Series 2018A Bonds on behalf of the County in substantially the forms presented at this meeting, containing such insertions, deletions and filling in of blanks as the person executing such documents shall approve, such execution to be conclusive evidence of approval by the Board of any such changes. The Clerk to the Board or any assistant or deputy Clerk to the Board is hereby authorized to affix the official seal of the County to said documents and to attest the same to the extent required.

Section 5. No deficiency judgment may be rendered against the County in any action for breach of any contractual obligation with respect to the Series 2018A Bonds or under the Trust Agreement and the First Supplemental Trust Agreement, and the taxing power of the County is not and may not be pledged directly or indirectly to secure any moneys due with respect to the Series 2018A Bonds or under the Trust Agreement.

Section 6. The Board hereby approves the form of the Preliminary Official Statement in substantially the form presented at this meeting and the distribution thereof by the Underwriters in connection with the offering and sale of the Series 2018A Bonds. Upon the sale of the Series 2018A Bonds to the Underwriters, a final Official Statement, to be dated as of the date of the Bond Purchase Agreement (the "Official Statement"), will be prepared substantially in the form of the Preliminary Official Statement and will contain such information relating to the pricing terms of the Series 2018A Bonds and such additional information as may be necessary. The Board hereby approves the delivery of the Official Statement on behalf of the County by the Chair of the Board, the County Manager and the Interim Finance Director and the distribution thereof by the Underwriters in connection with the offering and sale of the Series 2018A Bonds.

Section 7. The Chair of the Board, the County Manager, the Interim Finance Director and the Clerk to the Board, and any other officers, agents and employees of the County, are hereby authorized and directed to deliver such certificates, opinions and other items of evidence as shall be deemed necessary to consummate the transactions described above, including, without

limitation, any documents necessary to effect the partial prepayment of the Installment Financing Agreement.

Section 8. The County Manager and the Interim Finance Director are hereby authorized to cooperate with the Underwriters in preparing and filing such filings under state securities or "blue sky" laws as the Underwriters may request; provided, however, that the City shall not be required to consent to the jurisdiction of any state in which it is not now subject unless the County Attorney shall determine that such consent is in the best interest of the County.

Section 9. This resolution shall take effect immediately upon its passage.


Item Summary:

- Purpose: North Carolina General Statute § 153A-239.1(a) requires the Board of Commissioners to hold a public hearing to rename State maintained streets outside the corporate limits of municipalities.
- Background: The construction of the Triangle Expressway (NC 540) has interrupted the existing road network, splitting and rerouting roads. These traffic flow changes cause challenges with addresses. Logical and consistent addresses are needed to ensure prompt delivery of emergency services. In an effort to remedy this, on May 1, 2018, the Town of Apex passed a Resolution to change the names of three street segments of Green Level Church Road which were split by NC 540. Portions of these roads are in their extraterritorial jurisdiction and require the county to hold a public hearing before the Board of Commissioners.
- Board Goal: This action supports routine County business.

Fiscal Impact: Costs of new signage will be covered in the FY2019 budget.

Additional Information:

The residents, Town of Apex emergency personnel, the Wake County GIS E911/Addressing Team, and Wake County Public School System expressed concern about the disconnected segments of Green Level Church Road after the construction on NC 540. This caused a change in traffic flow and continuity of street names. The Town of Apex Planning Department held meetings with the affected property owners and worked with them to create new street names, approved by Wake County Geographic Information Services (GIS). The proposed name changes affect four residences and no businesses.






NC 540 splits Green Level Church Rd

ORDINANCE APPROVING THE REQUEST TO RENAME PORTIONS OF GREEN LEVEL CHURCH RD

AN ORDINANCE TO RENAME A PORTIONS OF GREEN LEVEL CHURCH ROAD (SR 1600) WITHIN THE TOWN OF APEX EXTRATERRITORIAL JURISDICTION

WHEREAS, Green Level Church Road (SR 1600) originally passed through the Green Level community, turned westward along Yates Farm, and terminated at the Chatham County line; and

WHEREAS, land development, construction, and emergency response necessitated road name reassignments and the creation of a new terminus for Green Level Church Road; and

WHEREAS, Green Level Church Road now begins at US 64 in Apex and extends northward through the Green Level community of Wake County to its terminus in the Genlee community of Durham County at NC 55; and

WHEREAS, the construction of NC 540 bisected Green Level Church Road, severed the southern terminus of said road, and realigned the detached segment east of NC 540 to serve as a connection between US 64 and Jenks Road (SR 1601); and

WHEREAS, Green Level Church Road is no longer the continuous traffic movement at its intersection with Kelly Road (SR 1163) west of NC 540; and

WHEREAS, Green Level Church Road west of NC 540 terminates as a cul-desac constructed as part of the NC 540 project; and

WHEREAS, residents, Town of Apex emergency personnel, the Wake County Addressing/E911 Team, and Wake County Public School System have expressed concern in the years following NC 540 construction regarding confusion created by the disconnected segments of Green Level Church Road; and

WHEREAS, the Town of Apex contacted property owners along the fragmented segments of Green Level Church Road in 2016 and 2017 in order to coordinate the assignment of distinct road names; and

WHEREAS, Edith S. Morris is the sole property owner fronting the segment of Green Level Church Road east of NC 540 and, thus, directly affected by a new road name assignment; and

WHEREAS, the Town of Apex Planning Department, Wake County Addressing/E911 Team, and Edith S. Morris approved the availability, appropriateness, and use of the name Morris Acres Road on March 10, 2017 for the segment of SR 3129, formerly SR 1600, located between US 64 and Jenks Road; and

WHEREAS, only the portion of SR 3129 extending approximately 2600 feet northward from U.S. 64 to the southwest property corner of Edith S. Morris is within Town of Apex corporate limits; and

WHEREAS, the portion of SR 3129 extending northward from the southwest property corner of Edith S. Morris to Jenks Road was acquired by the North Carolina Department of Transportation Turnpike Authority for NCDOTTA Project # 35520.5 within Town of Apex extraterritorial jurisdiction but beyond Town of Apex corporate limits; and

WHEREAS, North Carolina General Statute § 153A-239.1(a) authorizes a county to rename any road within the county and not within a city by means of an advertised public hearing before the board of commissioners, whereupon the local postmaster, Board of Transportation, and any city within five miles of the road is notified of the approval; and

WHEREAS, Merquiades Cespedes, excepting the Town of Apex, is the sole property owner fronting the segment of Green Level Church Road west of NC 540 and, thus, directly affected by a new road name assignment; and

WHEREAS, the Town of Apex Planning Department, Wake County Addressing/E911 Team, and Merquiades Cespedes approved the availability, appropriateness, and use of the name Dominik Court on March 29, 2017 for the segment of SR 1600 extending from its turnaround west NC 540 to its intersection with Kelly Road; and

WHEREAS, the aforementioned segment of SR 1600 is completely located within Town of Apex extraterritorial jurisdiction but beyond Town of Apex corporate limits; and

WHEREAS, the Town of Apex Planning Department, Town of Apex Fire Department, and Wake County Addressing/E911 Team agree that the remaining segment of SR 1600 located between the Kelly Road intersection and the Jenks Road intersection continue the name Kelly Road due to the free-flowing traffic movement; and

WHEREAS, the aforementioned segment of SR 1600 is completely located within Town of Apex extraterritorial jurisdiction but beyond Town of Apex corporate limits; and

WHEREAS, the assignment of distinct road names as endorsed by the affected property owners does not appear contrary to public interest in accordance with public safety and general perception; and

WHEREAS, the Town of Apex Board of Commissioners passed a resolution supporting the name changes at their May 1, 2018 meeting; and

WHEREAS, the General Statutes of the State of North Carolina (G.S. 153A-239.1) delegates authority to name and rename roads to the Wake County Board of Commissioners and prescribe procedures to be followed in the process; and

WHEREAS, this request was duly advertised and was the subject of a public hearing by the Wake County Board of Commissioners on May 21, 2018 and was duly considered; and

NOW, THEREFORE, BE IT RESOLVED BY THE WAKE COUNTY BOARD OF COMMISSIONERS OF THE COUNTY OF WAKE, NORTH CAROLINA, AS FOLLOWS:

That the portion of SR 3129 located within Town of Apex extraterritorial jurisdiction between U.S. 64 and Jenks Road to Morris Acres Road; to rename the segment of SR 1600 extending from its turnaround west NC 540 to its intersection with Kelly Road to Dominik Court; and to rename the continuing portion of SR 1600 between the Kelly Road intersection and Jenks Road to Kelly Road. Effective May 21, 2018.


SECTION 4.(a) G.S. 115C-436 is amended by adding a new subsection to read:

"(c) Upon receipt of a report from the North Carolina Teachers' and State Employees' Retirement System, generated pursuant to G.S. 135-8(f)(2)f., containing a list of employees for whom the local board of education made a contribution to the North Carolina Teachers' and State Employees' Retirement System that is likely to require an additional employer contribution should the employee elect to retire in the following 12 months, the school financial officer shall transmit a copy of the report to the local board of education. The school financial officer shall also notify the board of county commissioners of the county in which the local administrative unit is located that the report was received and the number of employees listed in the report."

This memorandum serves as notice that the Wake County Public School System received a report dated February 15, 2018 from the Retirement Division of the State Treasurer of North Carolina with 36 employees included on the list. Funding has been reserved for the potential liability. This information has been shared with the Wake County Board of Education.

Dear 99201 - WAKE COUNTY:

During the 2014 General Assembly session, contribution-based benefit cap legislation was enacted effective January 1, 2015. The purpose of this legislation is to control the practice of "pension spiking," in which a member's compensation significantly increases late in his or her career, thereby creating unusually high unforeseen liabilities to the Retirement System to pay a monthly retirement benefit that is significantly greater than the member and employer contributions would fund. Prior to January 1, 2015, these liabilities were shared and consequently absorbed by all agencies participating in the Retirement System. This legislation applies to members who retire on and after January 1, 2015, with an average final compensation of \$100,000 or higher (adjusted annually for inflation), and will only directly impact a small number of those individuals. It requires the member's last employer to pay the additional contribution required to fund the member's benefit in excess of the cap. [G.S. 135-5(a3); 135-4(jj); 128-27(a3); and 128-26(y)]

In order to assist employing agencies with planning and budgeting to comply with the contribution-based benefit cap provisions, we are required to report monthly to each employer a list of those members for whom the employer made a contribution to the Retirement System in the preceding month that are most likely to require an additional employer contribution should they elect to retire in the following 12 months. This letter and the attached report serve as our required monthly notification to your agency under this provision. [G.S. 135-8(f)(2)(f) and G.S.128-30(g)(2)(b)]

The chief financial officer of your agency is required to provide a copy of the attached report to the chief executive of your agency, as well as to the governing body, including any board which exercises financial oversight. Additionally, the chief financial officer of a public school system is required to provide a copy of the report to the local board of education and notify the board of county commissioners of the county in which the local administrative unit is located that the report was received and how many employees were listed in the report. [G.S. 115C-436(c); 135-8(j); and 128-30(j)]

The attached report lists employees of your agency who may be eligible to retire in the next 13 months, and whose salary is \$90,000 or greater based on information in the employee's most recent annual benefits statement. Your agency may be required to submit an additional amount to the Retirement Systems in the form of a lump-sum payment, due after the employee retires, to cover these unforeseen liabilities should the employee elect to retire in the next 12 months.

This list is not exhaustive, and members included on this list may or may not exceed the contribution-based benefit cap upon retirement, depending on a number of factors such as the member's average final compensation, the member's age at retirement, and membership service. This is merely a notification of a potential cost that your agency may be required to pay in the future.

Your agency can utilize the statutory formula to help determine the likelihood that the retirement allowance of a member listed on the attached report might exceed the contribution-based benefit cap (CBBC). The current CBBC Factor for TSERS is 4.5 and LGERS is 4.7. The current multiplier for TSERS is 0.0182 and LGERS is 0.0185. <u>Employers/Pages/default.aspx</u>. You can access the member's accumulated contribution balance and service history through ORBIT Self-Service (Reporting – View Member Info – View Account History). The total contribution balance does not include the interest (currently 4%) for the current year. The CBBC formula is as follows:

Benefit Formula = AFC X Multiplier X Service

CBBC Formula = Contributions / Annuity Factor X CBBC Factor

If Benefit is greater than CBBC, the difference is multiplied by the Annuity Factor

You can contact the Retirement System for assistance in calculating the likelihood of a potential CBBC liability for a particular member. Additional information and video training regarding the contribution-based benefit cap is available on our website at <u>www.myncretirement.com</u>.

SUBJECT: Process Changes in WCPSS Agenda Items

Commissioners – Over the last month, I have reached out to you via email or in discussions at the Wednesday agenda review regarding proposed changes to handling agenda items for WCPSS. The feedback regarding the changes has been favorable; therefore, with the May 21 agenda, the new process will be used. The purpose of this memo is restating the reasons for the change and formerly documenting the new process.

Background: With the implementation of the Joint Schools Facilities Core Team in 2015, the process for WCPSS agenda items has significantly improved. Over the last two years, the Board has considered the majority of the second readings on the Consent Agenda given the relatively routine nature and there being no outstanding questions after first reading. Two readings are not required for WPCSS items by any statute. The two-reading practice was established in the early 2000's because there were often significant questions on the agenda items with substantial follow-up needed.

Process Change: For future routine items (appropriations and reallocations) supported and endorsed by County staff, plan for only one reading. The Board always has the option to defer an item to a future meeting if there are significant outstanding questions.

For non-routine items (land acquisitions, long-term leases, development agreements), frame these items such that if there are no outstanding questions, the Board would move to approve (or deny) the item or if additional information is needed, defer the item to the next regular meeting to allow staff to address outstanding issues prior to the Board's final consideration. The language for non-routine items would read as shown below.

Specific Action Requested: That the Board of Commissioners:

Approves (Denies) "requested action"

Or

Defers the item to the next regular meeting for a second reading.
