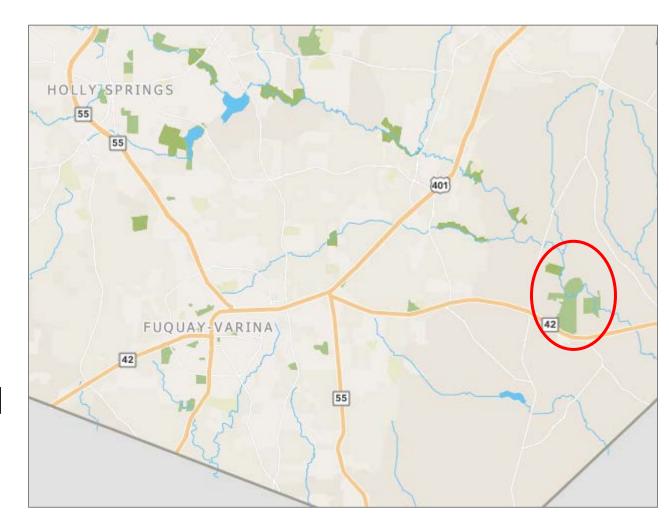




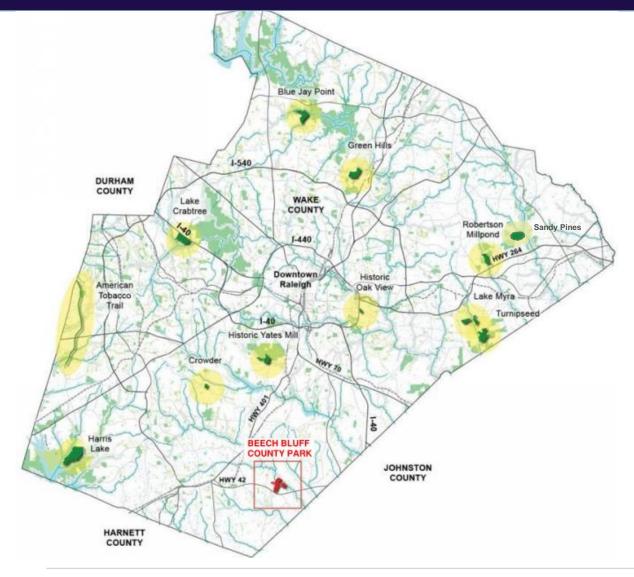


Background

- ~300 acres in southeast Wake County
- A part of Wake County Parks and Recreation Master Plan since 2003
- Top priority project from \$120M bond approved in 2018



Significance



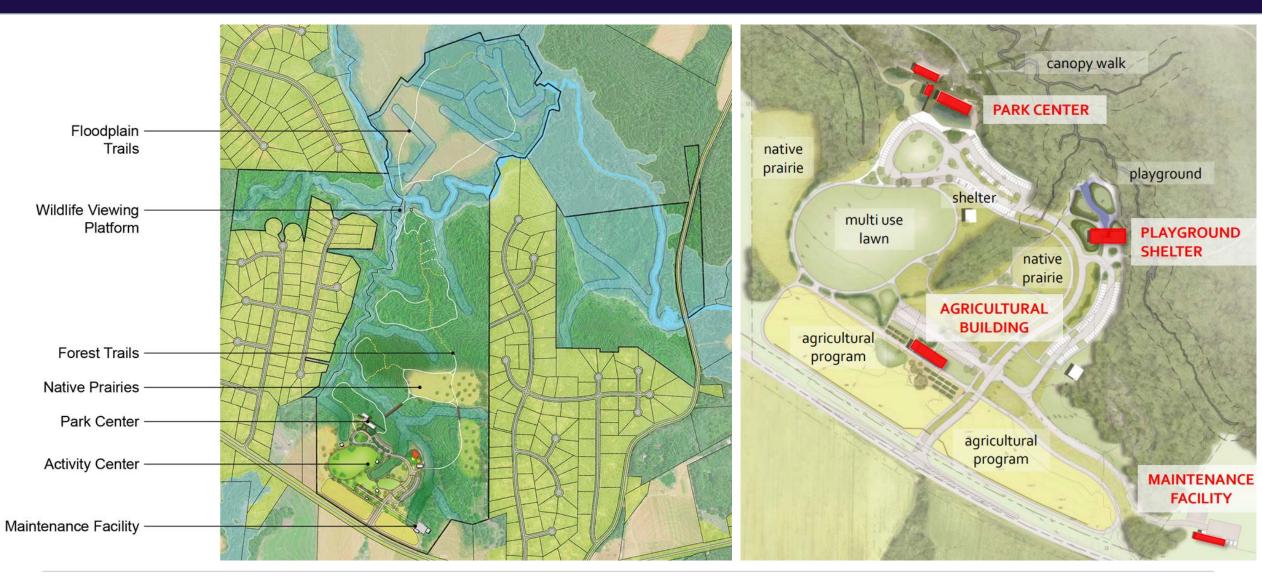
- First County park in 15+ years (Yates Mill in 2005)
- No County park in southeast Wake County
- Extension of 540 = significant growth
- Ecological significance

Master Planning

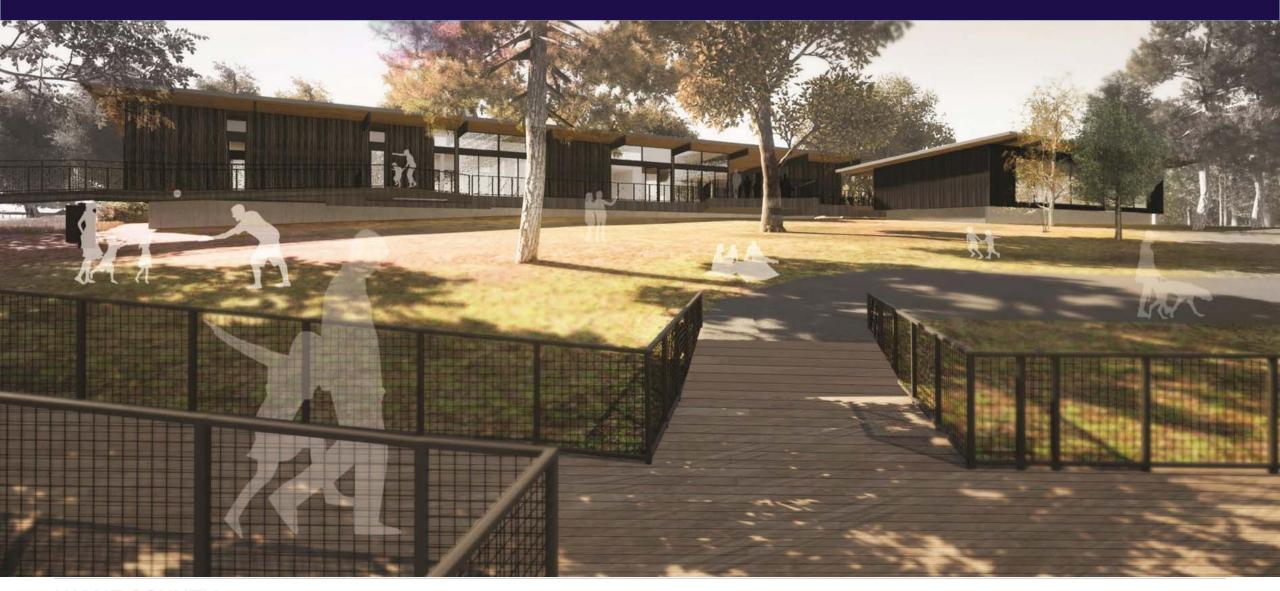
- Significant community input
 - o September 2018
 - o February 2019
 - o April 2019
- BOC approval of master plan in August 2019
- Support from OSAPC and Energy Commission

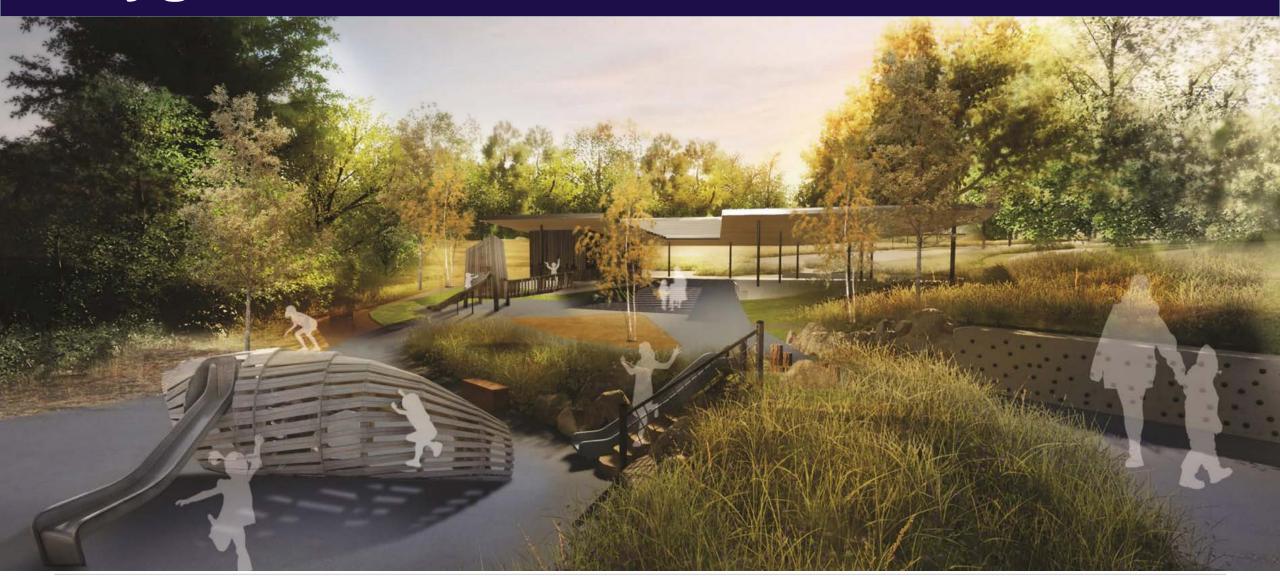

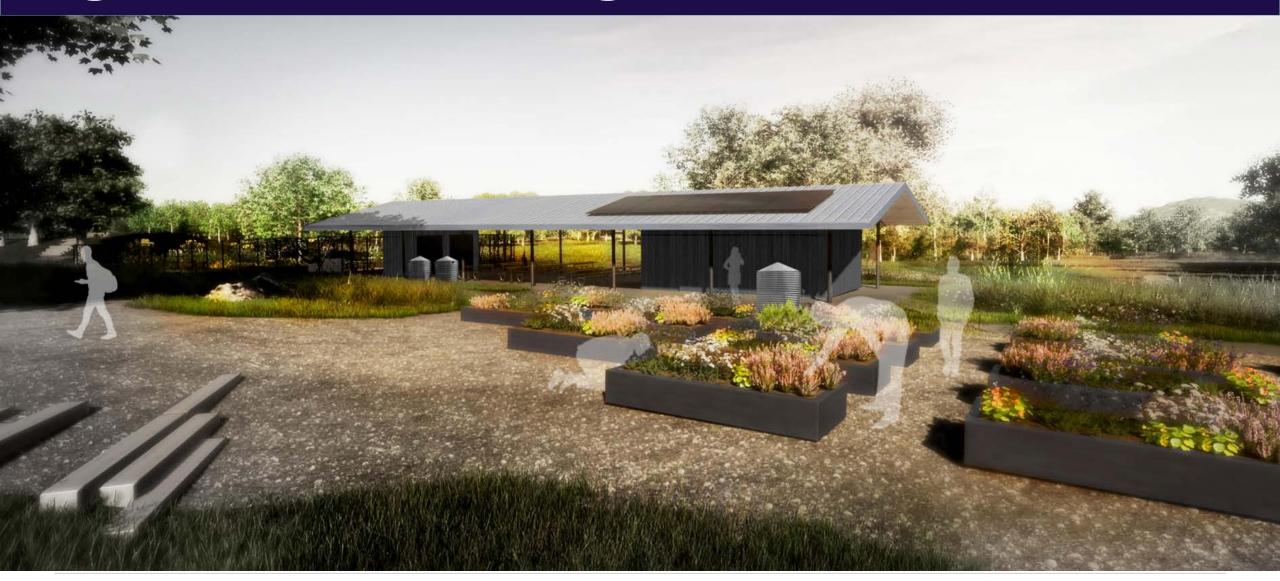

Project Budget vs Bids

- Project budget estimated at \$14.2M during bond planning
- Lowest bid: \$20.5M, which is for construction only
- Factoring in playground equipment, furniture, contingency, etc., total project cost is now \$22.0M
- Budget gap: \$7.8M
- Why such a big gap?
 - Original estimate was before master planning and construction drawings
 - Changing construction market
 - Escalation, escalation

Value Engineering vs Budget Reallocation

- We work with designers and contractors on value engineering (VE) for every project – we evaluate trade-offs between minor cuts and savings
- Base level VE recommendation of \$400,000
 - Won't disrupt program focus
 - Some changes could be added back in a later phase
- To close the remaining \$7.4M gap would require massive changes
 - Eliminating most built structures
 - Eliminating several planned sustainability features
- Remaining park projects likely to face similar challenges

Slated Park Projects

Kellam-Wyatt Farm

- Original budget estimate: \$3.5M
- Master plan adopted December 2021
- Currently in schematic design estimated to be completed November 2022
- Current budget estimate: \$5.5M

Lake Myra County Park

- Original budget estimate: \$16M
- Master plan adopted December 2008, updated in 2016
- Currently soliciting consultants for design development
- Current budget estimate: \$17.2M

Proposed Solution

- Remaining shortfall after value engineering: \$7.4M
- Postpone two projects and reallocate \$ to Beech Bluff
 - American Tobacco Trail Renovations: \$6.9M
 - Sinclair Nature Preserve: \$1.2M
 - Balance of \$0.7M applied toward future planned projects
- Next bond will likely focus on OS/Greenways/Preserves, so adding these two projects is a good fit
