## I. Financial Policies for Fund Balance and OPEB

Maintaining and properly using fund balance is a core part of the County's overall financial management. The use of fund balance has a direct impact on ratings from credit agencies. For several months, staff has been developing refined policies for using fund balance. Specifically, staff has prepared policies that would guide using fund balance to fund such long-term commitments as Other Post Employment Benefits (OPEB) and authorized deferred taxes. In this briefing, staff will review key concepts, describe OPEB as a long-term liability, and walk the Board through the proposed policies. Staff seek the Board's feedback and approval to proceed with implementing the policy. A tentative Board action has been prepared for the November 21 regular meeting.

#### II. Update on ARPA Funding

Since the American Recovery Plan Act was enacted and funds distributed, the range of eligible uses has been gradually narrowing. Staff has analyzed the current range of uses and considered the County's resource needs. Staff proposes applying ARPA funds to the County's affordable housing capital program, while using County funds to cover project cost increases in other County capital programs. In this briefing, staff will review the changes in ARPA rules, the state of the capital program, and the specific proposal. Commissioners will have an opportunity to ask questions and provide feedback. Staff have prepared an action to implement this proposal for the Board's consideration at the November 21 regular meeting.
