

# Affordable Homeownership Program

- Program helps first-time homebuyers achieve the dream of homeownership
- Offers forgivable loans up to \$50,000 to low- to moderate-income households
- Serves all Wake County municipalities, outside of Raleigh and Cary
- DHIC administers the program on Wake County's behalf and provides homebuyer education and 1:1 sessions to clients
- Serves households or below 80% Area Median Income
- Individuals interested in purchasing their first home
- No maximum sales price; minimum credit score of 640
- How to Apply: Call / email DHIC to apply for program



# **Housing Rehabilitation Grants**

#### **Elderly & Disabled Rehab Grant**

- Home repairs to address a variety of needs, including mobility needs
- Typical repairs: widening doorways, accessible bathrooms, and ramps
- One-time grant up to \$20,000
- Must be 62+ and/or disabled
- Up to 50% AMI
- Not delinquent on taxes
- Permanent foundation home
- How to apply: Call EHCD Housing Division

#### **Emergency Rehabilitation Grant**

- Emergency repairs to prevent immediate or near danger
- Typical repairs: heating systems, wells, septic tanks, and roof hazards
- Up to 50% AMI
- Must live in home
- Not delinquent on taxes
- Permanent foundation home
- How to apply: Call EHCD Housing Division

## **Veteran Services**



- Assists veterans, their families in applying for benefits and services from the Department of Veterans Affairs and North Carolina Department of Military & Veterans Affairs
- Resources include:
  - Applying for NCDVMA benefits
  - Retrieving official Wake County documents in support of claims
  - Help at NCWorks Career Centers
  - Obtaining DD-214s
  - Affordable housing assistance for Veterans experiencing homelessness
- How to apply: call / email Wake Veteran Services Division

## Wake Prevent! Program

- Emergency rental and utility assistance to prevent evictions / homelessness prevention
- Staff provide 1:1 support to divert the eviction process, engaging with landlords and other entities to help keep residents in their homes
- Staff are co-located at existing community service centers throughout Wake
- How to apply: contact team via dedicated email address and phone number



## South Wilmington Street Center

- Largest men's shelter in North Carolina
- Co-located on campus with Oak City Center
- Uses Nationally Recognized Low Barrier Model
- Targeting Clients with the longest lengths of homelessness
- Providing Diversion Services to Rapidly End Homelessness
- How to apply: call SWSC directly or utilize a coordinated entry site

#### WAKE COUNTY

## **Cornerstone Center**

- 20 units for people experiencing chronic homelessness with physical and mental health needs
- Crisis intervention, clinical assessments and treatment, workforce development and case management provided on-site
- Residents receive PHSS housing vouchers
- First group of residents moved-in on February 26<sup>th</sup>
- How to apply: Referrals through coordinated entry & community outreach teams



# **PHSS McKinney Team**

- Supports residents with mental health issues who are also experiencing homelessness
- Provides assessments, mental health nurse for clients, medication management, case management, housing assistance and on-going support to maintain housing
- Partnerships with non-profit housing organizations including CASA to help house these residents who have high barriers to accessing traditional housing
- How to apply: coordinated entry process

# **Rental Assistance Housing Program**

- Permanent supportive housing that links rental assistance and support services to individuals who are experiencing homelessness with a diagnosed disability
- Residents receive ongoing case management from housing social workers to assist in maintaining housing and life skills training to help lead to clients living independently
- Tenant-based & project-based vouchers are utilized in this program HOPWA, CoC, and Wake County vouchers
- Wake also has a team located at Cornerstone Center who serves anyone in PHSS with a voucher and also needs more intensive services
- The Cornerstone team provides specialty case management, housing navigation, there's a rehab counselor on-site, and SOAR resources
- How to apply: coordinated entry process

# **Bridge 2 Home**

Service expansion program aimed at helping to move as many people as possible into permanent housing

- 11 participating agencies
- 7 program pillars:
  - Comprehensive Case Management
  - Flexible Financial Assistance
  - Housing Navigation
  - Healthcare Connection
  - Access to Benefits
  - Transportation
  - Permanent Home Furnishings
- How to apply: referral to one of the partnering agencies



# Landlord Engagement Unit

- Landlord Engagement Unit bridges gap between housing providers and County residents seeking affordable housing
- To receive assistance, residents must work with a community partner and be referred by case manager
- Includes the landlord incentive program, Lease 2 Home
- \$1,000 to cover damages above security deposit & standard turn costs
- Up to 2 mo. of rental payments if vacant 30+ days
- \$500 for every lease signed; \$750 if accepts housing voucher
- \$1,000 for lease renewals
- How to apply: contact Wake County LEU team



## Municipal Engagement & Technical Assistance

#### Field Inquiries from Municipal Staff and Elected Officials

- Build awareness of County housing programs and resources
- Provide housing development, grants, and planning technical assistance


#### Strategic Engagement

#### Community Investment Partnership Program

Assists the towns of Apex, Fuquay-Varina, Garner, Holly Springs, Knightdale, Morrisville, Rolesville, Wake Forest, Wendell and Zebulon with funding for community development projects, public facilities, and infrastructure that creates, preserves, or supports affordable housing in low-income neighborhoods.

# Wake Housing Preservation Fund

- Provides financing for nonprofit and for-profit developers to acquire, refinance, rehabilitate and preserve existing affordable multifamily rental housing in Wake.
- Provides a lending platform that can move at market speed to enable developers to acquire and preserve properties in a competitive environment
- Fund fully capitalized at \$61.6 million, leveraging a \$10 million Wake County investment



# **Preservation Fund – How to Apply**

#### **ELIGIBLE PROJECTS**

- Existing affordable housing development
- Development must be located in Wake County
- Preference for projects in areas of economic opportunity

#### **ELIGIBLE BORROWERS**

- Nonprofit developers
- For-profit developers
- Applicants must have recent, relevant affordable housing development experience
- How to apply: Contact Self-Help Credit Union

## Affordable Housing Development Program

- Low-interest gap financing loans to for-profit and non-profit developers of affordable housing to make deeply affordable development feasible.
- Program has supported the creation and preservation of over 3500 units since 2019
- How to apply: Submit application through Wake County Website

#### Affordable Housing + Public Land Disposition

- Wake's Affordable Housing Land Disposition Policy
- Evaluate all properties to determine if they're suitable for affordable housing
- How to apply: Available sites listed on the Wake County RFP page

## Affordable Housing Advisory Working Group

- The 17-member group provides guidance, contributes input and engages the public around affordable housing and homeless service efforts.
- Diverse industry representation
- Instrumental in providing feedback on County initiatives: Housing Annual Action Plan, 5-year Consolidated Plan & Wake County Strategic Plan
- How to apply: Community members can apply via the website
