

Background

2008 Interlocal Agreement

Parties: Wake County, Raleigh, Wake Forest, Wendell, and Zebulon

Purpose: To protect surface water supply by controlling development type and intensity in the watershed




Background

2008 Interlocal Agreement

Highlights:

- R-80W in Critical Area
- R-40W in Non-Critical Area
- Prohibits extension of water / sewer into the watershed
- Prohibits municipal annexation into the watershed
- Prohibits non-residential development except in designated Activity Centers





Analysis

Since 2008

- Continued population growth in Wake County
- Meet the original intent of the Interlocal Agreement
- Recent development requests:
 - Expansion of Existing Churches
 - County Park
 - Solar farm
 - Telecommunication Tower



Analysis

Proposed Changes to Interlocal Agreement

- 1. Allow the following uses outside of an Activity Center: parks, fire/EMS/law enforcement stations, telecommunication facilities, and solar farms
- 2. Allow "Public/Civic" uses (located outside an Activity Center) that were established prior to the 2008 ILA, to expand their use (Ex: churches)
- 3. Prohibit the creation of new Activity Centers or the expansion of any existing Activity Center
- 4. Commit to studying municipal expansion into the watershed with the ILA partners



Background What have we been doing

✓ Sept 2013 – Started discussion with Partners on changes to the ILA

✓ April 2014 – Drafted an amendment to the ILA

✓ Sept 2015 - Wake County Board Work Session

 March 2016 - Wake County Growth, Land Use & Environment Committee

March 2016 - Started discussion with Partners on broader changes to the ILA related to municipal expansion

June 2016 - General agreement from Wake Forest, Wendell, Raleigh, and Wake County on proposed changes to the ILA

August 2016 - Public meeting on proposed changes

✓ August 2016 – Town of Zebulon Board of Commissioners

Postponement of public and private projects until amended



Analysis

Municipal Expansion into the Watershed

- 1. Staff meetings (3) among partnership
 - Reviewed watershed regulations across County and NC
 - Discussed interests for municipal expansion into the watershed

2. Workshop with subject matter experts

- Discussed technical and regulatory issues related to different types of development in the watershed
- Discussed the critical success factors and concerns of each party related to development



Findings

- 1. The 2008 ILA was not intended to preclude certain uses or the expansion of some existing non-residential uses
- 2. Restricting expansion of existing commercial activity centers minimizes the impact on the watershed
- 3. The proposed changes are consistent with the original intent of protecting water quality in the watershed
- 4. Already commenced discussion about municipal expansion which will be ongoing
- 5. Conducted a public meeting with the community
- 6. Other ILA partners have indicated initial agreement to execute the amendment



Next Steps

- ILA Partners consider approval of the amendment
- Continue discussions with partnership on municipal annexation into the watershed
