1. I have personal knowledge of the matters addressed in this affidavit, and I am competent to sign this affidavit. I am the owner of Shotwell Landfill, Inc.


2. On August 6, 2016, the notice of public hearing attached under Tab A was printed in the *News & Observer*.

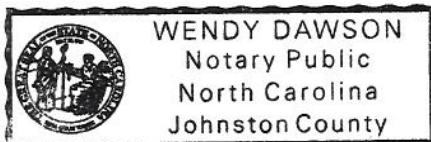



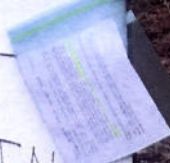
