EASEMENT

For and in consideration of <u>Ten and 00/100</u> dollars (\$10.00) and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, the undersigned owner(s) of the premises described below, (hereinafter referred to as "Grantor"), do(es) hereby grant to **BellSouth Telecommunications**, **LLC**, *d/b/a* **AT&T** North Carolina, **a Georgia Limited Liability Company**, and its parent and its and its parent's direct and indirect affiliates, subsidiaries, agents, attorneys, employees, officers, directors, servants, insurance carriers, licensees, successors, and assigns(hereinafter referred to as "Grantee"), a non-exclusive easement to construct, operate, maintain, add, and/or remove such systems of communications (including broadcast), facilities, standby generators and associated fuel supply systems as a means of providing uninterrupted service during commercial power outages, and related items as the Grantee may from time to time deem necessary in the conduct of its business upon, over, and under a portion of the lands described in Deed Book <u>2272</u>, page <u>678</u>, <u>Wake</u> County, <u>North Carolina</u> Records ("Premises"), and, to the fullest extent the Grantor has the power to grant, upon, over, along, and under the roads, streets, or highways adjoining or through said property. The said easement is more particularly described as follows: Generally, easement area shall be the areas of the premises where Grantee's facilities are shown on the routing plan attached as Exhibit A and five feet (5') on either side of such facilities; provided that, following initial installation of Grantee's facilities, the easement area will be deemed to be the areas of the Premises where Grantee's.
