#### The Introduction to the Project:

- -Who is the developer? Answer: Jack Carlisle
- -Will the county send us other notices about meetings?
- -How do we express our concerns about rezoning? Answer: Wake County Planning Dept. Bryan Coats. Information is on the letter that Adams and Hodge Engineering sent out.
- -How do we contact DOT? The roads are insane.
- -What will be the starting prices of the houses?
- -Will there be one entrance to the subdivision or two? Answer: One
- -When 540 comes, how close will it be to here?
- -Will there be a homeowners association?
- -What kind of timeframe are you talking about for starting this project? Answer: Projected to break ground in the springtime for Roads.
