Bryan,

I've copied David (Division 5) and Jimmy (Division 4) in case they have additional information.

The 3 NC 540 projects are listed below. It is our hope that R-2721 and possibly R-2828 could be moved to 2019 but it's very unlikely the projects could be accelerated before 2019. As you know the orange/green route is the selected corridor and that will include an interchange along NC 50 just north of Cleveland School Road.

R-2721 (NC 55 to US 401) in 2020

R-2828 (US 401 to I-40) in 2020

R-2829 (I-40 to US 64) in 2027 - corridor cap is holding this back

I do not have any funded projects along NC 50 although we are hopeful that some widening projects will be coming in the next couple prioritization cycles.

NC 42 is programmed for widening to four lanes in two projects.

R-3410B (NC 50 to US 70 Bypass) 2021

R-3401A (US 70 Bypass to US 70 Business) 2021

These two projects have not gone through design yet but I would anticipate some intersection improvements at NC 50 and Cleveland School Road.

There is also the I-5111 (I-40 widening) project that includes interchange improvements at NC 42 in 2019. The NC 42 interchange project was originally I-4739 but I believe this project has now been included in the larger I-5111 project.
