Subject: Neighborhood Meeting Summary

A meeting was held on August 30, 2016, at 6:00 p.m. on the New Life Camp campus. Ninety nine meeting invitations were mailed to owners of properties within 1000' of the camp property. There were eleven total attendees including camp representatives.

Loftee Smith, consultant with WithersRavenel, started the meeting and explained the need of the camp to replace existing cabins which resulted in the investigation into the placement of the current R40W / R80W zoning line and the impervious limits associated with each zoning classification. The results of the investigation being that more accurate information exists today allowing for the zoning line to be "corrected" or moved while keeping the criteria set forth in the watershed study, performed in 1992, which set the current zoning line. Maps of the camp were presented to show the existing and proposed zoning lines.

Phil Begany, member of New Life Camp Board of Directors, explained the mission and history of the camp. Mr. Begany went into further detail by explaining the need for the replacement of the existing cabins for public safety to meet current building codes and other intended improvements to the camp which are seen as necessary for the camp to continue to provide a safe and fulfilling experience for the camp users and staff.

At the conclusion of the presentations by Mr. Begany and Mr. Smith questions were fielded from the attendees. Most of the questions related to preservation of the perimeter buffers and site features as well as the proximity of certain houses to the camp.

When asked if any attendees had specific concerns or opposition to the movement of the zoning line and the camp improvements, all responses were favorable and no opposition or concerns were stated.

The meeting was concluded at 6:45 p.m.
