Roe has been involved in application of conservation easement agreements with landowners since 1976 when he completed his master's thesis-equivalent study project (@UNC-CH) on the subject of alternative methods to conserve natural areas and rural lands, and produced the first edition of conservation easement guidelines in North Carolina

Much of Roe's knowledge about conservation easements has been acquired by a combination of practical experience and reading professional articles and reference publications over a forty year span of time from 1975 to present, beginning with preparation of his master's-thesis-equivalent research on conservation easements for his UNC-Chapel Hill Master's Degree in Regional Planning. In preparation of his numerous publications (see list) focused on conservation easements and their application, during his tenure as director of the State of North Carolina's Natural Heritage Program and of the Conservation Trust for North Carolina, Roe consulted multiple reference literature sources and conferred with authorities and practitioners concerning that subject.

During his ten years tenure as director of the Conservation Trust for North Carolina (1993-2002) that organization sponsored or co-sponsored (often co-sponsored with the NC Agricultural Extension Service, NC Division of Forest Resources, private land trust conservancies and others) several dozen public educational workshops and seminars for landowners, professional advisors, and public agencies across the state on the subject of conservation easements. Roe frequently moderated those workshops, presented components of the workshop training segments, and also learned from other experienced professional instructors in those same workshops.

During his eleven years tenure as southeastern U.S. regional director for the Land Trust Alliance (2004-2014), Roe organized and managed eight regional land conservation conferences, all of which included training workshops on the subject of conservation easements, which Roe monitored and benefited by refresher and advanced training himself from listening to the experienced professional instructors. Additionally in that same time period Roe organized and managed many (approximately 15-18 total) training workshops on the subject of conservation easements for many southeastern state associations of land trusts, and for other state and national conservation organizations: including in Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina; Tennessee, and Virginia. While moderating and facilitating those workshops, Roe gained knowledge

and new information from the professional experts he employed/contracted to instruct those workshops.

Roe has been an individual member of the Land Trust Alliance's Conservation Easement Practitioners and Defense Network, and was a beneficiary of its educational information and newsletters, for the time of its existence (from 2010 to present).
