SERVICES AGREEMENT OVER \$50,000

WAKE COUNTY

THIS AGREEMENT, is made and entered into this 1st day of July, 2018 by and between Wake County, North Carolina (the "County") party of the first part; and Sonoco Recycling, LLC (the "Provider"), party of the second part;

WITNESSETH:

For the purpose and subject to the terms and conditions hereinafter set forth, the County hereby contracts for the services of the Provider, and the Provider agrees to provide the services to the County in accordance with the terms of this Agreement.

I. SERVICES TO BE PROVIDED

The services to be performed by the Provider shall be specified herein as Attachments A and B.

Provider shall not sub-contract all or any part of the services provided for in this Agreement without written approval of the County.

II. TERM

The services of the Provider shall begin on <u>July 1, 2018</u>, and unless sooner terminated by mutual consent, shall be provided until <u>June 30, 2023</u> with two (2) one-year optional extensions at the discretion of Wake County and upon mutual consent with the Provider.

III. MAXIMUM AMOUNT PAYABLE:

Total amount payable shall not exceed One Million Fifty Thousand Dollars (\$1,050,000.00) unless approved by Wake County and Provider by means of Amendment and shall be payable as follows:

IV. PAYMENT

Provider shall submit an invoice for services provided. The invoice shall contain Provider's name and federal tax identification number and shall be signed and dated by an officer of Provider. It shall detail all services provided in payment requests. The County will make payments to Provider upon receipt of and approval of the invoice by the contracting department.

V. RELATIONSHIP OF PARTIES

Provider is an independent contractor of the County. Provider represents that it has or will secure, at its own expense, all personnel required in performing the services under this Agreement. Such personnel shall not be employees of or have any contractual relationship with the County. All personnel engaged in work under this Agreement shall be fully qualified and shall be authorized or permitted under state and local law to perform such services. It is further agreed that the Provider will obey all State and Federal statutes, rules and regulations that are applicable to provisions of the services called herein. Neither Provider nor any employee of the Provider shall be deemed an officer, employee or agent of the County.

VI.CANCELLATION

This Agreement may be canceled by Provider upon thirty (30) days' written notice to the County, and the County may terminate this agreement upon thirty (30) days' written notice to Provider.

VII.INSURANCE REQUIREMENTS

The Provider shall obtain, at its sole expense, all insurance required in the following paragraphs and shall not commence work until such insurance is in effect and certification thereof has been received by Wake County's Finance Office. If any required insurance policy expires during the term of this agreement, Provider must provide a certificate of insurance to the Wake County Finance Office as evidence of policy renewal prior to such policy expiration.

Provider signature on this agreement indicates that Provider agrees to the terms of this insurance section and understands that failure to comply may result in cancellation of this agreement at Wake County's option.

Workers' Compensation Insurance, with limits for Coverage A Statutory- for State of North Carolina and Coverage B - Employers Liability \$500,000 each accident/disease each employee/disease policy limit.

<u>Commercial General Liability</u> - with limits no less than \$1,000,000 per occurrence and \$2,000,000 aggregate, including contractual liability.

<u>Commercial Automobile Liability</u>, with limits no less than \$1,000,000 per occurrence for bodily injury and property damage for any vehicle used during performance of contract services, including coverage for owned, hired, and non-owned vehicles. Evidence of commercial automobile coverage is only necessary if vehicles are used in the provision of services under this Agreement.

<u>Professional Liability Insurance</u>, applicable to any professional services provided under this Contract with limits of no less than \$1,000,000 per claim and \$2,000,000 aggregate.

If any coverage is on a claims-made basis, Provider agrees to maintain a retroactive date prior to or equal to the effective date of this Agreement and to purchase and maintain Supplemental Extended Reporting Period or 'tail coverage' with a minimum reporting period of not less than three (3) years if the policy expires or is cancelled or non-renewed. If coverage is replaced, the new policy must include full prior acts coverage or a retroactive date to cover the effective dates of this Agreement. Provider shall provide a Certificate of Insurance annually to Wake County indicating any claims made coverage and respective retroactive date. The duty to provide extended coverage as set forth herein survives the effective dates of this Agreement. All insurance companies must be authorized to do business in North Carolina and have an AM Best rating of "A-/VII" or better; or have reasonable equivalent financial strength to the satisfaction of the County's Finance Office. Proof of rating shall be provided to the county upon request.

Insurance with limits no less than those specified above shall be evidenced by a Certificate of Insurance issued by a duly authorized representative of the insurer and dated no more than thirty (30) days prior to the start date of the agreement. In the case of self-insurance, a letter of explanation must be provided to and approved by Wake County Risk Management.

The Provider shall be responsible for providing immediate notice of policy cancellation or non-renewal during the term of this Agreement to the Wake County Finance Office and for three years subsequent for any claims made coverage.

If Provider does not meet the insurance requirements specified above, alternate insurance coverage satisfactory to Wake County may be considered. Any requests for consideration of alternate coverage must be presented by Provider PRIOR TO provision of any services associated with this Agreement.

In the event that Provider uses subcontractors to perform any of the services under this Agreement, then and in that event, Provider shall contractually require such subcontractor(s) to meet all of the requirements of this section.

VIII.INDEMNIFICATION

Provider agrees to defend, indemnify, and hold harmless the County, for all loss, liability, claims or expense (including reasonable attorney's fees) arising from bodily injury, including death or property damage, to any person or persons caused in whole or in part by the negligence or misconduct of the Provider, except to the extent same are caused by the negligence or willful misconduct of the County. It is the intent of this section to require Provider to indemnify Wake County to the extent permitted under North Carolina law.

IX. NO WAIVER OF SOVEREIGN IMMUNITY

Wake County and the Provider agree that nothing in this Agreement shall be construed to mandate purchase of insurance by Wake County pursuant to N.C.G.S. 153A-435; or to be inconsistent with Wake County's "Resolution Regarding Limited Waiver of Sovereign Immunity" enacted October 6, 2003; or to in any other way waive Wake County's defense of sovereign or governmental immunity from any cause of action alleged or brought against Wake County for any reason if otherwise available as a matter of law.

X. NON-ASSIGNMENT

Provider shall not assign all or any portion of this Agreement, including rights to payments, to any other party without the prior written consent of the County.

XI. ENTIRE AGREEMENT

The parties have read this Agreement and agree to be bound by all of its terms, and further agree that it constitutes the complete and exclusive statement of the Agreement between the parties unless and until modified in writing and signed by the parties. Modifications may be evidenced by telefacsimile signatures.

XII. NON-APPROPRIATION

Provider recognized that Wake County is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are not available and not appropriated to purchase the services specified in this Agreement, then this Agreement shall automatically expire without penalty to Wake County and without the thirty (30) day notice requirement set forth in Section VI.

In the event of a legal change in Wake County's statutory authority, mandate, and mandated functions which adversely affects Wake County's authority to continue its obligations under this Agreement, then this Agreement shall automatically expire without penalty to Wake County and without the thirty (30) day notice requirement set forth in Section VI.

XIII. GOVERNING LAW

Both parties agree that this Agreement shall be governed by the laws of the State of North Carolina.

XIV. E-VERIFY REQUIREMENTS

To ensure compliance with the E-Verify requirements of the General Statutes of North Carolina, all contractors, including any subcontractors employed by the contract(s), by submitting a bid, proposal or any other response, or by providing any material, equipment, supplies, services, etc., attest and affirm that they are aware and in full compliance with Article 2 of Chapter 64, (NCGS 64-26(a)) relating to the E-Verify requirements.

XV. IRAN DIVESTMENT

By signing this agreement; accepting this contract/purchase order; or submitting any bid, proposal, etc., vendors and contractors certify that as of the date of execution, receipt, or submission they are not listed on the Final Divestment List created by the NC Office of State Treasurer pursuant to NCGS 147 Article 6E, Iran Divestment Act, Iran Divestment Act Certification. Vendors and contractors shall not utilize any subcontractor that is identified on the Final Divestment List.

In addition:

Any organization defined under NCGS 147-86.80(2), Divestment from Companies Boycotting Israel, shall not engage in business totaling more than \$1,000 with any company/business, etc. that boycotts Israel. A list of companies that boycott Israel is maintained by the NC Office of State Treasurer, pursuant to NCGS 147-86.81(a)(1). Any company listed as boycotting Israel is not eligible to do business with any State agency or political subdivision of the State.

ATTACHMENT A
RECYCLING SERVICES SPECIFICATIONS

SCOPE OF WORK:

The Contractor shall provide recycling collection services at each WCPSS site specified in the attachments. New sites may be added by Wake County at any time. As new sites are added, unit pricing in effect at the time will be used to expand the scope of the contract.

Provider shall provide collection containers, hauling services, and processing of the following recyclable materials from WCPSS facilities:

- a. Mixed paper including catalogs, cartons, envelopes, file folders, magazines, newspaper, notebook paper, office paper, phone books, snack boxes, etc.
- b. Aluminum cans and foil
- c. Glass bottles and jars
- d. Plastic bottles and containers
- e. Tin food cans

1. HAULING FREQUENCY

The frequency of mixed paper and commingled recyclables collection services at participating WCPSS facilities is once per week.

- i. Wake County reserves the right to increase or decrease the frequency of pick-ups at individual facilities based on the level of recycling activity at that site, operational requirements of the facility, or to accommodate holiday schedules, and year-round/traditional calendars. Where space permits, Wake County will request the Contractor add additional carts so that the frequency of pick up will remain once per week. However, space limitations may prevent the addition of more carts and require that a second (or more) pickup must occur. If the frequency is increased to two or more pickups per week for a particular school, the Contractor will be reimbursed for each pickup based on the pricing provided in Attachment B.
- ii. The approximately 135 tons of commingled recyclables generated by WCPSS Child Nutrition Services (CNS) may eventually be added to this contract.
- iii. The collection of paper and commingled recyclables at WCPSS facilities shall not interfere with the start of school in the morning or dismissal of students at the end of the day.
- iv. The Contractor agrees to respond to emergency, extra pick-up requests within 24-hours of being notified in writing (email), or verbally (telephone), by Wake County.
- 2. Where local ordinances require enclosures, the driver will open all enclosures and correctly replace the containers. At WCPSS facilities, the Contractor will be responsible for closing gates.

- 3. The Contractor will determine recycling collection schedules subject to approval by Wake County. It is preferable that the Contractor maintain the existing pick-up schedule, to the extent possible. Any change in recycling collection schedules or change in the number of carts must be submitted in writing to and approved by the Contract Administrator at least five (5) working days prior to the changes. All schedules are tentative and subject to change based on school and other WCPSS facility needs.
- 4. The Contractor shall not be required to make regular collections on New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, or Christmas Day; provided, however, that collection occurs reasonably in advance thereof or thereafter in the opinion of the Contract Administrator. The rest of the week's schedule shall be completed regardless of the holiday. The Contractor shall provide a holiday service schedule in writing at least ten (10) days prior to the holiday.
- 5. Wake County and the Contractor acknowledge that timely performance of collection services is essential to the success of the recycling program. In extreme circumstances, collection may be suspended to protect public safety and/or the safety of the Contractor's employees. In the case of such an event, the Contractor will first contact Wake County so they can notify the effected sites and reschedule collection on a date acceptable to Wake County and the sites.
- 6. If scheduled service cannot be made due to equipment failure, illness, weather, or other unforeseeable delay, the Contractor will notify Wake County immediately.
- 7. The Contractor will provide 65 and 95 gallon recycling roll carts to the WCPSS facilities as part of the recycling collection services. The 65 gallon carts are generally used at elementary schools. The 95 gallon carts are generally used at middle schools, high schools and charter schools. Roll carts shall be new and uniform in color and design. Roll carts shall be able to withstand outdoor conditions. Roll carts shall be labelled with signage as provided by Wake County.
 - i. Broken carts shall be replaced by Contractor in a timely manner at no additional cost. Contractor shall provide new carts for school sites that are added to the program or to meet increased demand at existing sites, at no additional cost <u>up to the limit specified</u> on the Pricing Sheet.
 - ii. Contractor shall document and report to Wake County the number of replacement and new carts on an annual basis. After the total number of 65 gallon or 95 gallon carts specified on the Pricing Sheet is exceeded, Contractor shall provide carts at the Contractor's bid price.
 - iii. The Contractor shall keep up-to-date and accurate records of the number and type of carts and decals at each WCPSS facility and in storage. The Contractor shall notify the County whenever containers or decals (signs to identify the containers as recycling containers) in reserve are below twenty (20) in number.
 - iv. Wake County reserves the right to add or remove the number of containers and number of pick-ups when it is in the best interest of the Wake County.

- 8. Contractor shall respond to the Wake County's service-related inquiries within two (2) working days of receipt.
- 9. Contractor will provide one (1) point of contact to Wake County serving as an account manager as well as a point of contact for emergency service or repair issues.

CONTRACTOR EQUIPMENT

- i. The Contractor shall keep vehicles compatible with all specified recycling carts (65 and 95 gallon containers) owned by Contractor for the term of this Agreement.
- ii. Contractor shall keep all equipment used in the performance of the work in good working order and in a clean sanitary condition. The Contractor shall be responsible for the clean-up and full remediation of all fluid spills originating from their equipment. Equipment is subject to periodic inspection by Wake County.
- iii. Contractor shall clearly mark, as determined by Wake County, all trucks used for recycling collection with the Contractor's name and phone number.
- iv. Contractor shall secure and pay all licenses and permits required by law before and during the course of work.

ADDITIONAL CONTRACTOR RESPONSIBILITIES

- 10. The Contractor shall maintain an office with continuous supervision for accepting complaints. The office shall be in service during the hours of 7:00 a.m. until 5:00 p.m. Monday through Friday or until all routes are complete, whichever is later. The address and telephone number of such office and any changes therein shall be given to the County in writing.
- 11. The Contractor shall immediately clean up and dispose of any waste, recyclable material or other debris that is spilled in the provision of collection services to a facility.
- 12. The Contractor shall not use private driveways or parking lots that are not owned by the WCPSS while providing collection service under this Agreement.
- 13. The Contractor shall use its best efforts to ensure that all recyclable materials collected from WCPSS facilities are not placed in landfills or incinerators and are distributed to the appropriate markets for reuse and recycling. The Contractor will report to Wake County the types and amounts of recyclable materials landfilled, the reason for the landfilling and the steps being taken by the Contractor to avoid future landfill events. All costs associated with such disposal will be borne by the Contractor. The Contractor will at all times be under a duty to minimize recyclable materials landfilled.
- 14. Contractor shall be responsible for paying all fees (including landfill tipping fees), royalties, insurance premiums, etc., as required by law to fulfill the contract(s) based on the total number of containers.
- 15. The Contractor shall be responsible for any damage incurred in the performance of this Agreement, except as provided for in state law, by any employee, truck or equipment to property such as, but not limited to, dumpster enclosure walls, gates, fences, garage doors,

bollards, and third-party vehicles at facilities. Damage to WCPSS facilities must be reported immediately to the Contract Administrator.

FILING OF REPORTS

- 16. The Contractor shall provide an accurate monthly summary of the total tonnage of all recyclable materials collected and the primary purchaser(s) of the recyclable materials. Monthly summaries and invoices shall be submitted no later than the sixth (6th) working day of the month following the month of service, and may be submitted electronically upon agreement of Wake County.
- 17. If pricing on the Bid Form Alternate is selected, during the first contract year (July 1, 2018 through June 30, 2019), the Contractor shall provide an accurate monthly summary of the total tonnage of the commingled recyclable materials collected <u>and</u> the total tonnage of mixed paper collected. Depending on how the Contractor collects the materials, this may require that the commingled recyclables are collected with a separate collection vehicle in order to develop accurate weight estimates.

ACCESS TO RECORDS

18. The Contractor shall provide access to Wake County or any of its duly authorized representatives to review any books, documents, papers, and records of the Contractor related to performance of this Contract for the purpose of making an audit or other examination verifying compliance with its terms, and for preparing any reports required of the County.

WCPSS RESPONSILIBITIES

Wake County and the WCPSS shall provide the following services:

- a. Determine the specific facilities that will become part of the program.
- b. Determine the level of service to each facility (number of roll carts) with Contractor's recommendation.
- c. Determine the size, type and number of collection carts required by each Site.
- d. Provide public education and promotional materials to site managers for distribution to students and staff.
- e. Communicate with WCPSS site managers and custodial staff on recyclable material quality requirements.

SCHEDULE OF UNIT CHARGES AND ADJUSTMENTS

- 19. The initial Schedule of Unit Charges to be assessed by the Contractor to Wake County for services required herein shall be valid for the period extending from July 1, 2018 through June 30, 2019. Adjustments to the Schedule of Unit Charges shall be made on an annual basis, beginning July 1, 2018, in accordance with the Unit Cost Adjustment Factor described below.
- 20. Garbage and Trash Collection Consumer Price Index (CPI) Adjustment Factor
 - a. The Garbage and Trash Collection CPI Adjustment Factor shall be applied to the unit charge for collection and recycling (Bid Form Items 1 through 12). The unit charge adjustment factor shall be calculated based on the Bureau of Labor Statistic's Garbage and Trash Collection (US City Average, all Urban Consumers, Not Seasonally Adjusted) component of the CPI. Refer to: https://www.economy.com/united-states/cpi-urban-consumer-garbage-and-trash-collection/not-seasonally-adjusted. In all cases, the adjustments to the unit prices will be made up or down, as indicated by the change in the index. The maximum increase or decrease in any one year is limited to 3 percent. The unit rates for Bid Form Items 1 through 12 may only be adjusted on July 1 of 2019, 2020, 2021 and 2022. based on changes in the Garbage and Trash Collection component of the CPI. The base Garbage and Trash Collection CPI for the Contract shall be calculated using the average of the monthly Garbage and Trash Collection CPI values reported for the 12-month period extending from January 2017 through December 2017.
 - b. Unit rate change for collection and recycling shall be adjusted on July 1, 2019 based on a comparison of the average of the monthly CPI values reported for the 12-month period extending from January 2018 to December 2018 with the base CPI value. CPI adjustments will be made in the same fashion in subsequent years.
