Item Title: Wake County Juvenile Crime Prevention Council Annual Plan and

Certification for FY 2018-19

## **Specific Action Requested:**

That the Board of Commissioners adopts the Wake County Juvenile Crime Prevention Council Annual Plan for FY 2018-2019

## **Item Summary:**

Purpose: The Department of Public Safety (DPS) requires each county to

prepare an annual plan before releasing the county's allocation of DPS funds. The annual plan is prepared by the local Juvenile Crime Prevention Council and includes results from its needs assessment and resource assessment, priorities for funding and funding

recommendations.

Background: Juvenile Crime Prevention Council funds are made available to

Wake County from the North Carolina Department of Public Safety Division of Juvenile Justice to provide community-based delinquency and gang prevention strategies and programs. North Carolina General Statute 143B-845 sets the intent and responsibilities for Juvenile Crime Prevention Councils and requires planning efforts that include representation from local government, local public and private agencies serving juveniles and their families, local business leaders, citizens with an interest in youth problems, and youth representatives. DPS funds are used to provide services such as skill building programs for youth suspended from school, afterschool and weekend life-skills programs, literacy programs, emergency and residential placement, restitution community service

programming, and parenting programs.

Board Goal: This action complements various initiatives in the Public Safety goal

area.

Fiscal Impact: Grant funding and the County match total roughly \$2.3 million and

have been included in the FY2019 operating budget.

## **Additional Information:**

After considering the risk and needs assessment of Wake County youth and a resource assessment in the county, the Juvenile Crime Prevention Council identified the need for the development and strengthening of effective and accessible services for youth who may have been exposed to trauma or may be serious or violent offenders, including but not limited to services for gang involved youth. As a result, the Council prioritized the following risk and protective factors to be addressed by programs in the 2018-2019 Request for Proposals:
