## II. Item Title: Regional Food System Plan

Katherine Williams – Cooperative Extension Director

**Item Summary:** In response to recent activity and interest in a regional approach to food systems and economic development, the staff from Cooperative Extension have discussed approaches with staff from Durham, and Orange counties. This presentation reviews concepts, issues and opportunities staff have discussed. Staff welcome any feedback on this concept.

The components of a food system may be categorized in several ways, but five major areas capture the basics: 1) production, 2) processing, 3) distribution, 4) retail and wholesale consumption, and 5) waste. There is clear economic development opportunity in all aspects of that system but particularly in the areas of processing, distribution, and retail/wholesale consumption markets. Robust development of the economic drivers will create market for regional and statewide growers and provide positive benefits for agriculture, including more diverse markets and conservation of farms and farmers.
