I. Wake County Human Services Horizon Issues – Regina Petteway, Human Services Director

During the 2018 session, the State Legislature passed bills affecting reporting requirements and accountability standards for human services agencies state-wide. Staff will summarize these new requirements, which include new performance standards for several assistance programs and new State oversight structures. Staff will also summarize new requirements to recoup Medicaid overpayments or payments made in error. Mandy Cohen, MD, Secretary of the North Carolina Department of Health and Human Services, will join this briefing to share state perspectives on these changes.

III. Cooperative Extension Proposal for Wake Community-University Partnership Opportunity – Katherine Williams, Cooperative Extension Director and Dr. Leslie Boney, Vice Provost for Outreach and Engagement

Staff from the Cooperative Extension have collaborated with the NC State Office of Outreach and Engagement on a partnership opportunity to advance the Social and Economic Vitality program. The partners will identify community projects that will benefit from NC State faculty research and Cooperative Extension engagement. The partnership will seek opportunities and focus resources in two engagement zones, Southeast Raleigh and Eastern Wake County.

Wake County has commenced a process to develop its first ever Comprehensive Plan to help guide future growth and development. This effort will include updating our current land use plan and development policies while incorporating other master planning efforts by the County including parks and recreation, open space, greenways, affordable housing, transit/transportation, economic development, farmland preservation, and a variety of other elements. The project has been titled PLANWake and will take a thoughtful look at our community's major challenges and opportunities. Public engagement and stakeholder input will be a key aspect of the project. The process will take approximately 18 to 20 months and result in a final document that will outline the County's vision and key growth policies.
