Item Title: Additional Juvenile Crime Prevention Council Funding from the North

Carolina Department of Public Safety

Specific Action Requested:

That the Board of Commissioners accepts and appropriates \$32,240 of additional funding from the North Carolina Department of Public Safety (NC DPS) for Juvenile Crime Prevention Council (JCPC) partner agencies into the Human Services Department.

Item Summary:

Purpose: The Board of Commissioners must approve amendments to the

budget.

Background: NC DPS provides JCPC funding for each county in the state to

reduce and prevent juvenile crime. Through an annual needs assessment process documented in an annual plan approved by the Board of Commissioners, JCPC reviews and presents data related to juveniles at risk of or involved in the juvenile justice system. The needs assessment informs a competitive process that results in funds for local agencies to address the needs of youth at-risk. There are 11 separate programs that provide programming on a continuum of services targeting youth – at risk of or engaged in – delinguent

behaviors or gang involvement.

NC DPS will make available discretionary funds for capital needs to Wake County's JCPC-funded programs. NC DPS will award \$32,240

to two programs in Wake County.

Board Goal: Public Safety: One of the primary goals of all JCPC funded programs

is to reduce recidivism and prevent juvenile offenders from becoming

involved in the adult prison system.

Fiscal Impact: The County will receive a one-time payment of \$32,240 from NC

DPS to support Wake County JCPC-funded programs. This will increase Human Services budgeted revenues and expenditures by

\$32,240.

Additional Information:

NC DPS is providing additional discretionary funding to meet the expected increase in demand for services resulting from lawmakers raising the age of juvenile jurisdiction for nonviolent crimes to age 18 (Raise the Age). Individuals who are 16 and 17 years-old who commit crimes in North Carolina will no longer automatically be charged in the adult criminal justice system. The effective date is December 1, 2019.

The following programs received JCPC discretionary funds for capital increase:

- Juvenile Restitution and Community Service Program will receive \$30,000 for a vehicle to transport youth to worksites
- Wrenn House will receive \$2,240 for computer equipment

JCPC funding is received and expended in Wake County's Human Services General Fund budget. NC DPS reallocated FY19 funding between programs, shown below as FY19 Amended Budget.
