III. CARES Act Funding Plan

IV. Fall Election Preparations and Staffing

V. Wake Transit Update

Sales tax proceeds are the primary revenue source funding Wake transit investments. The economic downturn has significantly lowered projected revenues, forcing GoTriangle and CAMPO to reconsider priorities for limited funding. Staff will review existing capital and operating investment plans, then pose a series of questions to the Board to solicit feedback on funding priorities. Commissioners will provide feedback to staff on the questions raised, and share any additional feedback during the work session.
