II. Wake County Public Art Project Updates

In 2016, the Wake County Board of Commissioners enacted an ordinance to establish funding for public art in certain county capital projects. The intent of the ordinance is to enhance the aesthetic environment, expand public experience and exposure to culture through various art forms, enhance the appearance of public facilities and improve the environment of the county on behalf of its citizens, by the incorporation of art in the design and construction of public facilities within the county.

An administrative policy was subsequently established to define the process for acquiring and managing public art that is commissioned for Wake County owned facilities or donated as part of the Public Art program. County capital improvement projects estimated to cost \$1 million or more that provide significant general public access such as libraries, parks, and greenways shall be eligible for funding.

Staff will present the first two completed public art installations, design concepts for the next project, and future projects where public art is planned over the next few years. Staff ask the committee to receive the information and share any feedback.

Economic Strength

Goal ES 4: Support, promote, and celebrate arts and culture.

Rationale: Arts and culture are core to Wake County's identity. Inclusive cultural and artistic programs help broaden individual perspectives and enrich everyday experiences. Wake County supports its arts community that inspires and enlightens those living here and contributes to our continued growth.

Objectives:

- Improve residents' overall quality of life—linking to community health and vitality strategies.
- · Grow and broaden the economic base.
- Support and encourage visual and performing artistic expression.
- Increase exposure to art programs to school-aged youth.
