Mr. Marcus Kinrade, Wake County Revenue Director, said the North Carolina General Statute 105-373, the tax collector shall make a sworn report to the governing body to the taxing unit and make full settlement for all taxes collected for the preceding fiscal year. He said the Fiscal Year 2017 overall collection rate was 99.87% that leads the state. He commended his staff and their training for the collection rate.

Commissioner Portman commended Mr. Kinrade and his staff for an incredible job and Wake County for a nine year historical collection rate. He said that staff should be commended for the results and professionalism. He said the County Manager and all revenue staff deserve recognition.

Commissioner Portman moved, seconded by Commissioner Ford, that the Board of Commissioners accept and approve the settlement of the tax collector, credits him for taxes collected for the preceding fiscal year, credits him with releases duly allowed by the governing body for the preceding fiscal year, charges him with all collections for the current fiscal year and duly enters the settlement and charge into the minutes. The motion passed unanimously.

Mr. Joe Desormeaux, Assistant Superintendent for Facilities, Wake County Public School System, said the request is for the partial construction funding of Willow Springs High, Apex High and program components in the Capital Improvement Plan (CIP). He shared a Facilities, Design, and Construction Fall 2017 Appropriation Summary chart. He said the \$9,388,111 Program Contingency Request and the Space Needs Analysis and Prioritization (SNAP) request of \$2,300,000 will be requested at a later date.

Commissioner Portman asked whether the \$1 Billion in CIP covered

anticipated school construction was within budget. Mr. Desormeaux said that staff could provide this information to the board.

Commissioner Holmes thanked Mr. Desormeaux for the format and explanation of funding. She said it is helpful to know what has been accomplished and align the appropriations with actuals.

Commissioner Burns asked if the seven year plan for the new capital plan has changed the planning for spending capital appropriations comparing 2013 to ongoing plans.

Mr. Desormeaux said this is a seven year plan allowed for a closer look at the cash flow and the best ways to appropriate the funding.

Chairman Hutchinson said that Wake County staff and Wake County Public Schools' staff meet regularly to discuss the plan. Mr. Desormeaux said that both staffs meet monthly.

Commissioner Portman asked when the yearly review occurs for the capital plan.

Ms. Johnna Rogers, Deputy County Manager, said the enrollment numbers will be received in October and a complete review will be made. Commissioner Portman asked if the review will occur at the end of the fourth quarter of every year. Ms. Rogers said this is the second year of the seven year CIP.

Vice-Chair Calabria moved, seconded by Commissioner Burns, that the Board of Commissioners approve the following requests from the Board of Education for reallocations and appropriations in the WCPSS capital programs:

1. Appropriate \$2,435,856 in CIP 2013 for design for the Stough Elementary Renovation; and

2. Appropriate a total \$120,467,986 in the Seven-Year Capital Improvement Program for partial construction funding at Willow Spring High and Apex High; public infrastructure for Willow Spring High and Apex High; startup design for E-35 and H-15; design and construction funding for Space Needs Analysis and Prioritization (SNAP) projects; and annual allotments for property acquisition and security The motion passed unanimously.

Ms. Glenn George, Senior Vice President and General Counsel, UNC Health Care System said that the funding agreement expired on June 30, 2017. The board is requested to approve an amendment to the funding agreement that will continue the terms of the prior agreement with an extension to June 30, 2018. The county's annual funding committment for this agreement will be held constant at \$10,700,912. She said Wake County, UNC Health Care and Alliance Behavioral Healthcare began a joint committment for the provision of services at the WakeBrook campus in 2013. Funding comes in a large amount from Wake County and Medicaid. She said UNC Healthcare made a committment of \$40 million in 2012 to support behavioral health services in Wake County. She said that UNC Health Care operates crisis and assessment services, two 16-bed residential programs and a 28-bed inpatient program. Ms. George said UNC funded an expansion of WakeBrook last year at a cost of \$4 Million to add to the WakeBrook facility and to add an additional 12 beds to the existing 16 inpatient beds. She said that UNC Health Care provides medical care at WakeBrook. She said primary care and dental clinics are operated at WakeBrook for patients that do not have access to a primary care physician.

Commissioner Ford commended the partnership with UNC and Alliance Behavioral Healthcare. He said board members want to highlight the bridge between the existing two year contract and the amendment for the extension of the contract.

Ms. Beth Smerko, Senior Deputy County Attorney, said that she has worked with the UNC and Alliance Behavioral Health contract. She acknowledged Ms. Denise Foreman, Assistant County Manager, for working with the contracts. She said each year the contract is reviewed for auditing, reporting, defining source, and the use for funding. She said the amendment adds funding under the same terms and conditions as the previous contract.

Commissioner Ford asked about the interim funding for July since the agreement expired June 30, 2017. Ms. Smerko said there has been continuity of services and the agreement was necessary in order to sign the contract for payment to UNC.

Commissioner West asked about how follow up occurs and moving patients into the community and whether there is interface between patients

that have mental health issues and substance abuse issues for a seamless process.

Ms. George said WakeBrook is a model because of the range of services that it provides. She said that UNC also staffs an outpatient clinic with 500 patients and another facility called Horizons for substance abuse patients and expectant mothers.

Mr. Rob Robinson, President and CEO, Alliance Behavioral Healthcare, said staff will provide a report to the board on August 28, 2017 at the upcoming Work Session. He said there will be additional information provided to the board on opioid addiction.

Commissioner Portman said he served on the Board of Commissioners in 2011 when changes to the LME took place. He asked for quantitative information about how the care, cost, length of stay, and capacity have changed. He said that he has toured WakeMed and there is a department for mental health care that is at capacity. He asked for information about the real needs and cost for Wake County in the area of mental health. He asked for information about the shortfall each year, the plan beyond the one year extension, and how the continuous coverage plan and capacity issues will be handled.

Mr. Robinson said that he can provide information about how Alliance Behavioral Health was formed and how Wake County has benefited since that time.

Mr. Hartmann said he will ask staff to work with Human Services to compare the historical information and provide this information to the board.

Commissioner Portman said there is a capacity issue with mental health and it is important that those with mental health needs are being cared for.

Mr. Robinson said that since the Local Management Entity (LME) there has been increased population and shrinking resources. He said that comparison data can be made by staff.

Mr. Hartmann said the state has recently limited resources for opening of another crisis facility. He asked whether the \$26 Million for mental health that Wake County has provided is the highest in the state Mr. Robinson said that Wake County leads other counties for contribution of services for mental health.

Commissioner Burns said that he is proud of the role that Wake County has given toward mental health over the years to provide services for

mental health demand and there is interference from the legislature for funding. He said that it is important to understand that there is a lack of control over the actions from the legislature.

Commissioner West said the ideal, actual and impossible constraints must be considered for mental health care.

Commissioner Portman said there are many needs for providing county services in Wake County competing for the same tax dollars. He said that if there is not clarity about the needs for mental health, they will not be met. He said the stewardship responsibility is the safety net for the citizens of Wake County. He asked about the full funding needs for mental health.

Mr. Robinson said \$366 Million a year is needed to be able to serve the uninsured/underinsured equal to the services available for individuals with Medicaid across the four county region.

Commissioner Burns said he would like information presented at the Work Session about what percentages of funding for future projects came from Wake County, state Medicaid funding, and the percentages that were withdrawn from the budget for future years. Mr. Robinson said he would provide this information to the board.

Commissioner Ford expressed his appreciation to Alliance Behavioral Health staff for presenting the item and providing additional information.

Chairman Hutchinson thanked Commissioner Ford for requesting this to be placed on the regular agenda. He asked about the \$40 Million that was committed from WakeBrook.

Ms. George said the \$40 Million is being used to subsidize operations and for the addition of the twelve beds. She said a quarterly report is provided and half of the \$40 Million is still available.

Chairman Hutchinson asked about the burn rate each year. Ms. George said the burn rate is being reviewed, and additional information can be provided to the Board of Commissioners.

Chairman Hutchinson said a sustainability plan is needed so the burn rate is under control. Ms. George said there are regular meetings with leaders from other hospital to improve services and extend resources. She said Wake County also hosts regular stakeholder meetings to provide updates.

Chairman Hutchinson said the cuts being proposed at the state level can be detrimental to Wake County and the Work Session on August 28 will highlight this information. Commissioner Portman said reducing the burn rate may not solve the problems and solving the problem means providing care in a more cost effective manner with better outcomes.

Commissioner Ford said he is open to forwarding questions to Alliance Behavioral Healthcare in advance of the Work Session. He asked for discussion on the delays for the Adult Care Crisis Center and the Mental Health Behavioral Clinics at the Work Session.

Mr. Hartmann asked the board to forward the questions to Ms. Denise Foreman to ensure they are covered during the presentation.

Commissioner Ford moved, seconded by Commissioner Burns, that the Board of Commissioners authorize the County Manager to execute an amendment to the Funding Agreement with Alliance Behavioral Healthcare for UNC Health Care Behavioral Health Services at WakeBrook for fiscal year 2018, subject to terms and conditions acceptable to the County Attorney. The motion passed unanimously.

Mr. Jim Hartmann, Wake County Manager, said this is a second reading of the item. He said the North Carolina General Assembly adopted Senate Bill 155. The bill was signed by the Governor and became law on June 30, 2017. He said the approval of the ordinance covers the unincorporated areas of Wake County.

Commissioner Ford said that he spoke with Mr. Paul White, Wake County ABC Board, who provided additional information about the businesses affected by the approval of the ordinance. He said there are 790 mixed beverage permits in Wake County with the majority located in municipalities and fourteen in the unincorporated areas of Wake County, including the Raleigh-Durham Airport Authority property. He said that country clubs in the unincorporated area are also affected by the approval of the ordinance.

Commissioner Burns moved, seconded by Commissioner Holmes,

that the Board of Commissioners approve an ordinance allowing for the sale of malt beverages, unfortified wine, fortified wine, and mixed beverages in unincorporated Wake County beginning at 10:00 a.m. on Sundays pursuant to the licensed premises' permit. The motion carried by the following vote:
