Meeting Called to Order

Commissioner Burns called the meeting to order at 10:00 a.m.

Approval of the Minutes

Commissioner Hutchinson moved, seconded by Commissioner Calabria, to approve the Growth, Land Use, and Environmental Committee minutes of the May 8th, 2017 meeting. The minutes were approved unanimously.

Wake County Comprehensive Plan

Mr. Tim Maloney, Director, Planning Development Inspections, provided an overview of today's topics. Mr. Maloney said a consultant RFP will be released soon for the Wake County Comprehensive Plan and he would like to make sure the committee is in agreement prior to the release.

Mr. Maloney said the county has never had a comprehensive plan. He also said staff is working with partner agencies to leverage additional funding for the plan.

Mr. Tim Gardiner, Planner III, presented the existing conditions of the current county plans.

- · Land Use Plan with solid but high level goals
- Area Plans with differing levels of sophistication/ applicability
- Separate Transportation Plan
- Other plans


Mr. Gardiner shared the known issues with the current plans.

- Old Plans
- Plans not integrated



Commissioner Burns asked if staff should be looking at plans that are for future sub developments during this process. Mr. Maloney said that has been discussed and policies have been updated to require consideration of future sub developments.

Commissioner Portman suggested looking at all the municipal plans to determine what the county can do to assist the municipalities in providing services.

Mr. Maloney said one of the biggest issues is people are building bigger houses, which is limiting their space for a septic system.

Mr. Bryan Coates, Planner III, said over the last five years, staff has requested easements for utilities when a new sub-division is being proposed. He said this has been helpful and a simple process.

Commissioner Hutchinson said the county is going to double in size in coming years and it is important to consider that when creating this plan. He also said affordable housing and healthy communities need to be considered.

Mr. Maloney said staff will be looking at how other states and jurisdictions have implemented a comprehensive plan. Commissioner Burns suggested looking at Canada as well.

Commissioner Burns said he is concerned that open space will not be preserved properly.

Commissioner Calabria said open space is a very important issue and needs to be looked at closely.

Mr. Maloney shared the proposed schedule for developing the plan.

Now – Nov 2017 – Frame the Study

Nov 2017 – Dec 2017 – Select the Consultant

Jan 2018 – May 2018 – Ask the Big Questions

May 2018 – Sep 2018 – Verify the Policies

Triangle Bike Way

Mr. Chris Snow, Wake County Parks, Recreation and Open Space Director, said that the I-40 corridor is the most congested in the region.




He shared the potential solutions for congestion.

- Keep pace with demand
 - Additional lanes
 - Managed lanes
 - · Improved regional bus service

Mr. Snow said an additional solution would be a bike commuter route. Mr. Snow said this concept has been in the transit plans for Wake County and surrounding regions for several years. Mr. Snow said the Commissioners approved a funding agreement in May with Capital Area Metropolitan Planning Organization (CAMPO) to complete a feasibility study, which has been completed.

He shared a concept map for a bike commuter route.



Mr. Snow said staff is meeting with all those involved and everybody has agreed to move forward with creating the comprehensive plan.

Mr. Snow said there is a potential for additional funding through CAMPO. He shared information on potential funding for FY 2019 from Locally Administered Projects Program (LAPP).

- Locally Administered Projects Program (LAPP)
 - Approximately \$6 million to award for the FY 2019 funding cycle
 - Grant applications are due October 31, 2017
 - Design between Lake Crabtree and the Wake/Durham County line
 - Estimated cost for design = \$1,276,080
 - CAMPO's minimum 20% match = \$255,216
 - Very competitive projects with design as a single component do not score as well
 - Proposing a 25% match, or \$319,020 to increase the odds of receiving funding.

He also shared information about approximately \$70 million that is expected to be awarded for FY's 2022 & 2027 from the Strategic Transportation Prioritization (SPOT).

- Strategic Transportation Prioritization (SPOT)
 - Approximately \$70 million to award for the FY 2022 & FY 2027 funding cycles
 - 5 year cycle

Triangle Rikeway - Rike Highway

- Design, acquire right-of-way and construction between Raleigh's Reedy Creek Greenway in the east (Trenton Road) and Lake Crabtree County Park.
- Estimated cost for design = \$16,259,760
 - CAMPO's minimum 20% match = \$3,251,951

Commissioner Burns asked if the bike commuter route is on the current greenway plan. Mr. Snow said it currently is not, but the plan is flexible and there will be a request later this month for it to be added to the existing plan.

Commissioner Calabria asked how the county would fund its match if the grants were approved. Mr. Snow said the project is eligible for Capital Improvement funding.

Commissioner Hutchinson asked if the county match money needs to be identified prior to applying for the grants. Mr. Snow said CAMPO requires a letter stating the county will make attempt to obtain their portion of funds if these grants are approved.

Commissioner Hutchinson stressed the importance of this project. He said there is no other viable way to get through this corridor.

Commissioner Burns said many greenways are in need of attention and the board needs to be careful not to focus just on this one project.

A short break was taken at 11:03 a.m.; the meeting was called back to order at 11:12 a.m.

Commissioner Burns asked Mr. Orbon if he is aware of brown water coming from a certain water supplier's pipes. Mr. Orbon said he had one complaint recently and has worked with the resident to connect them with public water supply. He said the problem is believed to be caused by too much iron in the water. Mr. Orbon said he also addressed a complaint on low water pressure in that area.

Ms. Dale Threatt-Taylor, Conservation District Administrator, said this plan can be a great flood control structure, but will require public education and communication.
