Mr. Bryan Hicks, General Manager, Alcohol and Beverage Control Board along with Mr. Lucius Jones, ABC Board member and Mr. Ken Kirby, Vice-Chair of the Alcohol Beverage Control Board (ABC Board) presented a check in the amount of \$13M to the Board of Commissioners. He shared that sales are up seven percent this year. He shared that the board currently operates 25 retail stores (13 of which operate as wholesale outlets).

Mr. Jones shared that \$1M has been contributed to WakeBrook, \$5M to nonprofit partners, and \$5.6M to Wake County municipalities. He shared that bars, restaurants and clubs are down one percent. He shared that five of the top selling stores are located in Wake County.

Vice-Chair Adamson shared that the ABC board is her favorite group and thanked the board for the presentation.

Chair Calabria thanked the ABC board for the presentation and for the work that they do for the County. He shared that these funds support various programs in the community.

Sgt. Ronald Waller will continue to recover from his injuries at home, following several surgeries. Sgt. Waller faces on-going rehabilitation and physical therapy.

On the morning of June 2nd, Wake County deputies, along with other area law enforcement agencies, responded to the River Birch at Town Center Apartments off Old Wake Forest Road in Raleigh, after Sgt. Waller was shot while conducting a civil process.

As Sgt. Waller continues to recover from his injuries, the Wake County Sheriff's Office reminds citizens interested in supporting the family, that they can do so by visiting any of the 272 State Employee Credit Union of North Carolina branches statewide. He shared that resources should be made available to organizations in an effort to reach families in need. He shared comments about collective impacts and the empowerment of residents.

Commissioner Thomas shared that municipal managers should be invited to the community and organization meetings. She shared comments on creating a listserv to include municipal council representatives.

Commissioner Cervania shared comments on lifting the moratorium, evictions and the accomplishments of the Wake County Board.

Vice-Chair Adamson shared comments on communication and how it is disseminated. She shared comments on the HOUSEWAKE flyers and the translation.

Chair Calabria shared that the other business topics are centered around services that are being offered in the county and housing evictions.

Commissioner West shared comments on residents being displaced. He shared that the information should be distributed directly to the residents and not just to the directors of organizations.

Manager Ellis shared that the information is being shared with the residents that need it. He shared that a better job of dissemination could be enhanced.

Chair Calabria shared comments on the creation of a listserv. He shared that Housing currently has a listserv. He shared that additional data would be a benefit.

Manager Ellis shared that he has asked Mr. Holder and Ms. Jacobs to look at community outreach.

Commissioner Cervania shared comments on communication infrastructure.
