She shared a cookie with the Board representing the 85 years of service assisting families in Wake County. She shared that 27 residents were relocated last week. She shared that Wake County has partnered with TFS for 85 years.

Charles Dingee - no show

Heidi Franco - representing Habitat. She shared comments on property taxes. She lives in Wake Forest and shared that her neighbors are concerned about losing their homes due to the tax hike. She asked the Board to apply for a grant to support taxes.

Steve Rao - shared comments on innovation in Morrisville. He shared a book by Bill Gates on innovation. He shared comments on the IDC award that Morrisville received. He shared comments on Ukraine and the innovation jobs that are founded by Ukrainian's that are located in the U.S. He asked Commissioners to go to Ukraine.net and listen to the stories.

Elaine Peebles Brown - 721 Calloway Dr, Southeast Raleigh, 4th generation Wake County resident, shared comments on the increase in property taxes.

Leslie Fox - Hanes Street, shared comments on the property tax program. Shared that she was eligible for the property tax relief program in the beginning until they calculated her annual salary of \$8500.

Rev Holloway - Pastor of Friendship Chapel in Wake Forest. Has lived there 40 years. Shared that neighbors are being gentrified. He shared that property taxes are an issue as well in Wake Forest. Shared that his congregation is struggling.

Jemonde Taylor - Director of St Ambrose in Raleigh near Rochester Heights. He shared comments on gentrification. He implored the Commissioners to act now. He shared comments on negotiating their ask. He shared that they are ready to be flexible.

Edna Hall - lives in Wake Forest, shared comments on the property taxes. Asked the Board to consider a grant to support these efforts.

Tony Quarrio - shared comments on gentrification and the new businesses that are taking over. He shared comments on the Leandro case, people aren't educated enough to get the available jobs. Asked the Board to do something for all of the people that built this state.

Quincy Scott, US Veteran of 30 years. He shared that he appeared years ago and was told that the issue of housing was a priority but the county hasn't done the right thing. He shared comments on increased taxes and asked the Board to do the right thing.

Ann Tekman, Wake Tech and One Wake supporter, shared comments on property taxes and gentrification.

Octavia Rainey - shared comments about the raise in taxes. She shared that Wake County should not be passing any bonds right now. She shared that housing power is voting power. She shared comments on a SB 25 bill was that was passed in 2015.

Isaac White - shared comments on the assignation of Dr. Martin Luther King and the tax hike. He shared that the tax hike has a bearing on the community.

Annie Tinsley - shared comments on tax abatements. She shared that residents are penalized by HUD.

Samuel Robinson - lives in Cary. He shared comments on the median income in 27601. He shared that people in 27610 is the lowest median income and they deserve the same breaks as the Dell Corp.

David Isgit - shared comments on supporting families and excessive tax rates.

Freddy Dunstan -Wake Forest resident, received a vacate the premises notice and has to move by the end of this month. Asked the Board to listen to the concerns of the citizens.

Leeya Chaudhuri, Freshman at Enloe High School, shared comments on the renaming of Village library. Wants it changed to Oberlin Regional library. Adalia Schafrath-Craid (student) shared comments on the reasons why the name change should occur.

Cheryl Williams, descendent of the Turner family. She shared that they are here to honor the name change to Oberlin Regional Library. Asked the Board to approve the name change. Ms. Williams shared historical background references in the Oberlin community.

Recommendation

Utilize up to \$200,000 of 2018 Parks Recreation Greenway and Open Space bond funding to produce three concept plans for nature preserves in Little River, Buffalo Creek and Swift Creek.

Chair Hutchinson shared comments on the nature preserves. He shared that Wake County coined the phrase "nature preserves". He shared that it is a high recreational use with a low cost. He shared the story of turnip seed and the diverse bird population. He shared that this happens in May. He shared his hope to bring partners together and share the cost to open to the public for hiking and biking.

Vice-Chair Thomas shared comments on the planning process and the timeline. She commented that they have \$200,000 and asked to clarify that they will spend 4 - 6 months on the Master Plan and in the Fall begin on other aspects.

Mr. Snow confirmed that the initial stage will be to evaluate the plan and determine the best use for each area in the park. Once they have finished that if the Board likes their recommendations that will become the Master Plan.

Chair Hutchinson moved, seconded by Vice-Chair Thomas, that the Board of Commissioners appropriate \$200,000 of Parks, Greenways, Recreation, and Open Space (PGROS) bond funding to develop concept plans for three new County Nature Preserves. The motion carried by the following vote:

Commissioner West shared comments on the Meadowbrook Country club. He asked where does the golf course fit into the plans.

Mr. Snow shared that the town of Garner has purchased the golf course but he is unsure of the plan.

Commissioner Evans asked how to define the Wake County portion. Mr. Snow shared that they over lap. He shared that the land is between Lake Benson and Lake Wheeler.

Mr. Snow shared that Garner has an interest in the land. He shared that he doesn't have specific details until he speaks with the Town of Garner. He shared that Cary has a completed design.

Commissioner Evans shared support for the project and asked if a decision should be delayed until they find out the scope if the project.

Chair Hutchinson shared comments on the item and he would like to move forward.

Mr. Snow shared that when the Board allocates money, any money that is not spent returns to the greenway fund. If any of the partners contributes and in fact if there are surplus funds those funds are not spent they are not lost they just come back to the Open Spaces fund. Commissioner Adamson shared her support of the project. She asked if any of the land is in danger of being developed or left alone for open space. Mr. Snow shared that 99 percent is protected property.

Commissioner Adamson asked if there is a disincentive.

Chair Hutchinson shared that there will be plenty of time for Towns to get in on construction.

Commissioner Cervania shared comments on how the Town of Cary is participating in as it relates to the design and they are excited to partner.

Chair Hutchinson moved, seconded by Commissioner West, : that the Board of Commissioners:

1. Authorize staff to proceed with a Request for Qualifications (RFQ) for consultants to complete 100% design for the Wake County section of the Swift Creek Greenway; and

2. Appropriate \$3.5 million of Parks, Greenways, Recreation and Open Space (PGROS) bond funding to complete 100% design for the Wake County section of the Swift Creek Greenway. The motion carried by the following vote:

Commissioner Calabria shared comments on the renaming of the Village Regional Library to Oberlin Regional Library. He pointed out that this item was before them as a result of work done by citizens who brought this forward. He thanked Ms. Leeya Chaudhuri, Ms. Adalia Schafrath-Craig, and Ms. Cheryl Williams for their work. He stated that the reasons for renaming the library have been established and he shared that the renaming will better reflect our community, history, and aspirations.

Mr. Mike Wasalick, Wake County Libraries Director, shared a story celebrating Ms. Pearl Thomas, student of Shaw University who was denied

access to the library. She was invited back to Raleigh and was issued a library card at the age of 93. It was an opportunity to right a wrong. He shared that the Library Commission is in support of the Board's decision.

Vice-Chair Thomas shared that this action supports the Board's goal of diversity, equity, and inclusion, and the legacy of Dr. King 54 years later. She shared that libraries are about education and where dreams are created.

Commissioner Adamson asked Mr. Wasalick to share what the process entails. He shared comments about a display for the library and said they are working with residents of the Oberlin community to help develop the educational efforts. He is excited about being able to celebrate the history at this library just as they celebrate the Mollie Huston Lee collection at the Richard B. Harrison Community Library.

Commissioner West shared historical data of the intellects of the community.

Commissioner Cervania shared comments on community engagement. She thanked the management companies for their decisions. She thanked the two young ladies that presented on behalf of the library name change.

Commissioner Evans thanked the young ladies for their dedicated work on how to be effective on behalf of the community.

Chair Hutchinson shared comments on the representation of Oberlin community. He shared that there are stories to be told.

Ms. Williams shared her appreciation for the work of the young women and the Board for this action. She shared that there are five national historic sites within the Oberlin community and described some of the aspects depicted in the art work "Oberlin Rising".

Vice-Chair Thomas moved, seconded by Commissioner Calabria, that the Board of Commissioners approve renaming the Village Regional Library to "Oberlin Regional Library". The motion carried by the following vote:
