Ms. Gilyard shared that there were no online comments.

Mr. Paul Baer - shared comments on the recycling process. He shared that the rules should be reviewed. He shared comments on illegal burning in Wake County, illegal fireworks, traffic congestion at Buffaloe Rd, and staffing the fire department. He shared comments on zoning. He shared that it is appalling how veterans are being treated.

Councilman Steve Rao - Shared comments on RTA Awareness Day and his recent White House visit. He shared comments on Cyber Security Awareness month.

Marty Clayton, Duke Energy, thanked the Board for the tremendous effort during hurricane Ian. 104,000 customers were without power on Saturday and on Sunday only 3,000 customers were without power. He thanked everyone for their partnership.

Ms. Betty Parker, Senior Director, Real Estate Service, Wake County Public School System (WCPSS), presented the request.

She shared maps showing: High School Target: Western Wake County/Morrisville Area; Wake County GIS Depictions of Subject Property Area; Wake Technical Community College (WTCC) Research Triangle Park (RTP) Campus; Proposed H-14 High School Site at WTCC RTP Campus; Town Fire Station Site Exchange and Future Park Locations; Preliminary Feasibility Study.

She shared the Off-Site High School Standard Program Opportunity/Shared Use.

# Off-Site High School Standard Program Elements Locations:

- Track and Ancillary Facilities: Shared use of the Parkside Middle School/Wake Early College of Information and Biotechnologies (MS/WECIB) track as upgraded to high school standards with the future High School (HS) project.\*
- Tennis Courts, Softball Field and Ancillary Facilities: Develop at Cedar Fork Elementary School (ES) with the future HS project\* with Town of Morrisville per terms of an Amendment to Cedar Fork ES Joint Use Agreement (JUA)with Morrisville.
- Baseball field and Ancillary Facilities: Develop at Town of Cary's
  Mills Park with the future HS project\* with Town of Cary per terms of
  an Amendment to Mills Park ES/MS JUA with Cary.

\* Per 2022 Capital Improvement Plan (CIP), Design funding is in FY '24, Construction funding is in FY '26 & '27, and projected school opening is in Fall 2027 and aligns with the start of the 2027-2028 school year.

Shared maps and photographs of: Parkside MS/WECIB - High School Program Opportunity/Shared Use; Cedar Fork Elementary School (ES) Site - High School Program/JUA Opportunities; Mills Park/Mills Park ES & MS - High School Program/JUA Opportunities; H-14 High School Campus Site Proximity to Off-site Program Elements.

She shared the Purchase Contract Terms and Information.

## **Purchase Contract Terms and Information**

- **Purpose:** H-14 site for a small comprehensive high school with an estimated student capacity of ±1,200.
- **Seller:** Trustees of Wake Technical Community College, which acquired the property in 2011.
- Land To Be Purchased: A ±33.523 acre northwestern portion of

- the WTCC RTP/Morrisville campus located between NC Highway 54 & Paramount Parkway.
- **Zoning:** School Use within Conditional Office/Institutional(C-OI). A portion of the site lies is within Airport Overlay A (AO-A).
- Negotiated Purchase Price: \$3,609,857.21 (\$107,683/acre subject to survey).
- Appraised Value: An appraisal was not procured as the purchase price is the value WTCC paid to acquire the subject property in 2011.
- **Funding Source:** Site acquisition costs are funded from the Land Acquisition line item of the ongoing CIP.
- Operational Cost Impacts: Minor maintenance costs are anticipated until such time as parking lot removal/demolition occurs to support future site use.
- Public Transit: Morrisville Smart Shuttle, operated by GoCary, runs seven days a week connecting 15 shuttle stops including one at the WTCC RTP/Morrisville Campus. GoTriangle also runs seven days a week and has a stop at the WTCC RTP/Morrisville Campus.
- Post Closing Covenants: Seller will have the nonexclusive right to continue to utilize the portion of the surface parking lot, drive and sidewalks located on the future school site until removal in advance of the school project.
- Post Closing Contemporaneous Exchange: Board will acquire the Town's 2.5 acre fire station site for assemblage with the school site, and in exchange convey a long term lease for a comparable area that lies within the Airport Overlay to the Town for a future fire station (and Wake County EMS if desired).
- Potential Surplus Property: None foreseen given site constraints.

She shared the following charts: Land Acquisition Comparison and Approval Milestones of Collaborative Intergovernmental Agreements.

She recognized the Town of Apex team, Wake Tech, Town of Cary, Parks and Recreation, Chair Hutchinson, Mark Edmondson, Chris Snow and Emily Lucas.

Commissioner Evans shared comments on the presentation. She shared that when she was on the School Board, they were looking for land for Morrisville and appreciates that it is being completed.

Commissioner West shared comments on joint ventures, and the progress that has been made.

Ms. Parker shared that there are 60 contracts throughout Wake County. She shared additional information on joint collaborations.

Commissioner Adamson shared her excitement for the project. She shared that WTCC was kind and donated land for affordable housing and that they are great partners.

Commissioner Cervania shared comments on the outcry of the need for a high school.

Chair Hutchinson shared comments on the collaboration with Wake County Public Schools, Wake Tech, and Wake County. He asked that bike trails be considered.

Ms. Parker shared that it starts with good stewardship. She shared that they want to have continued success and support from the taxpayers. She shared that they can not build what they cannot afford. She shared that the municipalities have been very cooperative. She shared that the process started as soon as Dr. Greene shared the concept.

Commissioner Evans shared comments about Ms. Betty Parker and how passionate she is about her work.

Ms. Kristi Jacobs, Benefits and Wellness Manager, shared statistics on Mental Health and Wellness.

#### **Mental Health and Wellness**

Recent major changes to the health system, economy, and society have highlighted existing mental health issues and, in many cases, increased mental health and wellness issues.

- 1 in 5 people live with a mental health condition (The National Alliance on Mental Illness)
- 17 million adults in the US live with depression (The National Alliance on Mental Illness)
- 1 in 4 active military members show signs of mental health conditions (*Journal of the American Medical Association*)
- Suicide was the tenth leading cause of death overall, and second leading for individuals between 10 and 34 (2019 CDC)

- Suicide rates are growing among racial and ethnic minority communities (University of Houston)
- Among Wake County employees, there have been three suicides in the last four years

She shared Examples of Trauma our Employees Face.

# **Examples of Trauma Our Employees Face**

- Homelessness
- Animal Cruelty
- Child Abuse
- Elderly Abuse
- Domestic Abuse
- Pandemic Warzone
- Trauma Scenes
- Suicide in Parks
- Coworker Deaths

She shared that failure to acknowledge an employees' mental health can hurt productivity, professional relationships and the bottom line (*Harvard Business Review*).

Supporting the mental health of our employees is the responsible and right thing to do!

She shared the Current Support Options and Data.

# Current Support Options and Data

# Wake County's Health Plan

- Covers in-person care, telehealth, and online behavioral options
- In 2021, 33 percent of plan members had a behavioral health diagnosis - national average is 25 percent
- 687 provider visits at the Employee Health Centers for behavioral health concerns

# **Employee Assistance Program**

- Free professional and confidential services designed to help employees meet a variety of life challenges
- Provided 510 hours of service in 2021

#### **PTSD Services**

- Access to on-site psychologist for both group and individual sessions
- In 2021, 518 hours of counseling was provided

She shared the Recommendation.

#### Recommendation

#### **Add Wellness Leave**

- Two full workdays per year for regular full-time employees
- Pro-rated based on FTE
- Unused days will not roll over to the next year
- Still requires supervisor approval to take time off
- Not paid out upon separation
- Cost neutral way to support employees' health and wellness
- Can be used for wellness, stress, anxiety, depression, mental health visits, etc.
- Can be used for immediate family members

She shared How is this different from Sick Leave.

#### How is this Different from Sick Leave?

#### Sick Leave

- Sick Leave can be seen as reactive to an existing event
- Does not always prioritize preventative care
- Documentation and/or disclosure can be required
- Must wait to accumulate Sick Leave to use
- Time taken impacts length of service calculations for retirement

#### **Wellness Leave**

- Encourages employees to focus on themselves to proactively address mental health
- Can be used to get support, relax, or unplug from stressors
- Demonstrates Wake County's commitment to employees' mental wellness
- Aims to increase workforce productivity by bringing focus to employees
- Another tool to help recruit and retain top talent in a competitive environment
- Supports existing options for mental wellness

She shared Further Destignatizing Getting Help.

# **Further Destigmatizing Getting Help**

# **Employee Assistance Program**

 Rebranded to reduce stigma and increase mental wellness support usage (myS.E.L.F.network)

#### **Wellness Leave**

- Another way to reduce stigma
- Diversity, Equity, and Inclusion focused by providing an alternative avenue to get help
- Provides time to begin or continue mental wellness support
- Opportunity to rejuvenate and recharge

She shared the Implementation.

# Implementation

- Ask that Board of Commissioners approve the amendment to the Wake County Personnel Code of Ordinances for the establishment of Wellness Leave
- Effective January 1, 2023
- Communication to employees about new benefit to support their wellness

Vice-Chair Thomas appreciated the continued support from Manager Ellis and Ms. Angela Crawford on the importance of putting on our own oxygen mask first. She shared comments on attracting new talent and the retention of employees already in place. She emphasized the differences in types of leave and commented that by not allowing rollover or payout on separation encourages use of these new types of leave.

Commissioner Adamson shared that First Responders, EMS and Fire staff see a lot and these, and wellness hours allows them to regroup when they experience seeing loved ones in the ER.

Commissioner Cervania shared comments on mental health and the many tragedies. She shared her support for the ordinance.

Commissioner West shared comments on the manifestation of mental health. He shared that we don't realize if we treat people right, it's the transfer of learning. He shared comments on shared leave.

Chair Hutchinson shared his support of the ordinance. He shared the comments on the Community Health Assessment.

Vice-Chair Thomas moved, seconded by Commissioner Cervania, that the Board of Commissioners amends the Wake County Personnel Code of Ordinances for the establishment of Wellness Leave to provide two workdays of paid leave annually effective January 1, 2023.
